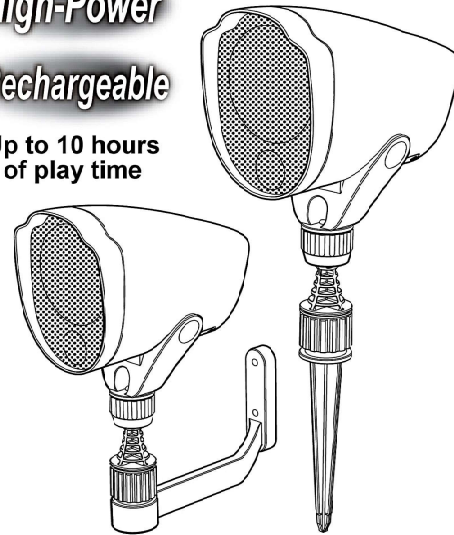

Your **Bluetooth® WIRELESS OUTDOOR GARDEN SPEAKER** is built for outdoor use and, to get the best performance from your speaker, do the following:

Charge your **Bluetooth® WIRELESS OUTDOOR GARDEN SPEAKER** completely before each use with the USB Cord included. You should expect about up to 10 hours of play time once fully charged.

Bluetooth® works with Bluetooth 4.0 and below and within a 60 foot range, if sound becomes unclear, move your Bluetooth® enabled device closer to the speaker.

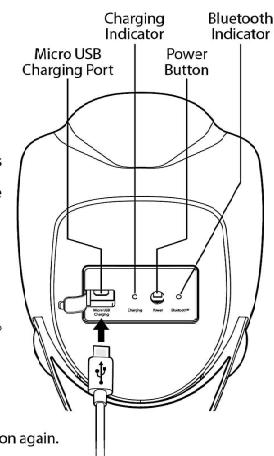
Bring your **Bluetooth® WIRELESS OUTDOOR GARDEN SPEAKER** indoors during extreme cold, heavy rain, or melting snow. Do not place it in standing water.

Do not charge your **Bluetooth® WIRELESS OUTDOOR GARDEN SPEAKER** in a wet environment.

The **Bluetooth® WIRELESS OUTDOOR GARDEN SPEAKER** must be powered "On" when charging. The charging indicator will be red. Once the battery is full, the light will change to green.

**Power and Pairing**

- Your speaker will automatically enter into pairing mode when you power it on by pressing the Power Button. The Bluetooth® indicator will flash green and you will hear an indicator tone letting you know your speaker is ready to pair. If you are pairing two speakers at once, make sure both speakers are "On" before going to the next step.
- Go to your music device's Bluetooth® setup screen and connect to "VR3" as shown on the screen. Follow your device's instructions.
- Once connected, the Bluetooth® indicator will be a steady green and a tone will sound.
- If there is no Bluetooth® signal for 30 minutes, the speaker will automatically turn off.
- To turn off, press the Power Button again.

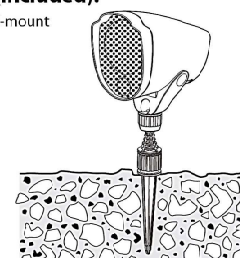


**Charging**

- When the battery voltage falls below 3 Volts, the red charging indicator light will flash and a prompt tone will sound.
- Insert the USB Charging Cable provided into the charging port and charge until the power button turns green again. Remember, the speaker must be powered "ON" while charging.
