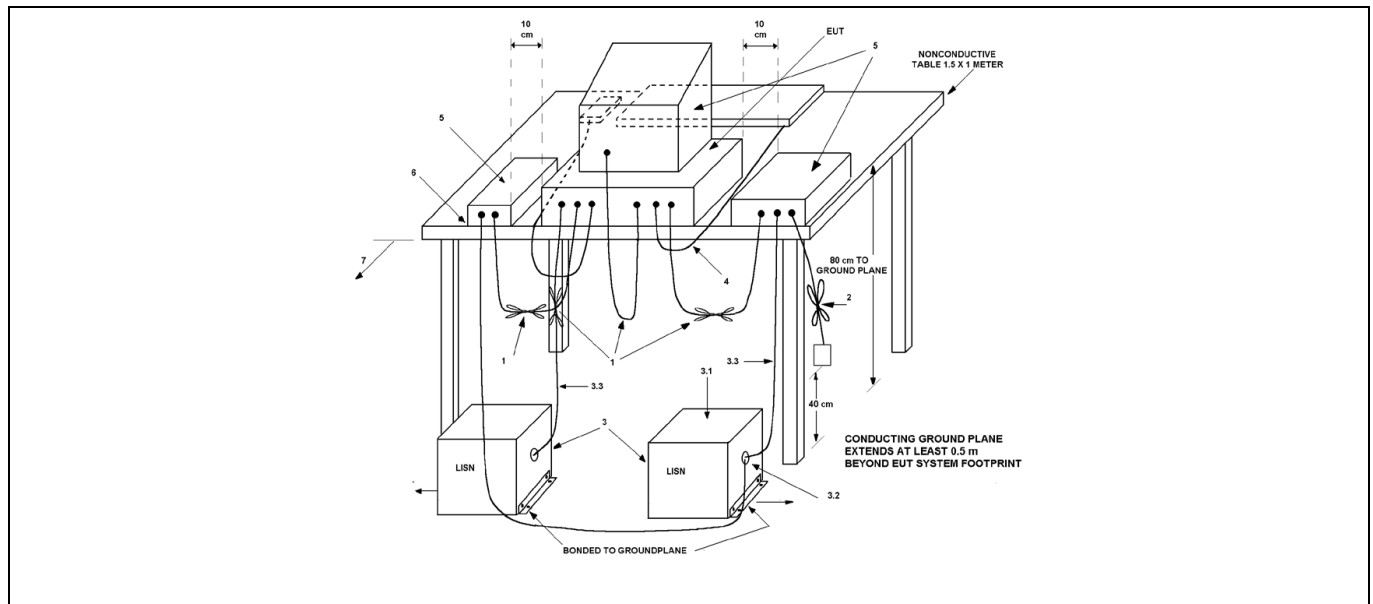

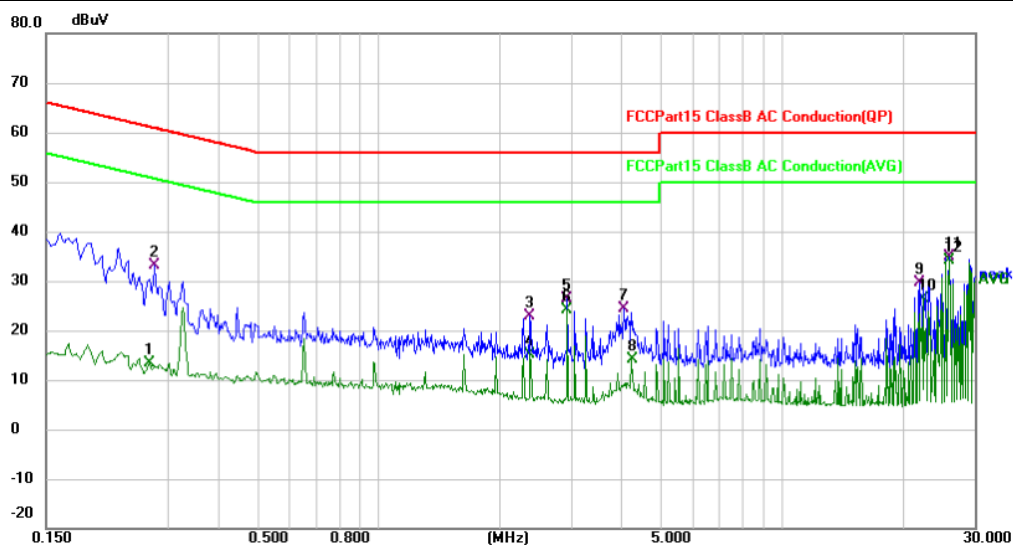

6.1.2 Test Setup Diagram:



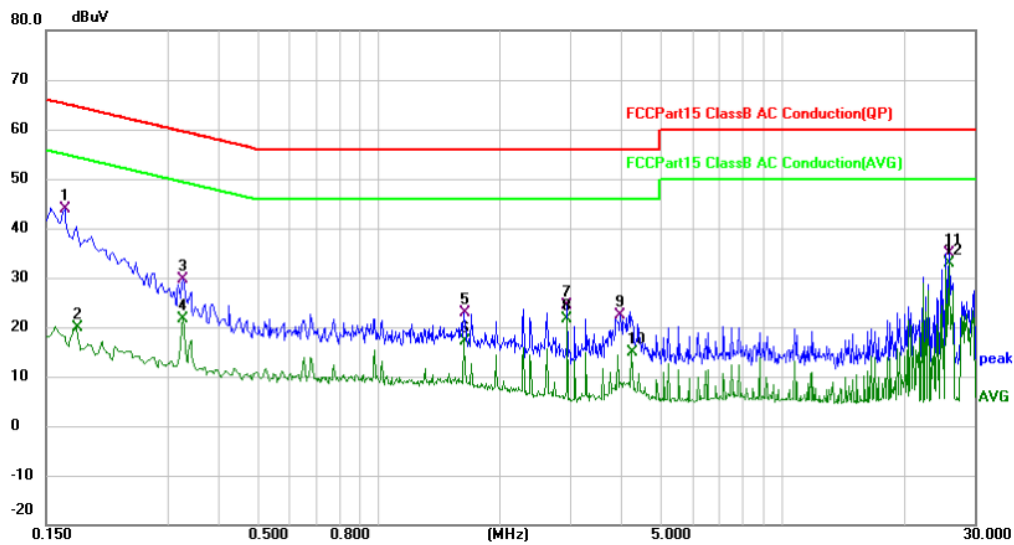

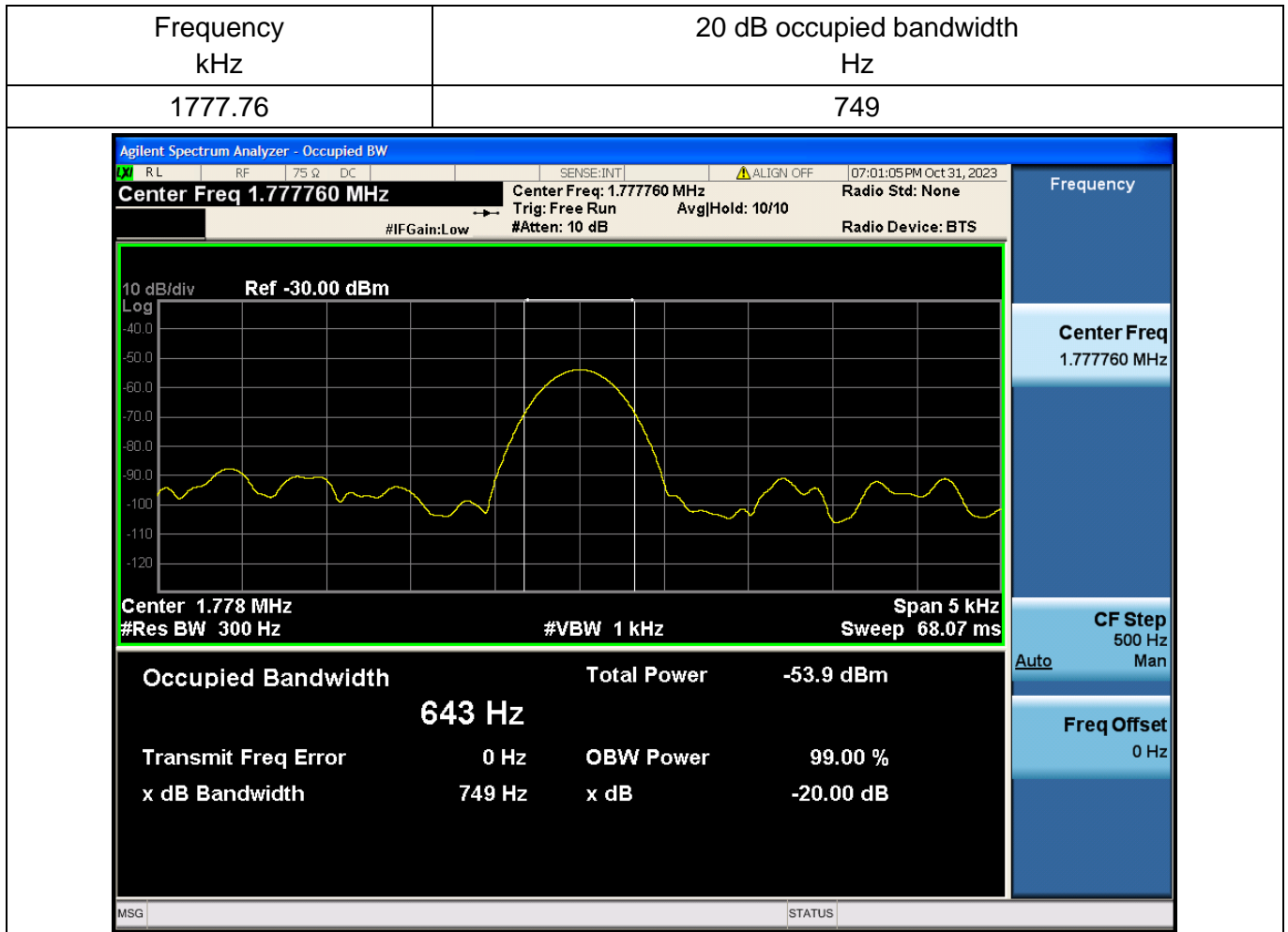

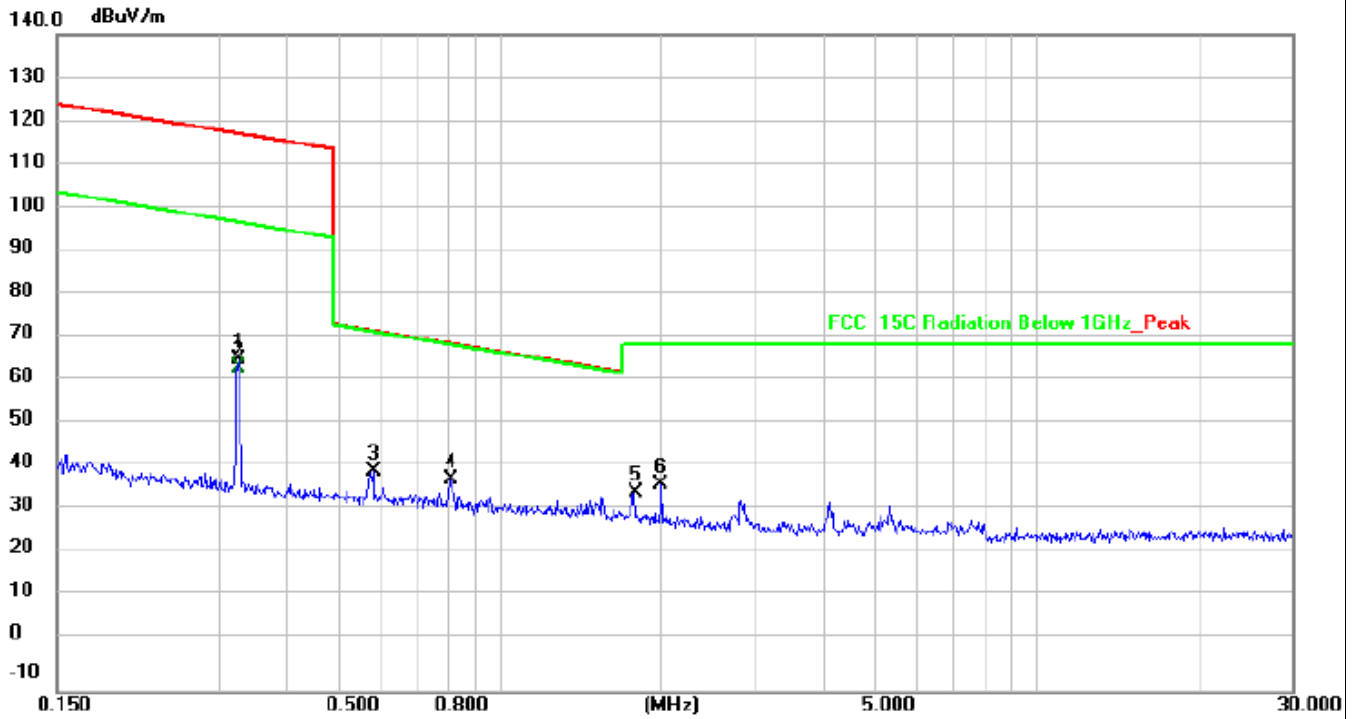

Mode1 / Polarization: Site axis



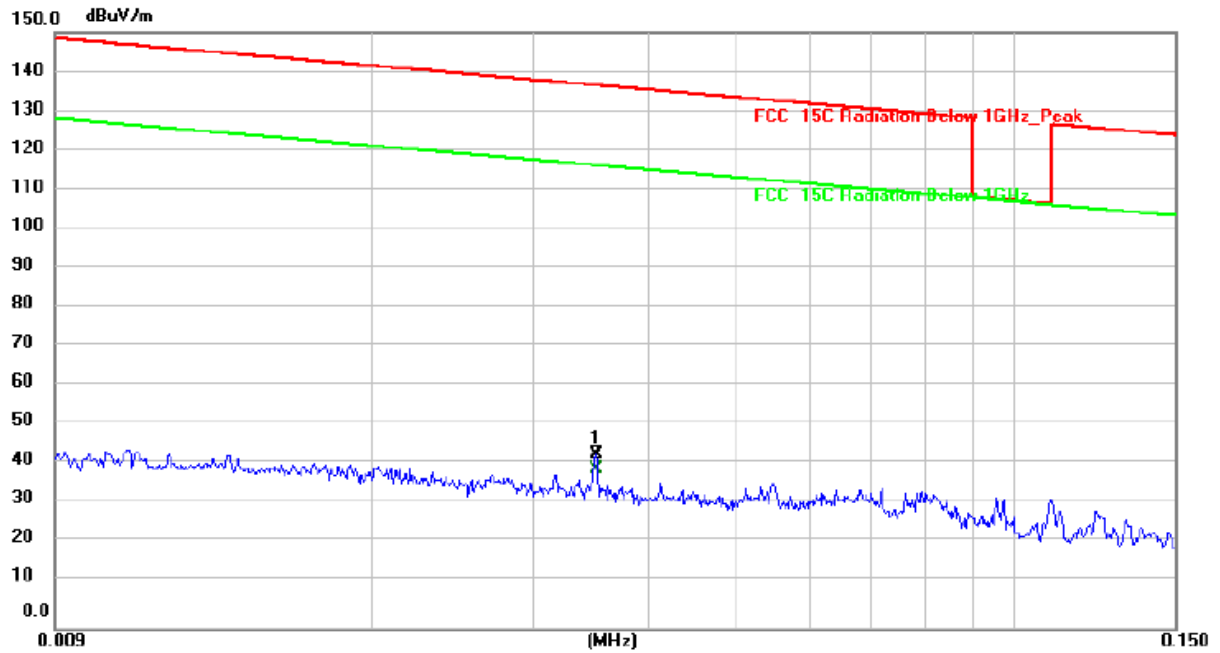

Mode1 / Polarization: Site axis



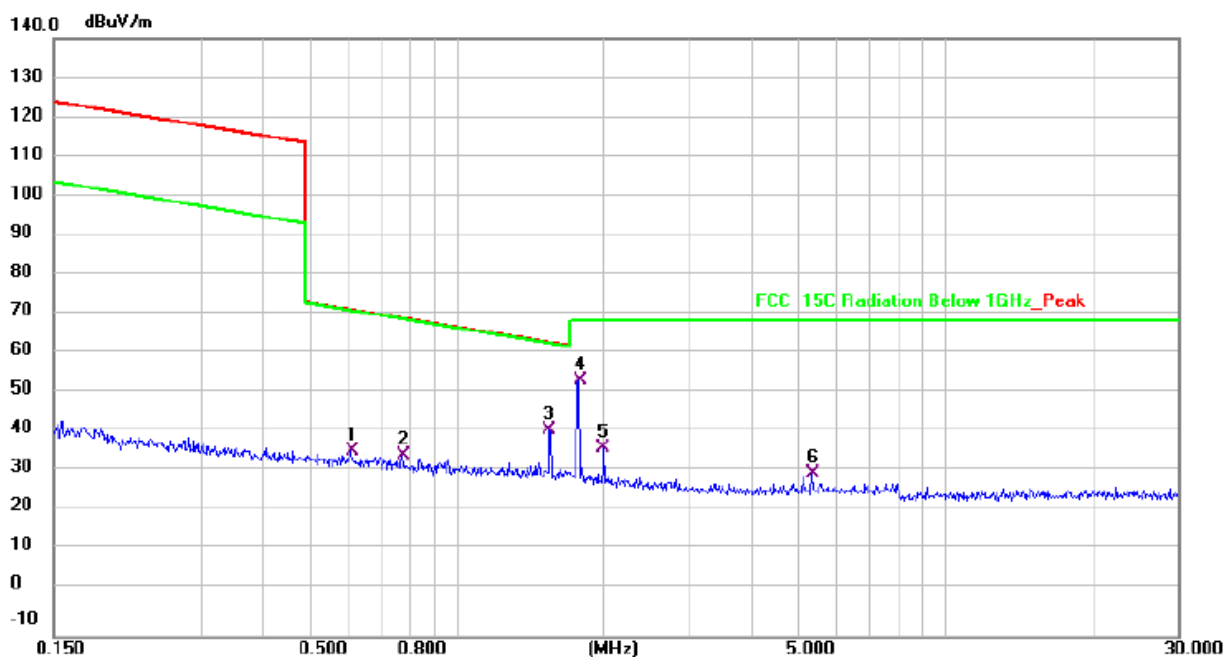

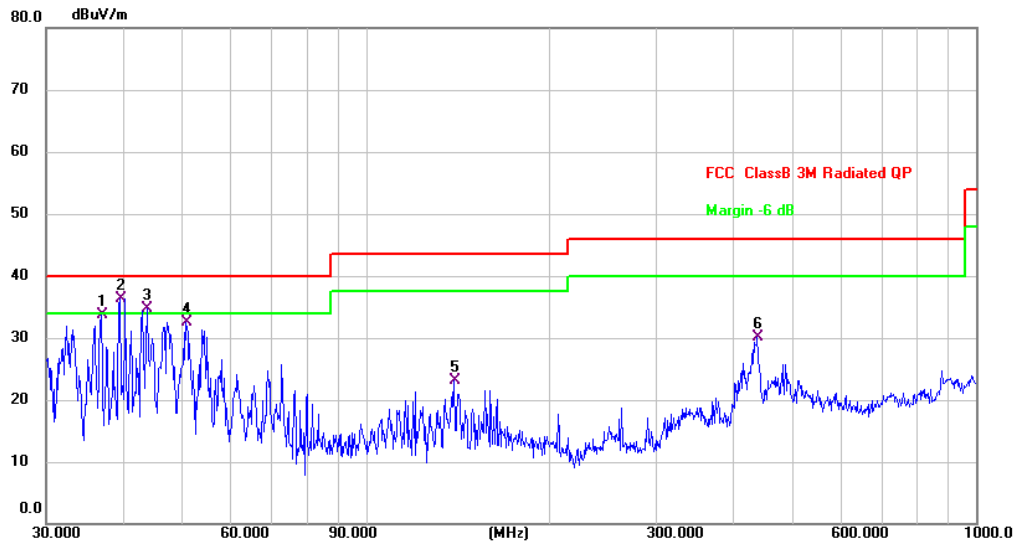
