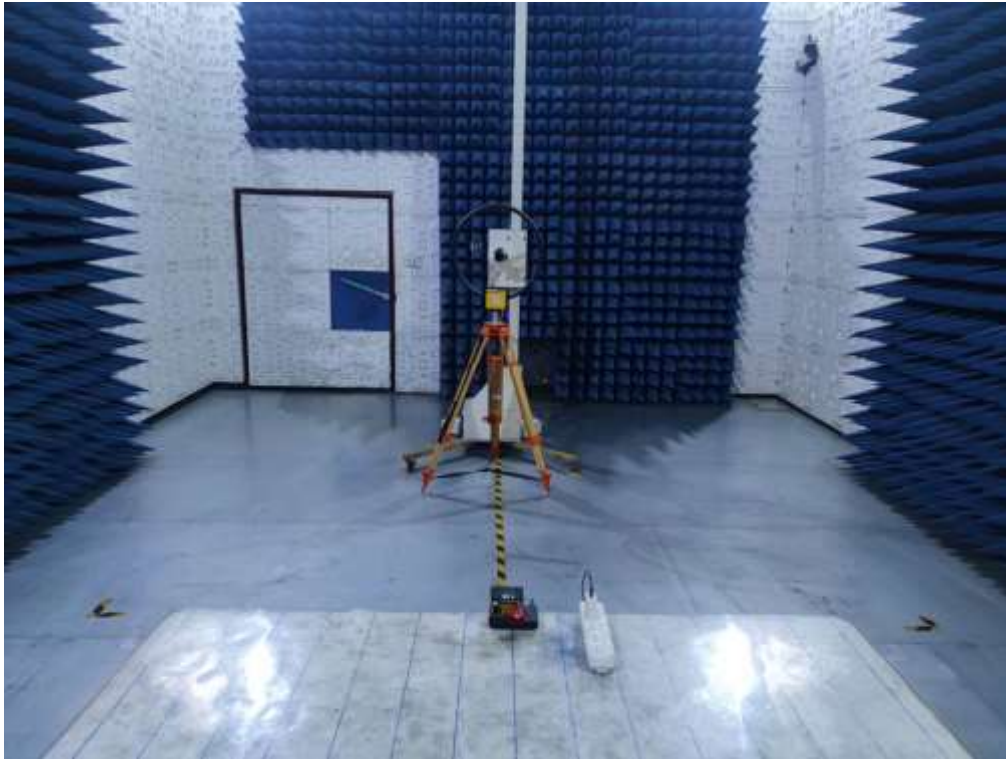
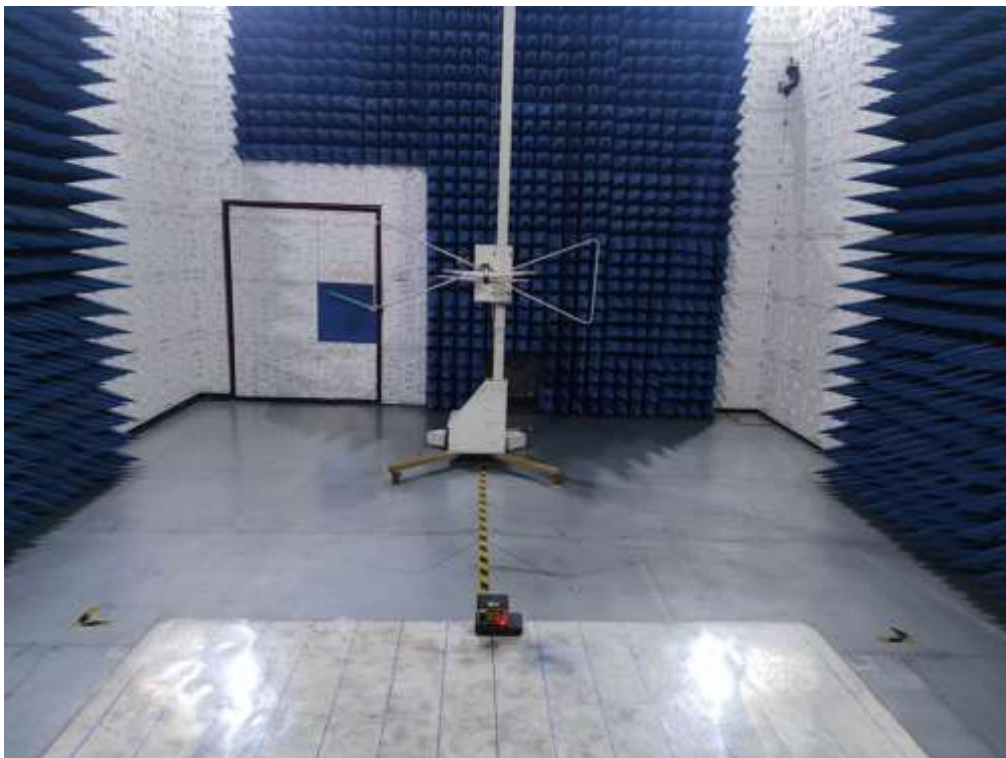

RADIATED EMISSION TEST SETUP BELOW 1GHz

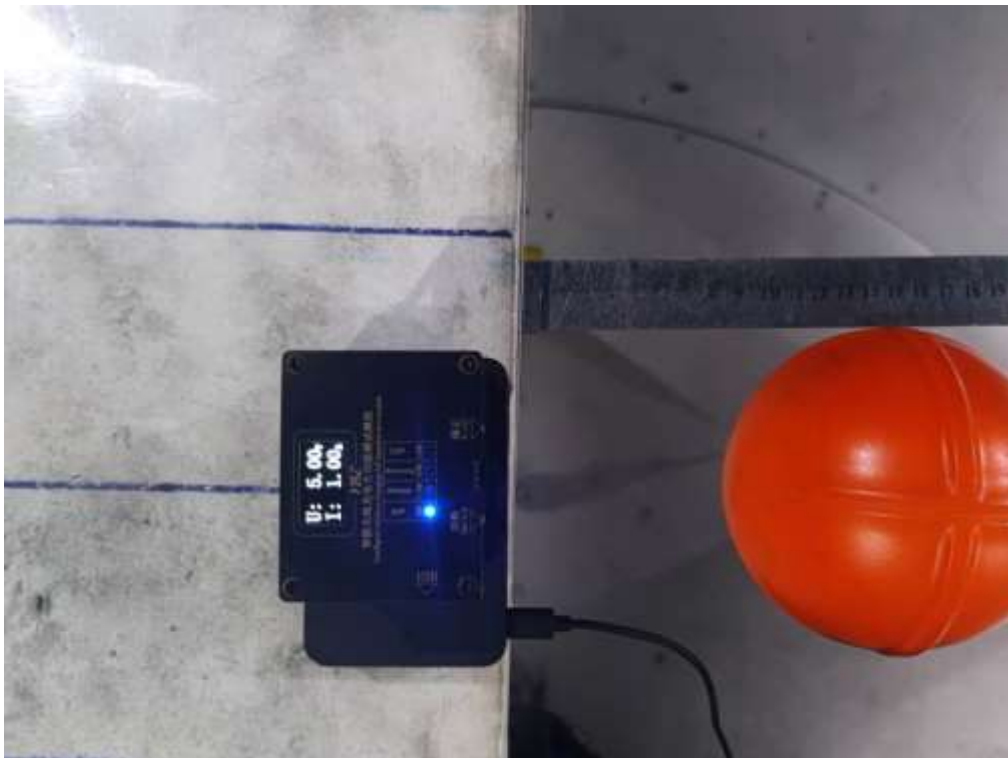

AC POWER LINE CONDUCTED TEST SETUP

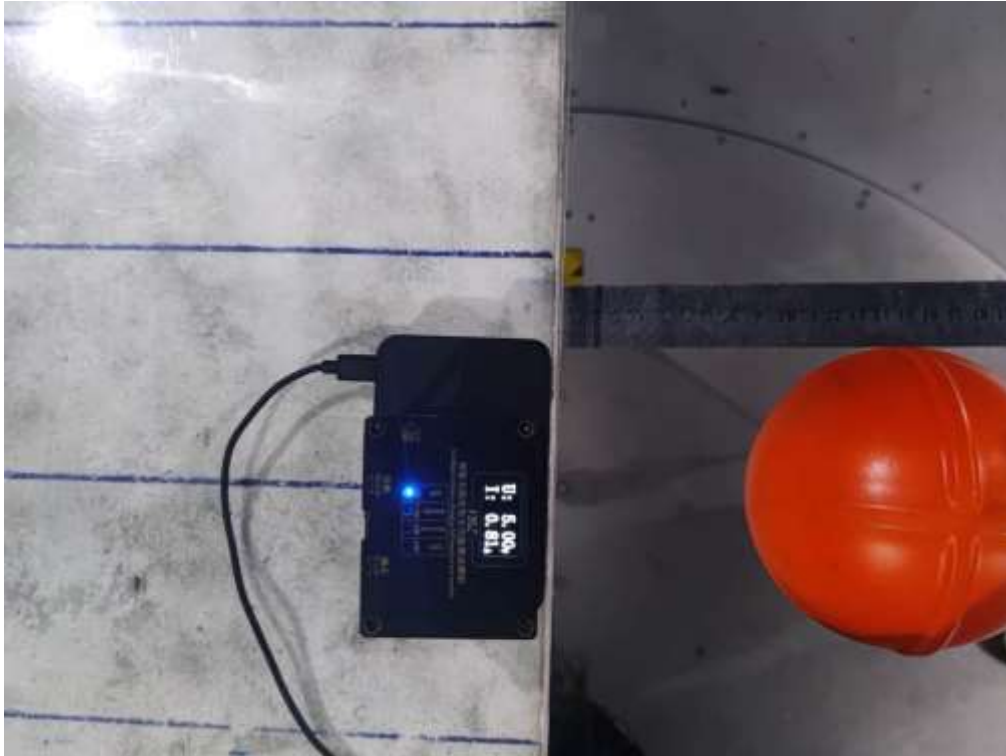

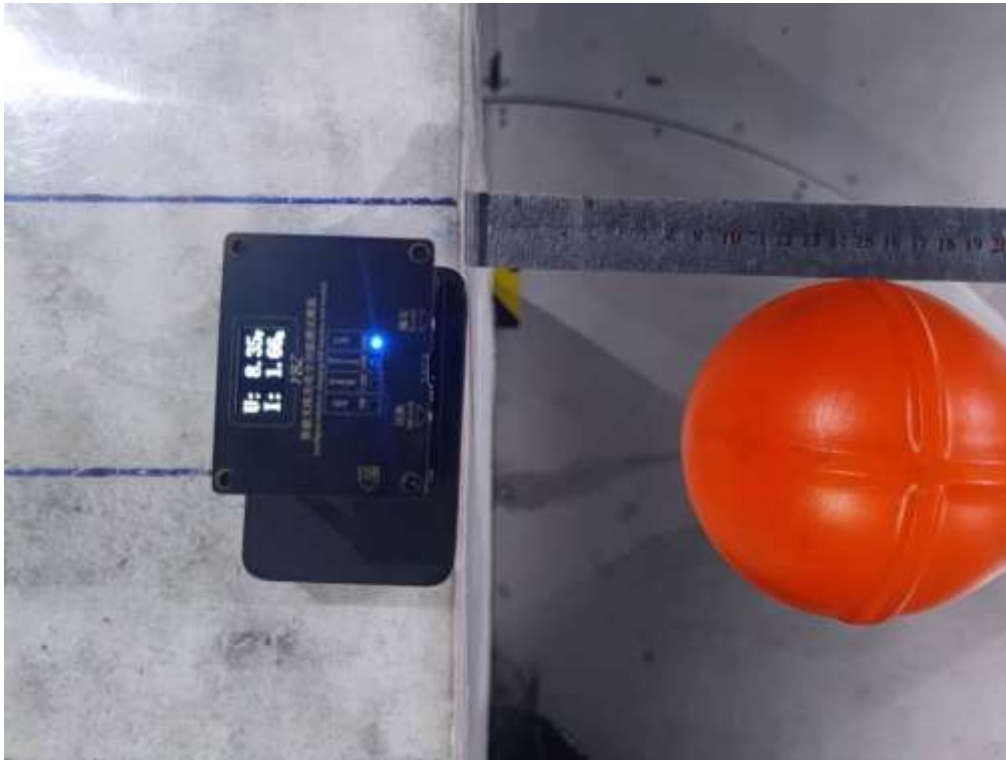
