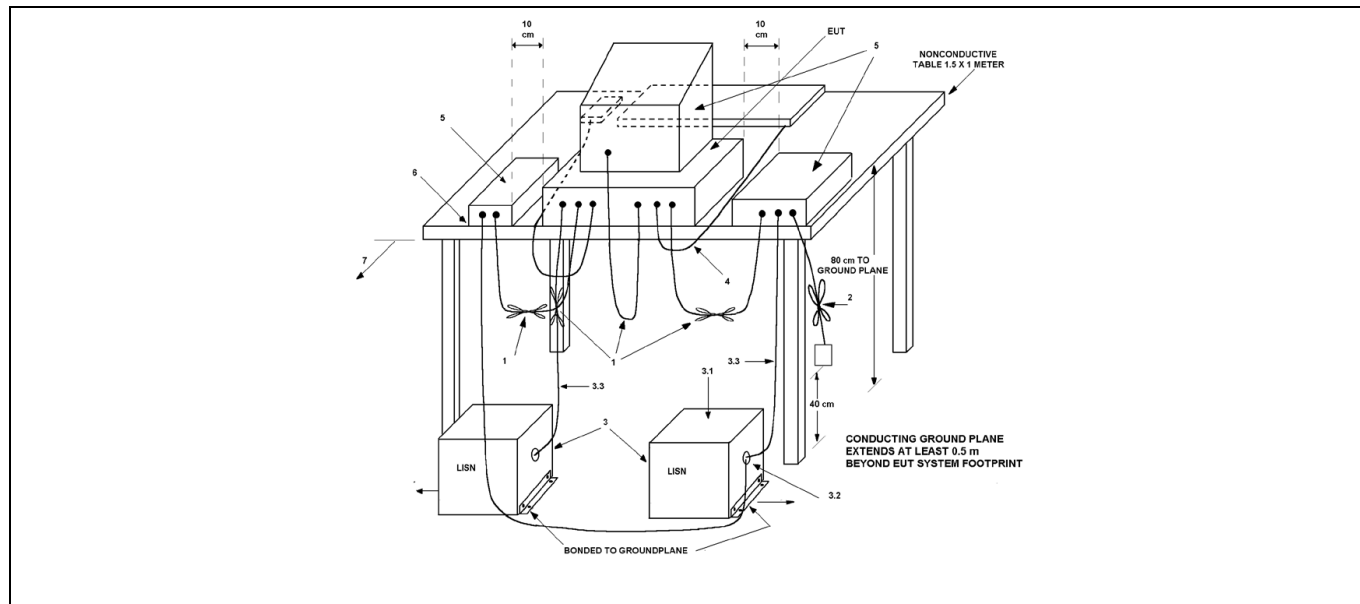

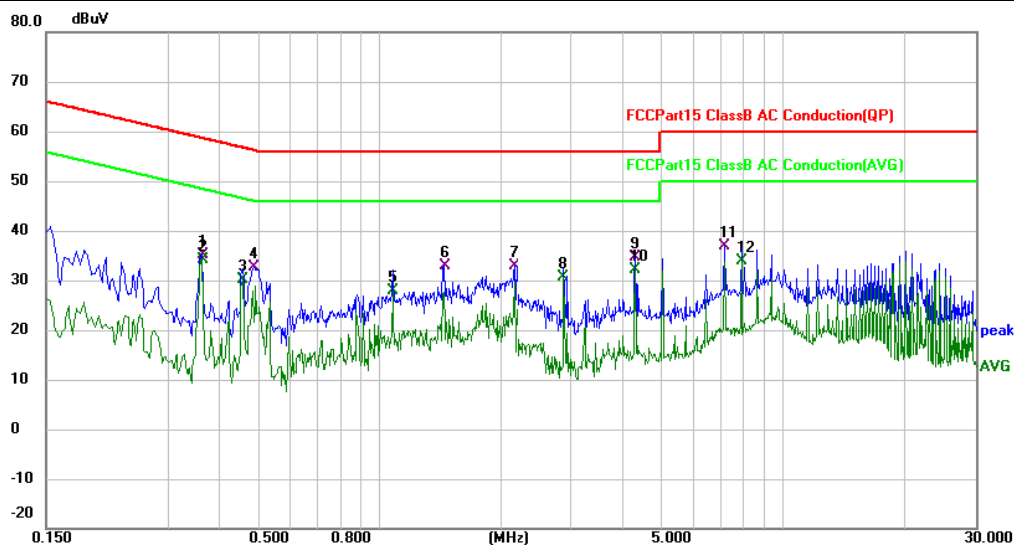

#### 6.1.2 Test Setup Diagram:



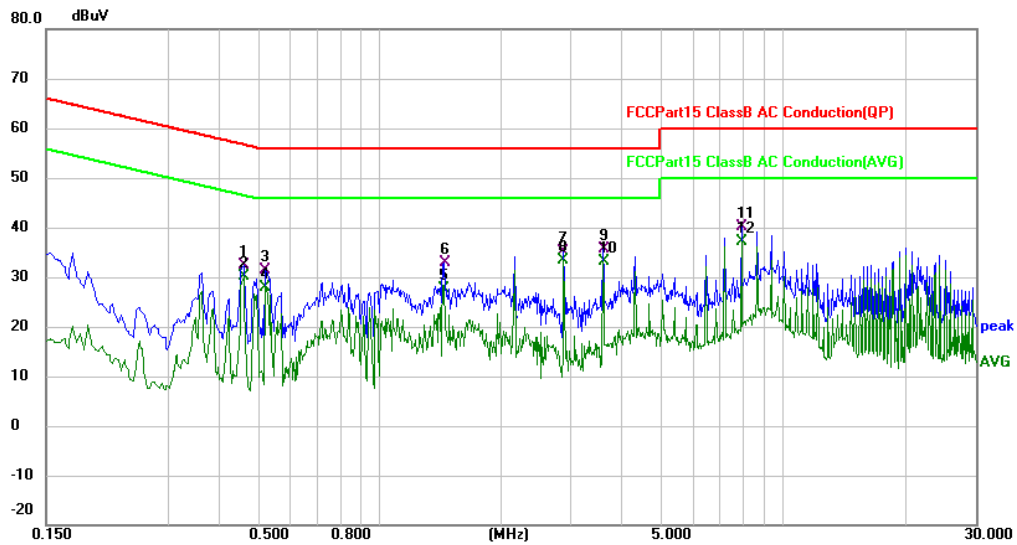

## Coil 2



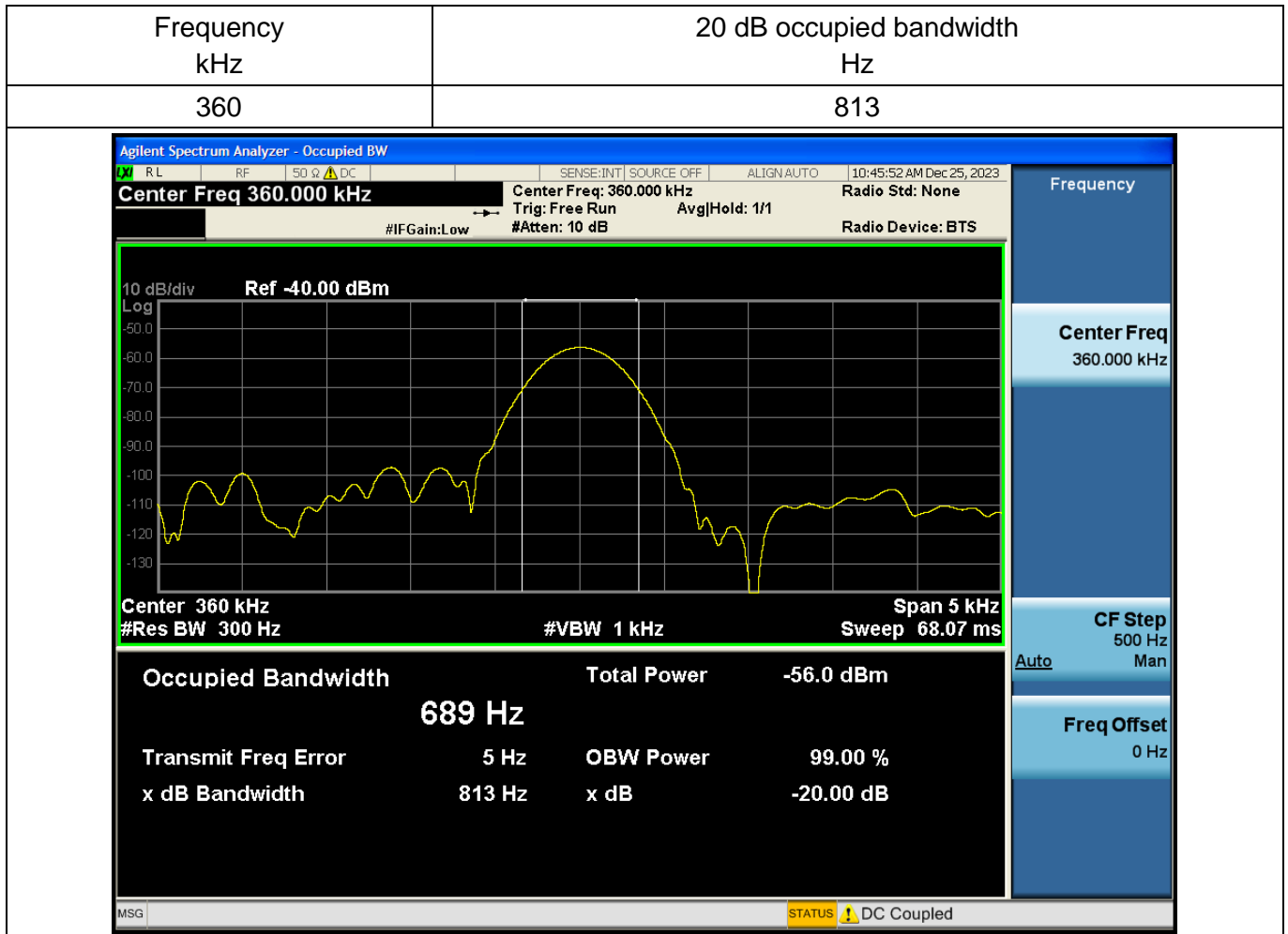

##### 6.4.2 Test Setup Diagram:



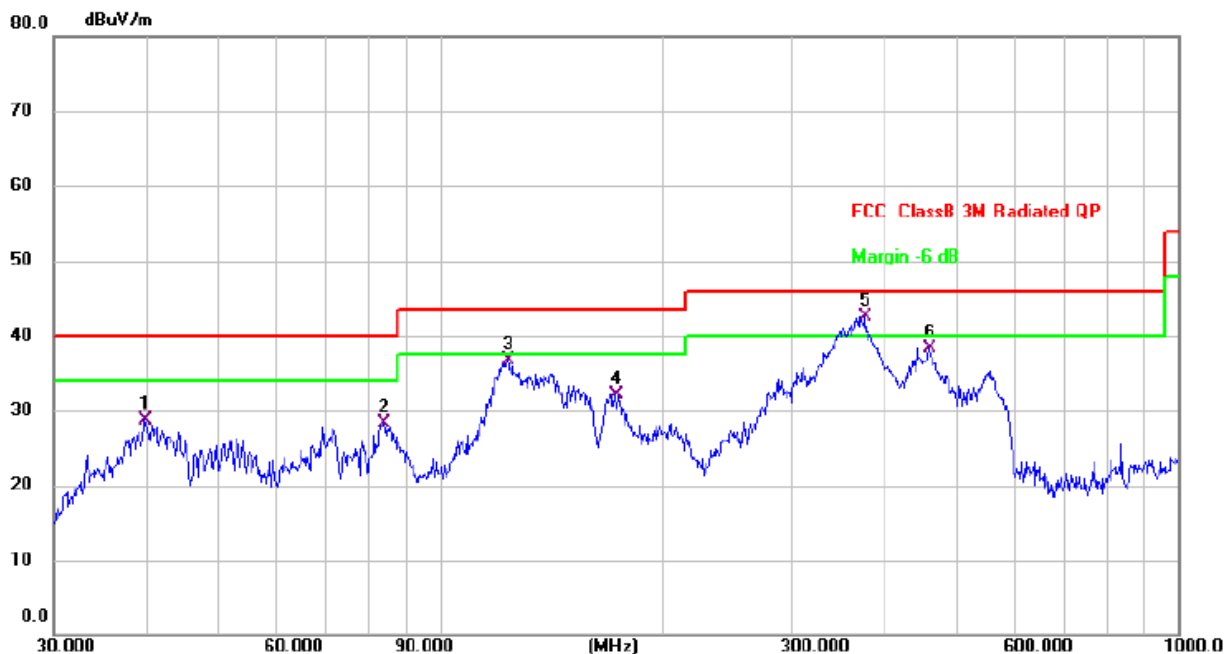
