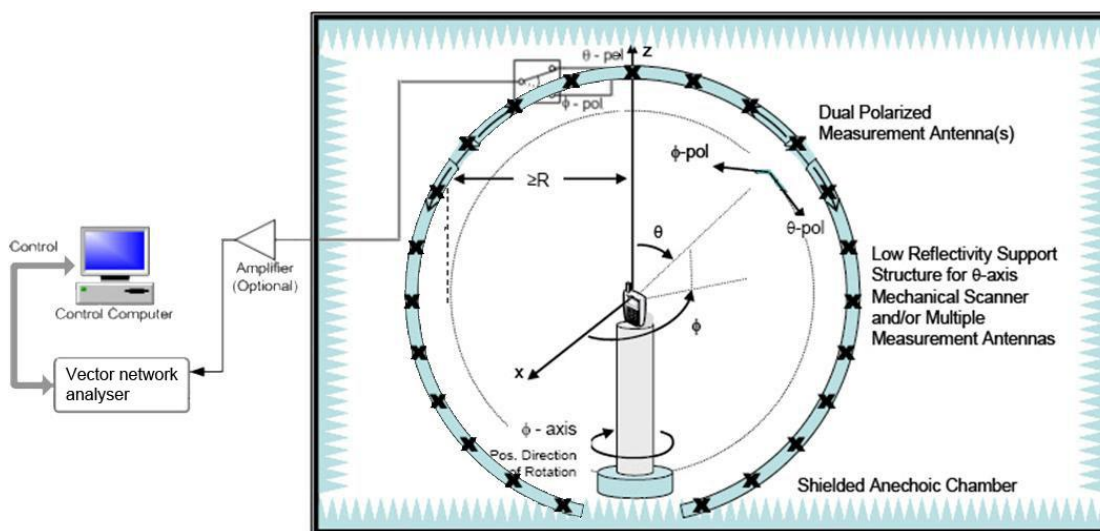

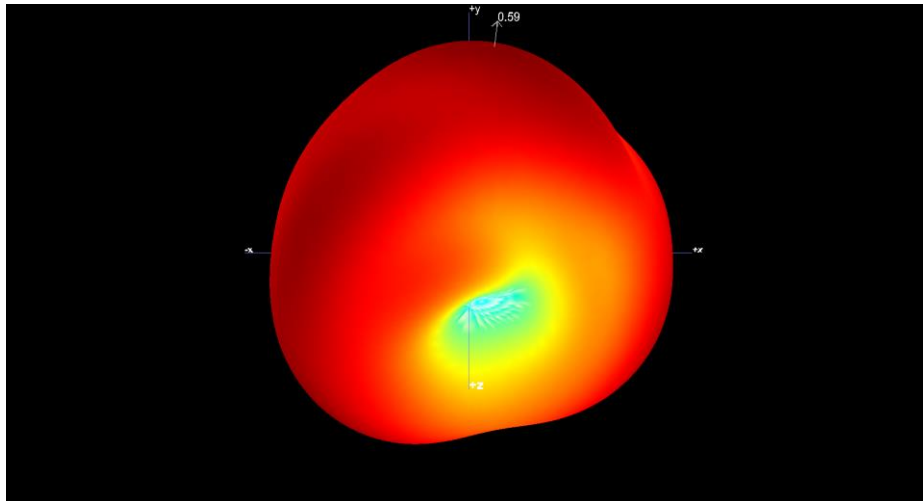

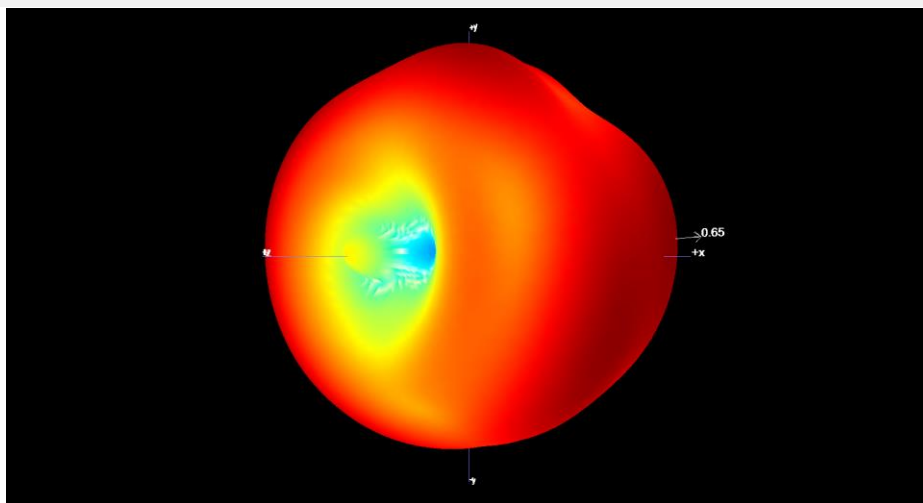

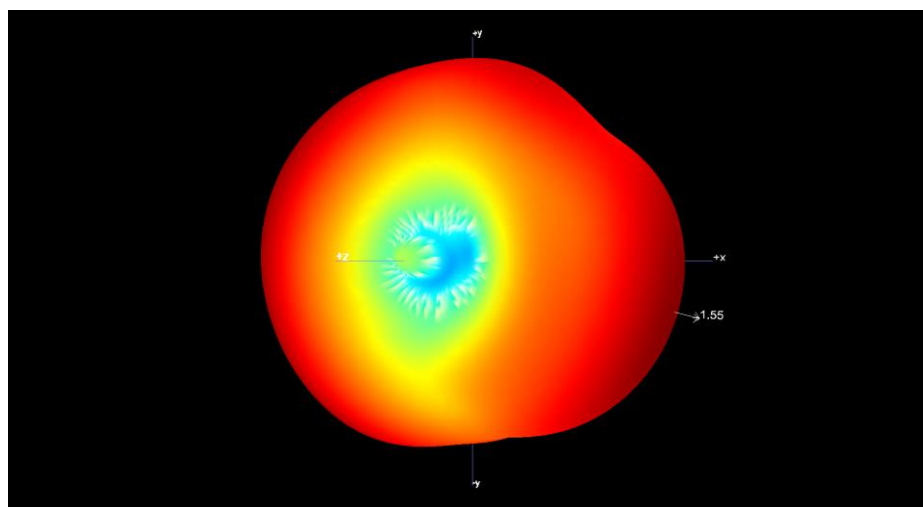
B1.1 3D Pattern for 2400MHz



B1.2 3D Pattern for 2440MHz

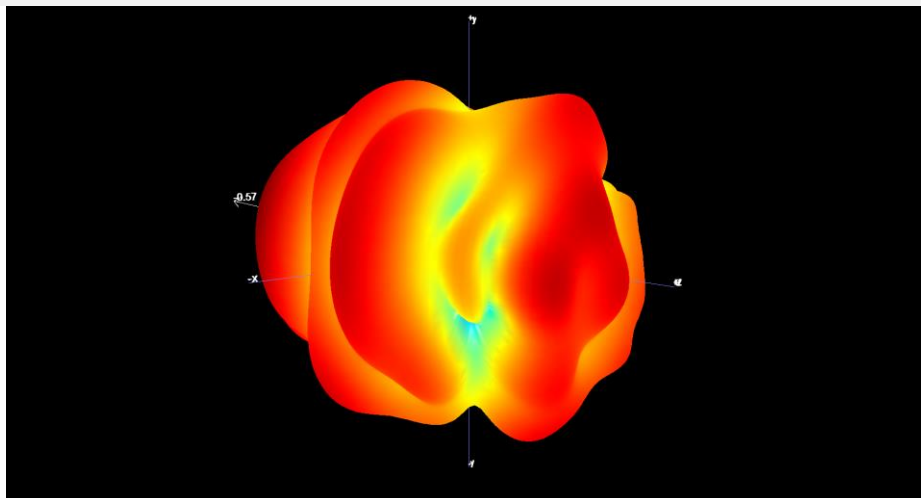


B1.3 3D Pattern for 2483.5MHz

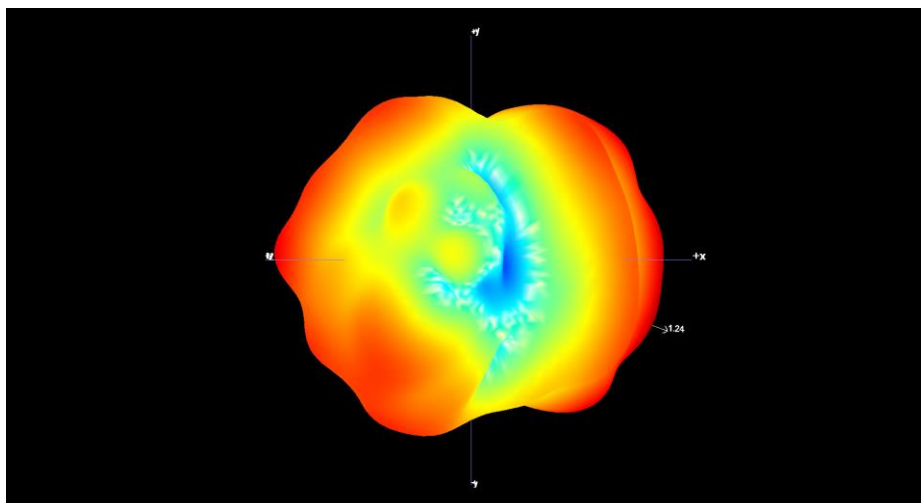

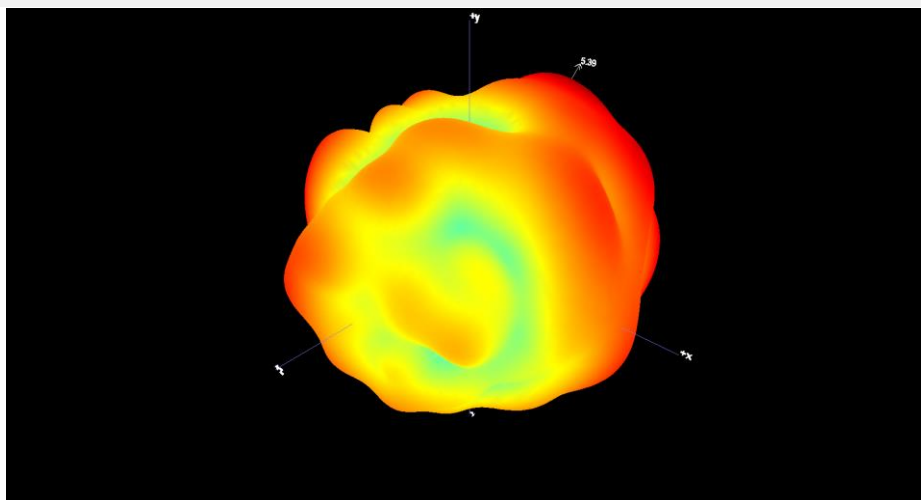
B1.1 3D Pattern for 5150MHz



B1.2 3D Pattern for 5500MHz



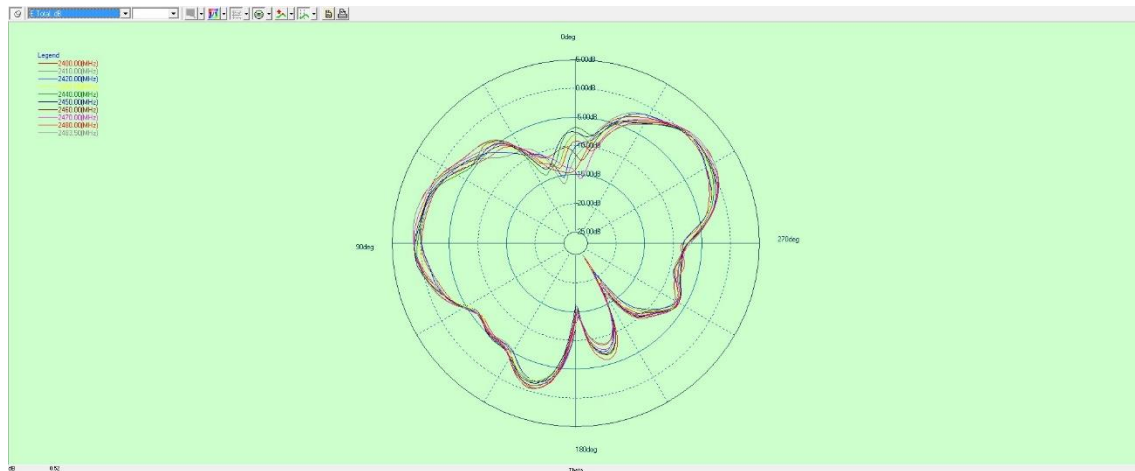
B1.3 3D Pattern for 5895MHz



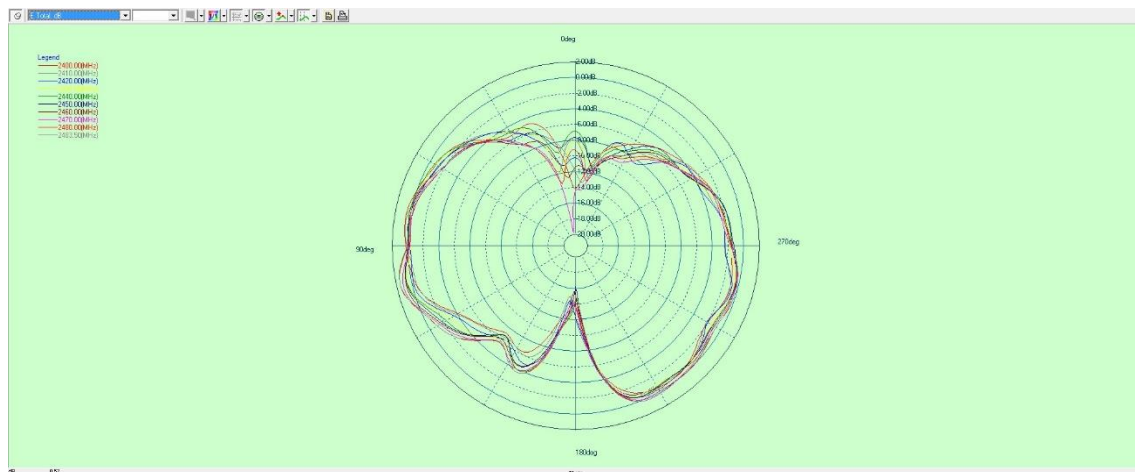
