

#### Test Procedure

- 1. The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram above.
- 2. OCB and 20dB Spectrum Setting:
  - (1) Set RBW =  $1\% \sim 5\%$  occupied bandwidth.
  - (2) Set the video bandwidth (VBW)  $\geq$  3 RBW.
  - (3) Detector = Peak.
  - (4) Trace mode = Max hold.
  - (5) Sweep = Auto couple.

Note: The EUT was set to continuously transmitting in each mode and low, Middle and high channel for the test.

  - (5) Sweep = Auto couple.







#### Test Procedure

- 1. The EUT was directly connected to the spectrum analyzer and antenna output port as show in the block diagram above.
- 2. Spectrum Setting:
  - (1) Spectrum Setting: RBW=1MHz, VBW ≥ RBW.
  - (2) Use video trigger with the trigger level set to enable triggering only on full pulses.
  - (3) Sweep Time is more than once pulse time.
- (4) Set the center frequency on any frequency would be measure and set the frequency span to zero.
  - (5) Measure the maximum time duration of one single pulse.
  - (6) Set the EUT for packet transmitting.

## Test Procedure

- 1. The maximum conducted output power may be measured using a broadband Peak RF power meter.
- 2. Peak power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor.
- 3. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter.
- 4. Record the measurement data.




Allow trace to fully stabilize. Then use the peak marker function to determine the maximum amplitude level.






















# 3.11. Antenna Requirement

# **Requirement**

## FCC CFR Title 47 Part 15 Subpart C Section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

# FCC CFR Title 47 Part 15 Subpart C Section 15.247(c) (1)(i):

(i) Systems operating in the 2400~2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.
