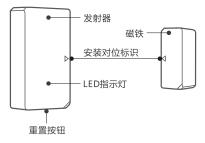

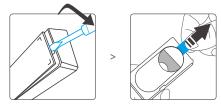
使用说明

1. 下载易微联App



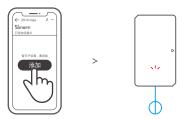
2. 添加 SONOFF Zigbee网关

3. 取出电池绝缘片

4. 添加子设备

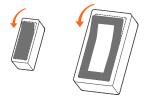


打开eWeLink App, 选择要连接的网关, 点击 "添加" 子设备,然后长按子设备重置按钮5秒 直至LED指示灯呈慢闪状态,子设备进入配对状态,等待设备连接。

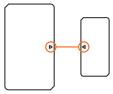
()如添加失败,请将设备移近网关后再重新添加。

5. 安装设备

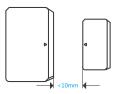
5-1 撕下3M胶保护膜。



5-2 安装时发射器和磁铁上的安装对位标识尽量对齐。



5-3分别粘贴在所需开合区域。



① 发射器和磁铁安装间隙门窗在闭合状态下小于10mm。

(!) 设备重量<1Kg,建议安装高度<2米。

有效距离验证

在选定的设备安装位置,短按设备的重置按键,设备指示灯双闪,表明该设备和Zigbee网络下的设备(路由设备或网关)处于有效通讯距离。

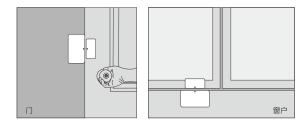
删除子设备

①用户还可在APP子设备界面中删除子设备。

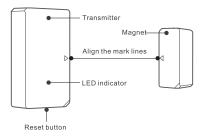

Features

SNZB-04P is a Zigbee low-energy wireless door/window sensor that makes you know the opening/closing status of door and window by separating the magnet from the transmitter. Connect it with the Bridge and you can create a smart scene to trigger other devices.

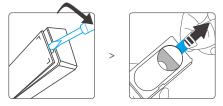
Operation instruction

1. Download the eWeLink App



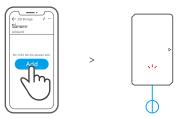
2. Pair SONOFF ZB Bridge to your eWeLink account

3. Pull out the battery insulation sheet



() The device has the version with battery and without battery.

4. Add sub-devices



Access eWeLink App, select the Bridge that you want to connect, and tap "Add" to add a sub-device. Then long press reset button on the device for 5s until the LED indicator flashes slowly, which means the device has entered the pairing mode, and be patient until pairing completes.

() If the addition failed, move the sub-device closer to the Bridge and try again.

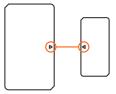
5. Install the device

5-1. Tear off the protective film of the 3M adhesive.

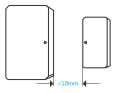




5-2. Try to align the mark line on the magnet with that on the transmitter during installation.



5-3. Install them in the opening and closing area separately.



- ① Make sure the installation gap is less than 10mm when the door or the window is closed.
- ① The device weight is less than 1 kg. The installation height of less than 2 m is recommended.

Effective Communication Distance Verification

Install the device in the desired place, then press the "Reset" button on the device. The LED indicator flashes twice means the device and the device under the same Zigbee network (the router device or hub) are in the effective communication distance.

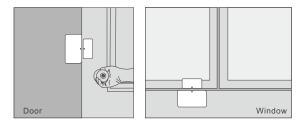
Delete sub-devices

Long press the reset button on the sub-device for 5s until the LED indicator flashes three times. In this case, the sub-device is deleted from the Bridge successfully.



Users can delete sub-devices directly from the sub-device page on APP.

Application



Note:

- Do not install outside the door/window.
- Do not install in the unstable position or in the place exposed to rain or moisture.
- Do not install near wiring or magnetic object.
