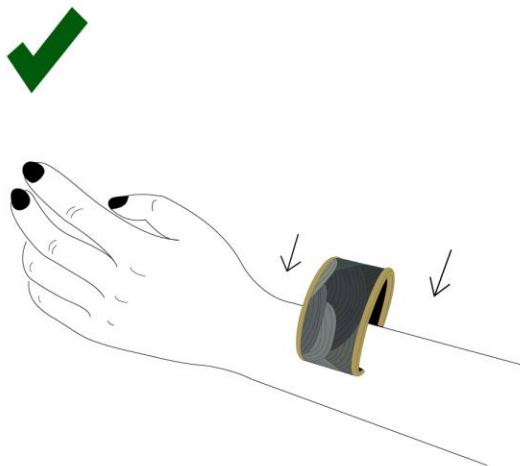

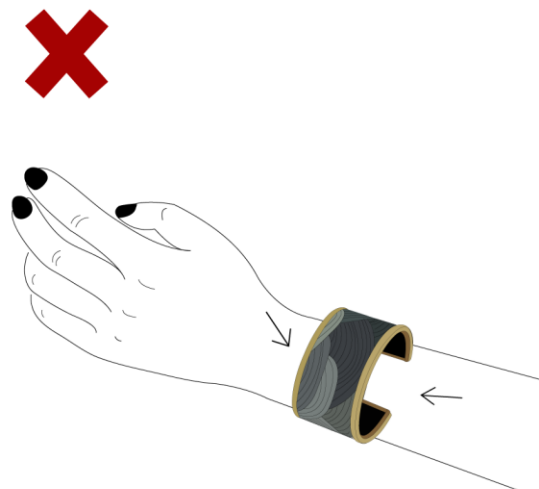


PLEASE MAKE SURE YOU PUT YOUR ONA BANGLE ON YOUR WRIST FROM THE RIGHT DIRECTION

Turn it slightly on the side and slide
it upon your wrist



Do not force it or push it strongly
from the front side



If you feel that the bangle is not comfortable, please consider a different size.

PLEASE MAKE SURE THAT YOUR SMARTPHONE AND ONA BANGLE IS WITHIN A RANGE WHEN CHANGING ART

Keep your smartphone and bangle within 60cm for fast change



If the range between the two is too long, it might not work

PLEASE MAKE SURE YOU PLACE THE ONA BANGLE ONTO THE CHARGER WITH THE RIGHT POSITION

Place it in the middle and look for
the blue light to turn on



If it is not in the middle or the blue
light is off it will not charge

- Remove the ONA bangle before washing hands, swimming, and/or applying products (e.g., perfume, hairspray, soap, or lotion), as this could harm the metal and reduce the life of the plating, as well as cause discoloration and loss of reflections of the display.
- Put on ONA bangle last when dressing and take off first when undressing.
- Avoid direct contact with both salt and fresh water, solvents, detergents, perfumes, cosmetic products, etc.
- Avoid hard contact (i.e., knocking against objects) that can scratch or chip the metal or display surface.
- Avoid wearing the bangle together with bracelets, metallic chains, watches or any other contact with hard objects.
- Avoid storing the bangle in cold (<10°C) or hot (50°C <) places
