To Whom It May Concern:

Pursuant to the provisions of Sections 0.457 and 0.459 of the Commission's rules (47 CFR §§ 0.457, 0.459), we are requesting the Commission to withhold the following attachments as confidential document from public disclosure indefinitely.

The radio system is only available to authorized purchasers and does not contain any user-serviceable components. We request that the internal photos be kept confidential long-term under the FCC guidelines that this is a business product not a direct consumer product and is only serviceable by employees and subcontractors of SmartSky, with all service personnel subject to non-disclosure agreements. The user manual is requested to remain confidential long-term under the FCC guidelines that the manual is technical and specific to installation on authorized aircraft and is not provided to the general public. The user manual contains proprietary information used by trained technicians to install and verify device operations.


Furthermore, the block diagrams, schematics, parts list antenna specification and operational description are requested to be confidential long-term under the FCC guidelines since our design incorporates a software-defined radio architecture which is innovative and proprietary to SmartSky. SmartSky has spent substantial effort in developing this product and is one of the first of its kind in the industry. Having subject information easily available to competitors would negate the advantage SmartSky has achieved by developing this product. Not protecting the details of design will result in financial hardship.

In addition to above mentioned documents, pursuant to Public Notice DA 04-1705 of the Commission's policy, we are requesting the commission to grant short-term confidentiality request on the following for One Hundred Eighty (180) days from the date of the grant.



## **CONSUMER DISCLOSURE**

From time to time, SmartSky Networks (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. ### **Getting paper copies**
