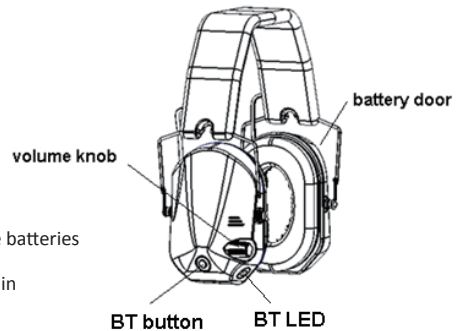


Digital BT Earmuff (BFT20B) - Instruction Manual

- Crystal clear and full dynamic speakers
- Two omni-directional microphones
- Sound activated compression for hearing protection while permitting normal conversation
- Low power **Bluetooth 4.0**: phone call or stream audio
- Volume control knob (off/on/sound volume adjustment)
- Foldable headband design for easier carry
- Adjustable headband length to fit different head size
- Soft ear cushion for maximum comfort
- Slim shape cup housing
- Replaceable 1.5V AAA batteries (2pc), included Vinnic alkaline batteries

Bluetooth

Power ON / OFF

- Long press the BT button (3 seconds) to turn ON the Bluetooth and enter pairing mode (timeout 120 seconds)
- Long press the BT button (3 seconds) to turn OFF the Bluetooth

BT Pairing

- Blue LED will flash (1 second intervals) while in pairing mode.
- Search advertising name: "QT" to connect
- Auto re-connect to previous last connected device during pairing if the BT device has been paired previously
- After paired, blue LED will be blinking every 10 seconds
- Bluetooth device will be switched off after 120 seconds if the device does not pair successfully

Phone Call

- To answer a call, short press the BT button
- To end a call, short press the BT button
- To reject a call, press the BT button for 1sec
- During a phone call, if another call is received, double press the BT button to switch from first call to the second call.
- Double press the BT button to redial the last phone number

Audio Play

- To play music, short press the BT button
- To pause music, short press the BT button during playback
