Band13-10MHz-QPSK-23230-1RB#0-Range2:0.15~30MHz



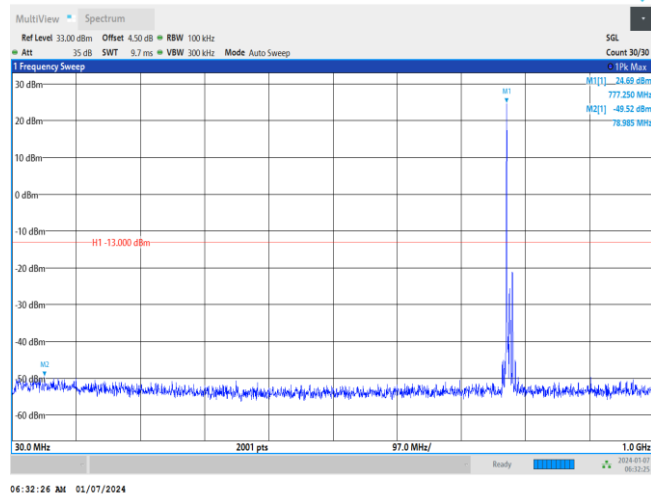

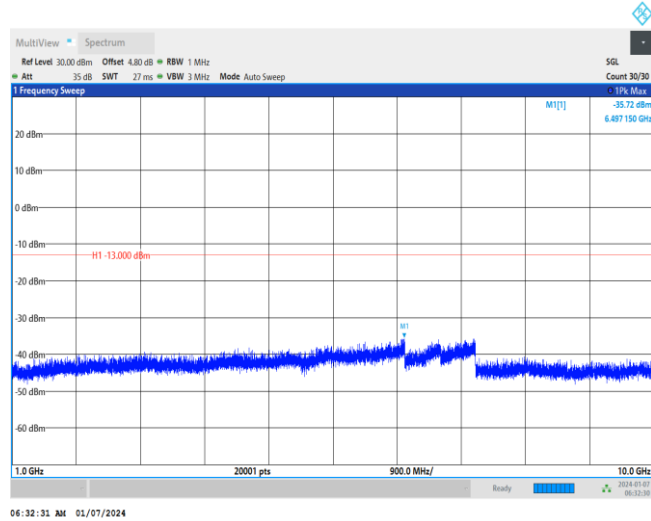
