Band17-5MHz-16QAM-23790-25RB#0

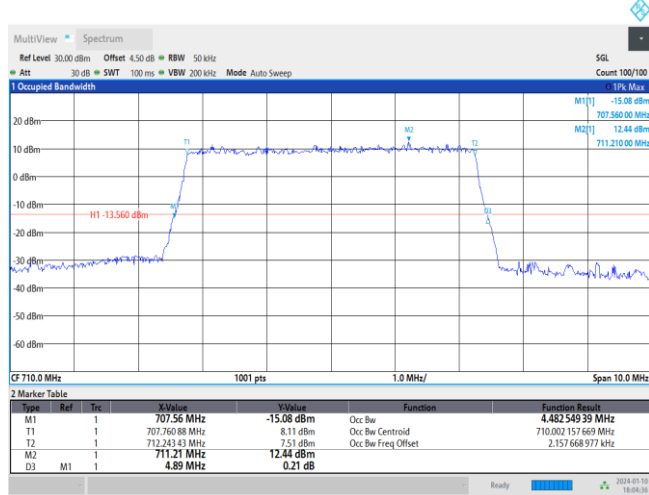
