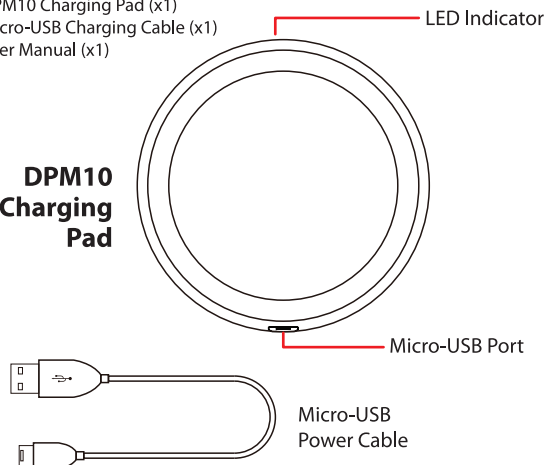

Powering the Charging Pad

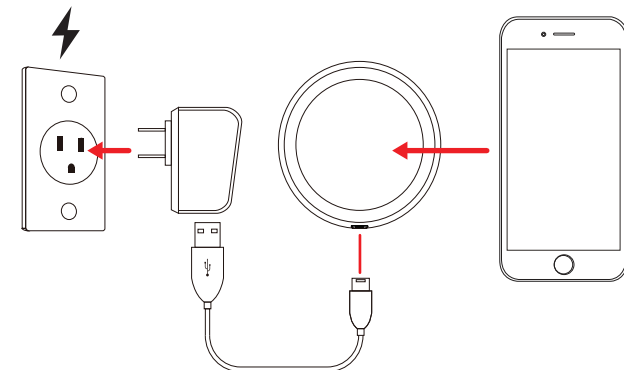
Attach the small connector of the supplied micro-USB power cable to the micro-USB port on the charging pad. Attach the large connector to a **5V USB adapter** (not included) and plug into a wall socket.

The LED indicator will turn **RED** to indicate that the charging pad has power.

Using the Charging Pad

After plugging in the charging pad, place your device in the center of the charging pad. The LED indicator will turn **BLUE** to indicate that your device is charging.

If your device does not begin to charge, try repositioning your device on the charging pad. **You may need to remove your smartphone case if you are using one.** After your device is fully charged, disconnect and unplug the charging pad.
