



INSTALLATION PROCESS:


1. Fix the wireless charger under any non-metallic furniture (wood, plastic, ceramic, glass,...) by using the double tape sticker.



NOTE: Furniture thickness should be between 25 to 35mm.


- 2. You can fix the product also with the M3*16
- 3. Stick the antenna sticker exactly aligned with the center of the wireless charger.

Antenna stiker must be placed on center



NOTE: Furniture thickness should be between 25 to 35mm.

4. Plug the wireless charger on the power adapter.



5. Place your phone on the center of the antenna sticker to start charging.

IMPORTANT ATTENTION:

The thickness of the furniture must be between 25 to 35 mm.



The vertical distance should not be less than 25 mm. Equipment below 25mm, enters in protection status and does not work.



The center of the antenna sticker fixed on the top of the furniture has to be exactly the same as the center for the wireless charger installed on the bottom



Do not place any metal object or credit card, magnetic storage media near the product, because information stored on may be erased.




