2.1.2 Test Graph



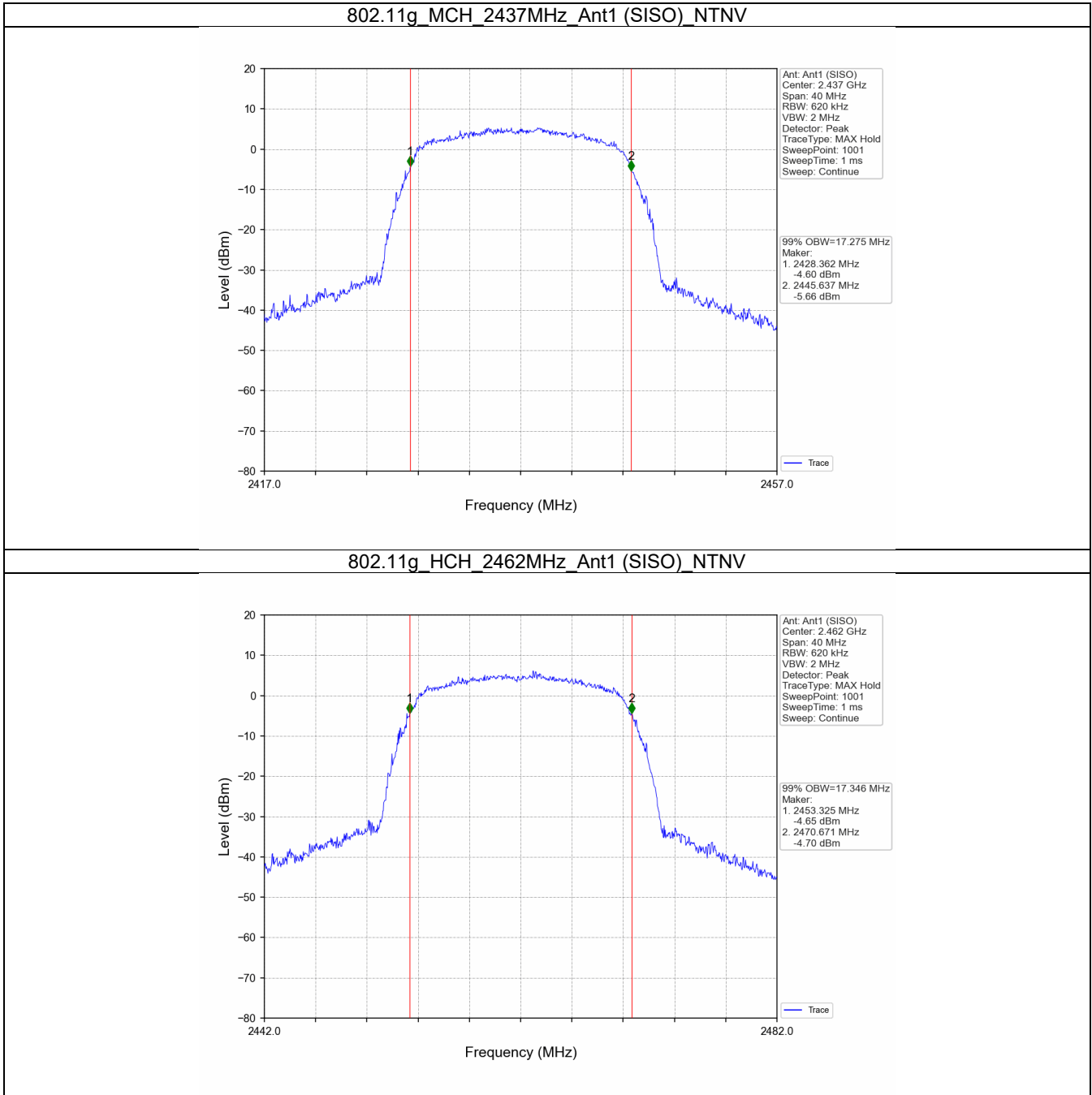

2.2.2 Test Graph



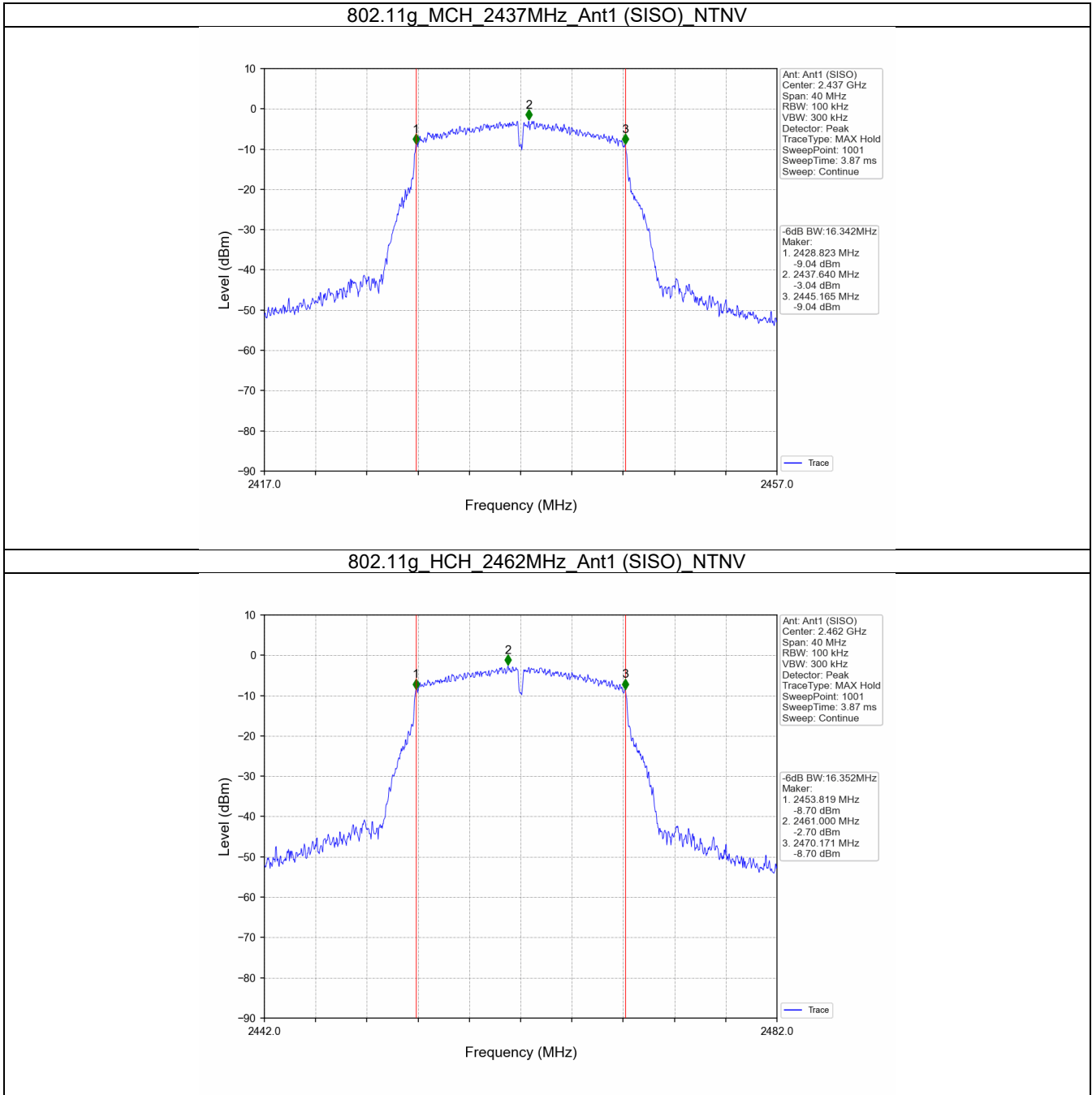

4.1.2 Test Graph



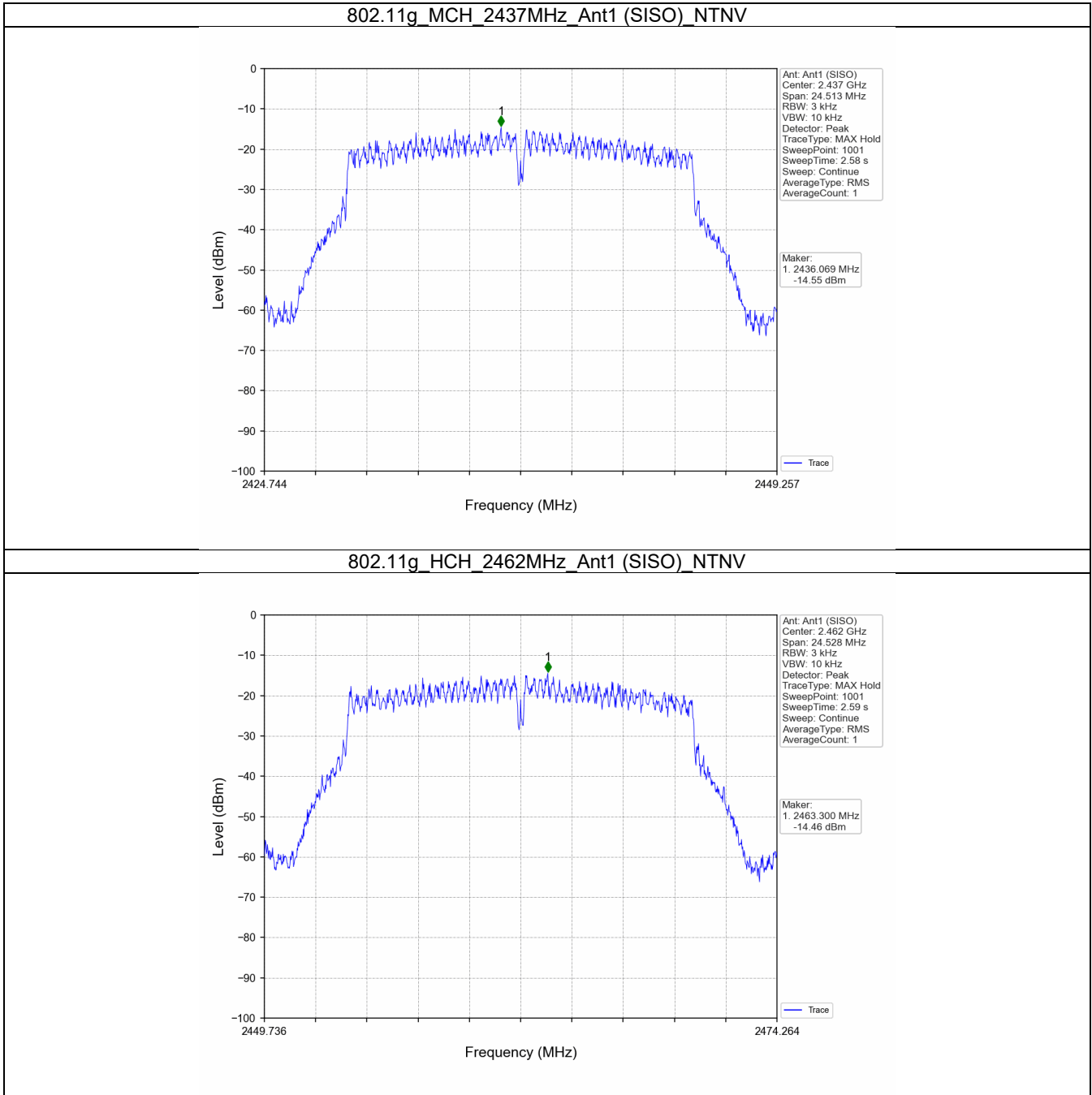
