OFDM_HCH_925MHz_Ant1_NTNV



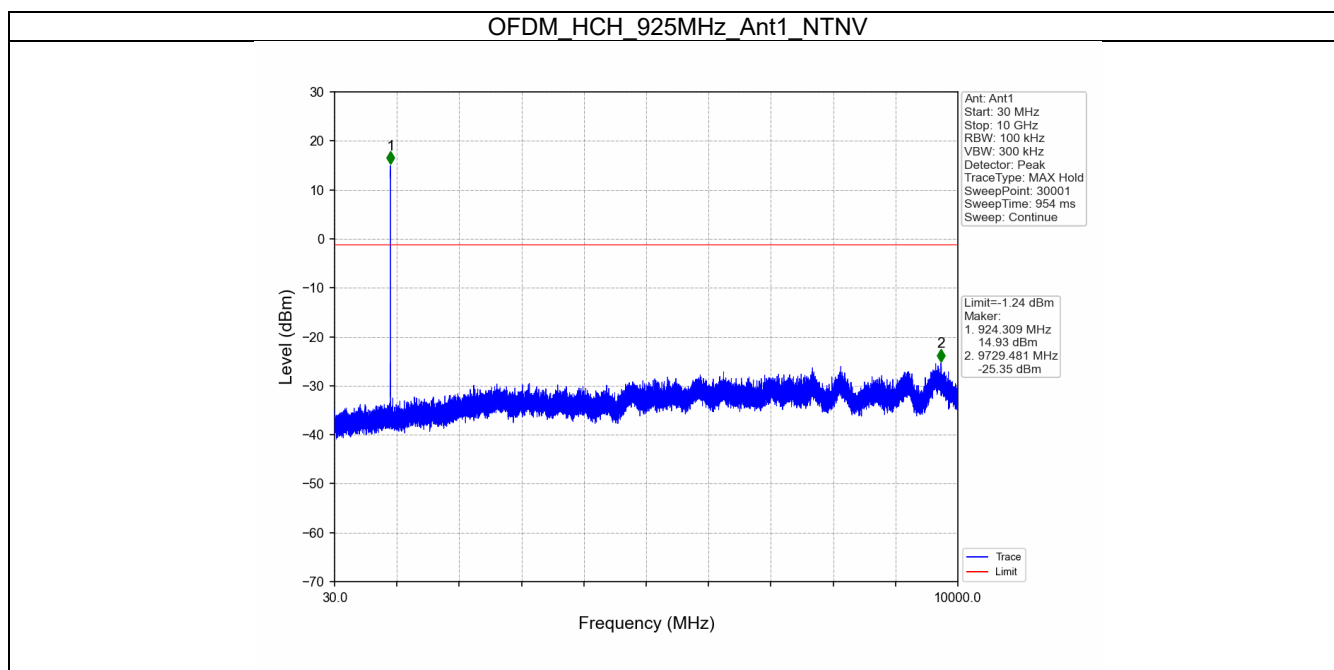
