Objective

The objective is to determine the compliance of EUT with FCC rules, section 15.203, 15.205, 15.209, 15.215 and 15.227.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 4.75 dB for 30MHz-1GHz, and 4.42 dB for 9kHz-30MHz, 1.6dB for conducted measurement.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Shenzhen) to collect test data is located on the 6/F., West Wing, Third Phase of Wanli Industrial Building, Shihua Road, Futian Free Trade Zone, Shenzhen, Guangdong, China.

The test site has been approved by the FCC under the KDB 974614 D01 and is listed in the FCC Public Access Link (PAL) database, FCC Registration No. : 342867, the FCC Designation No. : CN1221.

The test site has been registered with ISED Canada under ISED Canada Registration Number 3062B.




(b) The field strength of any emissions which appear outside of this band shall not exceed the general radiated emission limits in §15.209.

Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-4, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is 4.75 dB for 30MHz-1GHz, and 4.42 dB for 9kHz-30MHz.(k=2, 95% level of confidence), and the uncertainty will not be taken into consideration for all the test data recorded in the report.

EUT Setup



The radiated emission tests were performed in the 3 meters, using the setup accordance with the ANSI C63.10-2013. The specification used was the FCC Part 15.205 and 15.209 and 15.227 limits.

EMI Test Receiver Setup

The system was investigated from 9 kHz to 1000 MHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Correction Factor Correction Factor = Antenna Loss + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude




