

- a) The EUT was configured for testing in a typical fashion (as a customer would normally use it). The EUT has been programmed to continuously transmit during test. This operating condition was tested and used to collect the included data.
- b) The following is the setting of the receiver

Attenuation: 10dB

Start Frequency: 0.15MHz Stop Frequency: 30MHz IF Bandwidth: 9kHz

c) The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipment powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.

5. Radiated Emissions







- c) Use the following spectrum analyzer settings:

- d) Follow the guidelines in ANSI C63.4-2014 with respect to maximizing the emission by rotating the EUT, adjusting the measurement antenna height and polarization, etc. The peak reading of the emission, after being corrected by the antenna factor, cable loss, pre-amp gain, etc., is the peak field strength, submit this data. Each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.



7.1 Standard and Limit


According to 15.247(b)(3). For systems using digital modulation in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. 

Test Setup Block Diagram



Test Setup Block Diagram


