



USING YOUR CHARGING PAD

- 1 Plug one end of the USB cable into the Micro USB port on the back of your charging pad.
- 2 Plug the other end of the USB cable into a USB wall charger.





3 Place your Qi-enabled device on the center of your charging pad with the screen facing up. The LED is blue when your device is charging.

Note: If the LED is red, your device is not charging.

LED INDICATOR STATUS

LED	STATUS
Blinking blue	Standby
Solid blue	Charging
Blue and red both on	Quick charging
Solid red	Insufficient input power
Blinking red	Charging error

TROUBLESHOOTING

Device not charging/LED is red

- Make sure that your device is Qi-enabled.
- Make sure that your charging pad is connected to a working power outlet.
- Make sure that your device is positioned correctly on your charging pad.
- · Make sure that there are no other objects on the charging pad.
- Remove your device's case. It may be blocking the wireless signal.

Device charges slowly

- Your device may charge more slowly with the charging pad than a charging cable. This is normal behavior.
- Make sure that your device is positioned in the center of your charging pad.

CAUTION: Only use the cable with the wall charger that came with your charger. Using a different cable and wall charger can decrease charging performance or damage your charger.
