



USING YOUR CHARGING PAD

- Plug the power adapter into your charging pad and into a power outlet
- 2 Place your Qi-enabled device on the center of your charging pad with the screen facing up. The LED is blue when your device is charging. If your pad is guick charging, both the blue and red LED light.



Note: If the LED is red, your device is not charging. **CAUTION:** Do not place a credit or debit card on your charging pad. See "TROUBLESHOOTING" for more information.

TROUBLESHOOTING

- Device not charging/LED is red
- Make sure that your device is Oi-enabled. • Make sure that your charging pad is connected to a
- working power outlet.
- Make sure that your device is positioned correctly on your charging pad.
- Make sure that there are no other objects on the charging pad.
- Remove your device's case. It may be blocking the wireless signal.

Device charges slowly

- Your device may charge more slowly with the charging pad than a charging cable. This is normal behavior.
- Make sure that your device is positioned in the center of your charging pad.

CAUTION: Only use the cable with the attached power adapter that came with your charger. Using a different cable and adapter can decrease charging performance or damage your charger.
