

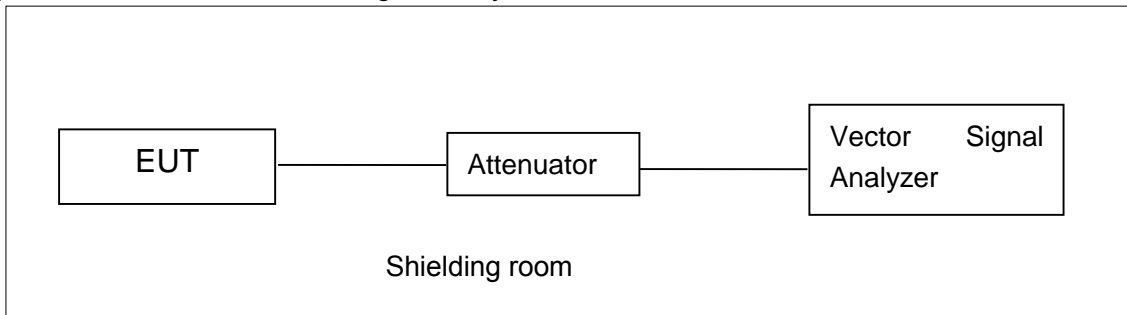

- 2). Set the EUT to the required work mode.
- 3). Set the EUT to the required channel.
- 4). Set the spectrum analyzer to start measurement.
- 5). Record the values. Vector Signal Analyzer

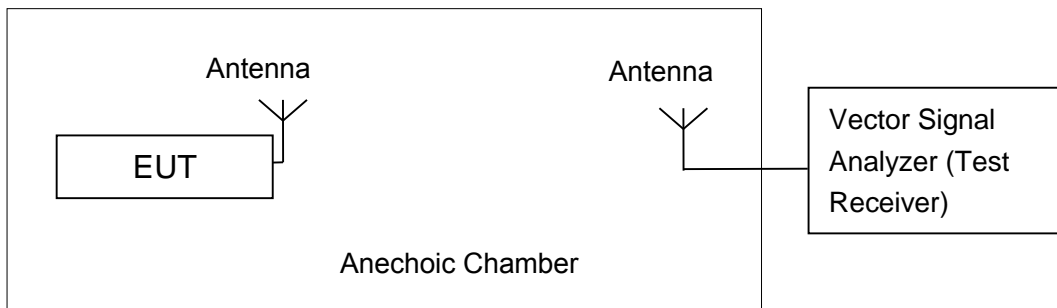


#### A.1.2. Radiated Emission Measurements

In the case of radiated emission, the used settings are as follows,

Sweep frequency from 30 MHz to 1GHz, RBW = 100 kHz, VBW = 300 kHz;

Sweep frequency from 1 GHz to 26GHz, RBW = 1MHz, VBW = 10Hz;



The measurement is made according to KDB 789033

The radiated emission test is performed in semi-anechoic chamber. The distance from the EUT to the reference point of measurement antenna is 3m. The test is carried out on both vertical and horizontal polarization and only maximization result of both polarizations is kept. During the test, the turntable is rotated 360° and the measurement antenna is moved from 1m to 4m to get the maximization result.

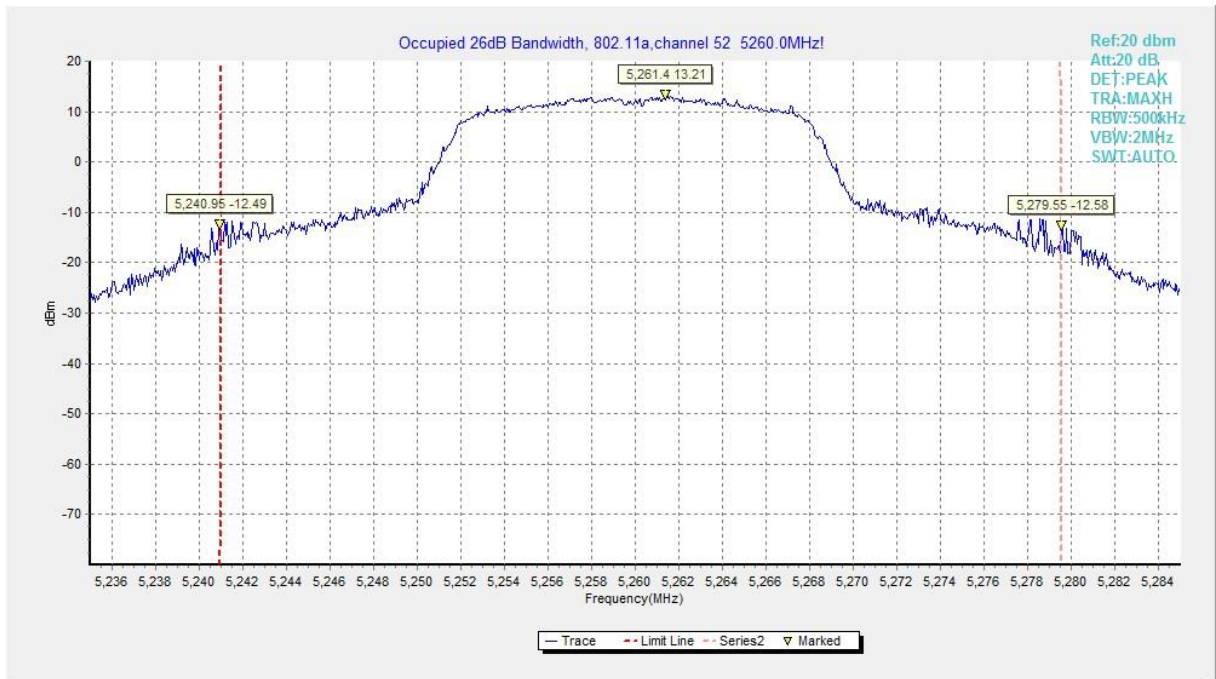
**Fig.1 Occupied 26dB Bandwidth (802.11a, 5180MHz)**



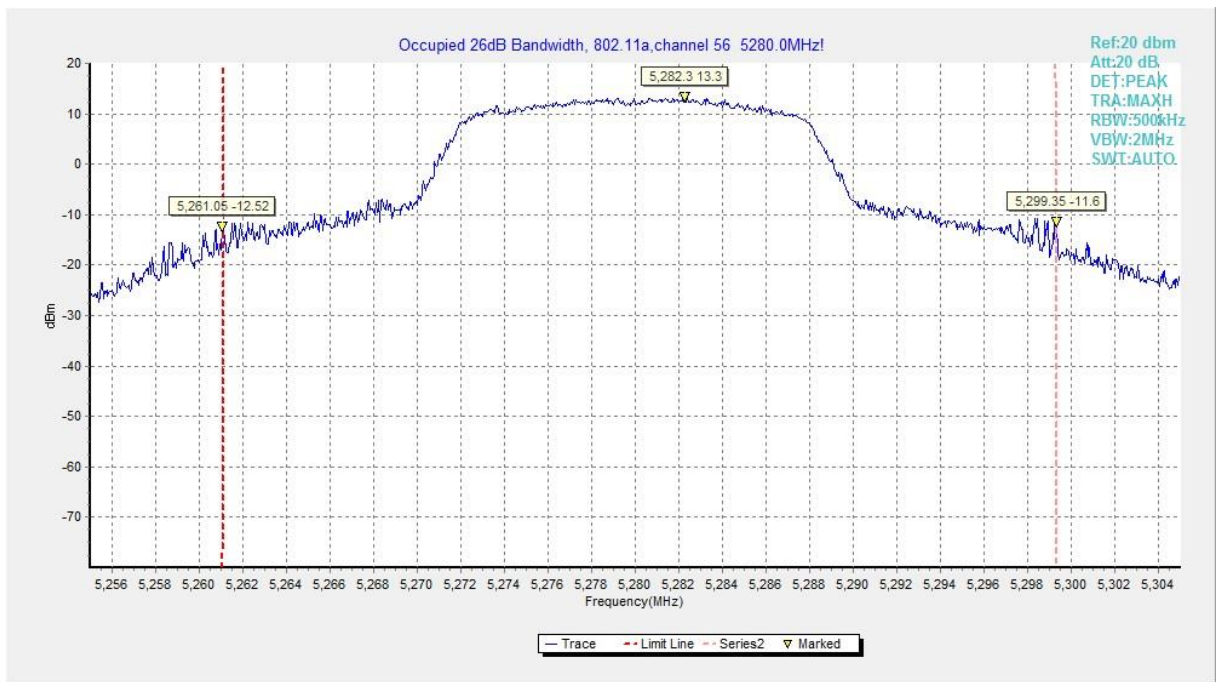
**Fig.2 Occupied 26dB Bandwidth (802.11a, 5200MHz)**



**Fig.3 Occupied 26dB Bandwidth (802.11a, 5240MHz)**

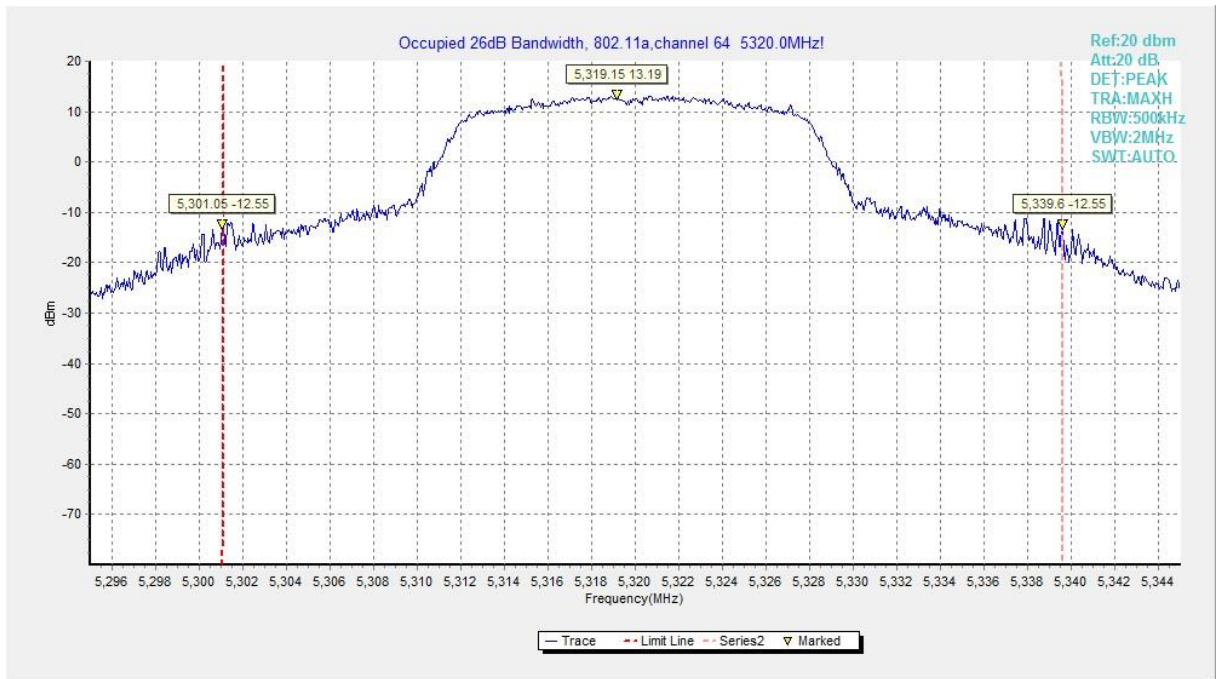


**Fig.4 Occupied 26dB Bandwidth (802.11a, 5260MHz)**

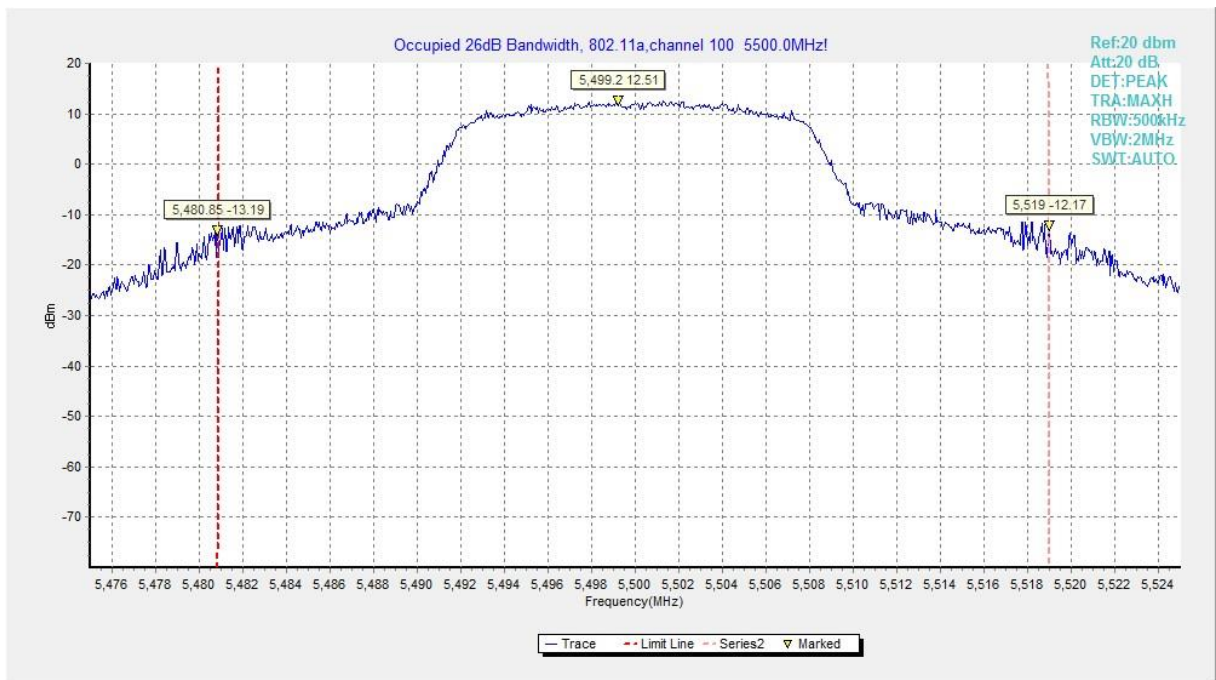


**Fig.5 Occupied 26dB Bandwidth (802.11a, 5280MHz)**

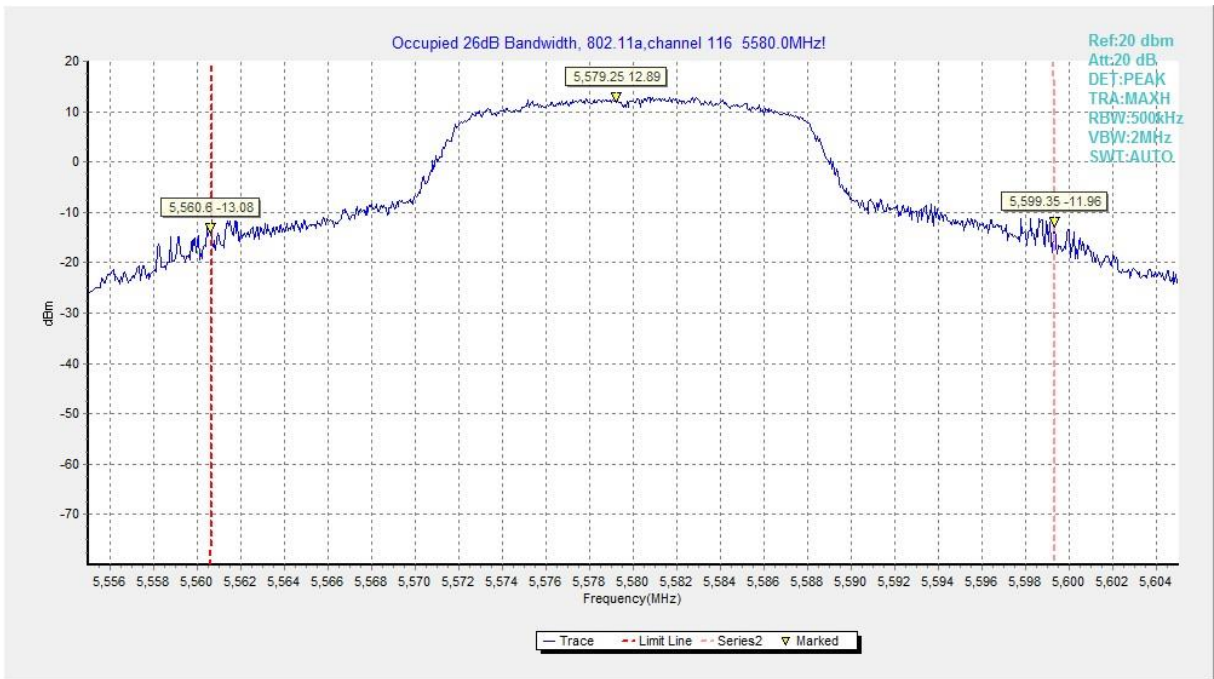




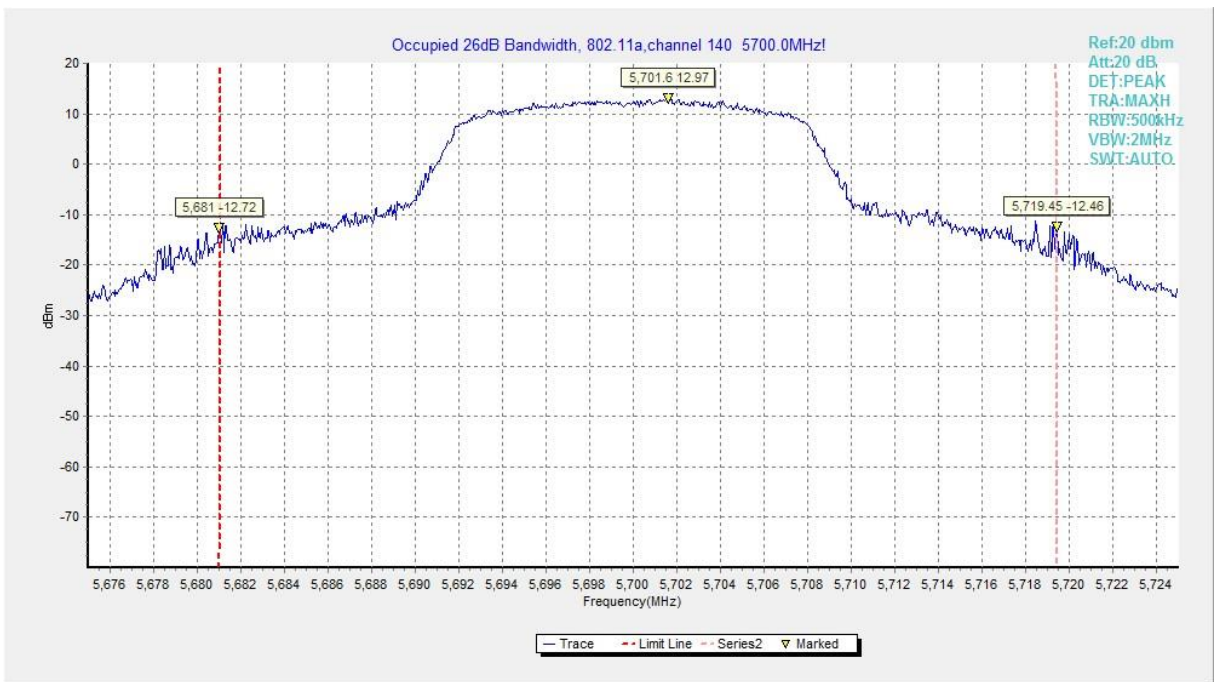
**Fig.6 Occupied 26dB Bandwidth (802.11a, 5320MHz)**



**Fig.7 Occupied 26dB Bandwidth (802.11a, 5500MHz)**



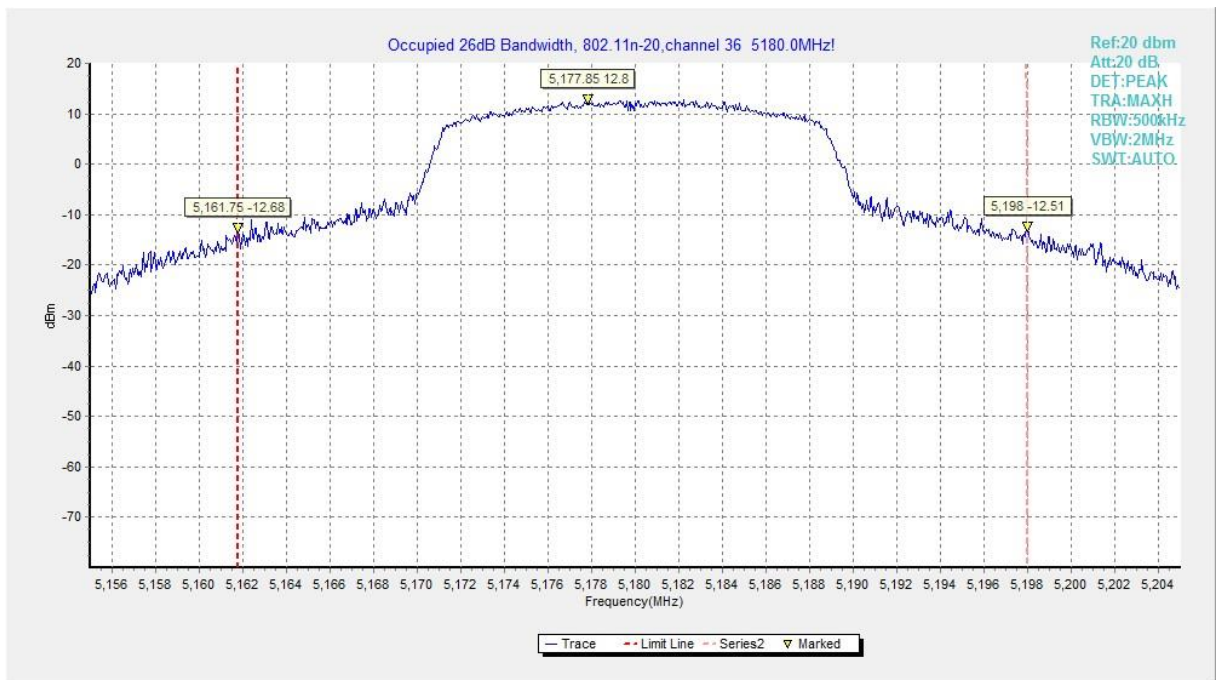
**Fig.8 Occupied 26dB Bandwidth (802.11a, 5580MHz)**



**Fig.9 Occupied 26dB Bandwidth (802.11a, 5700MHz)**

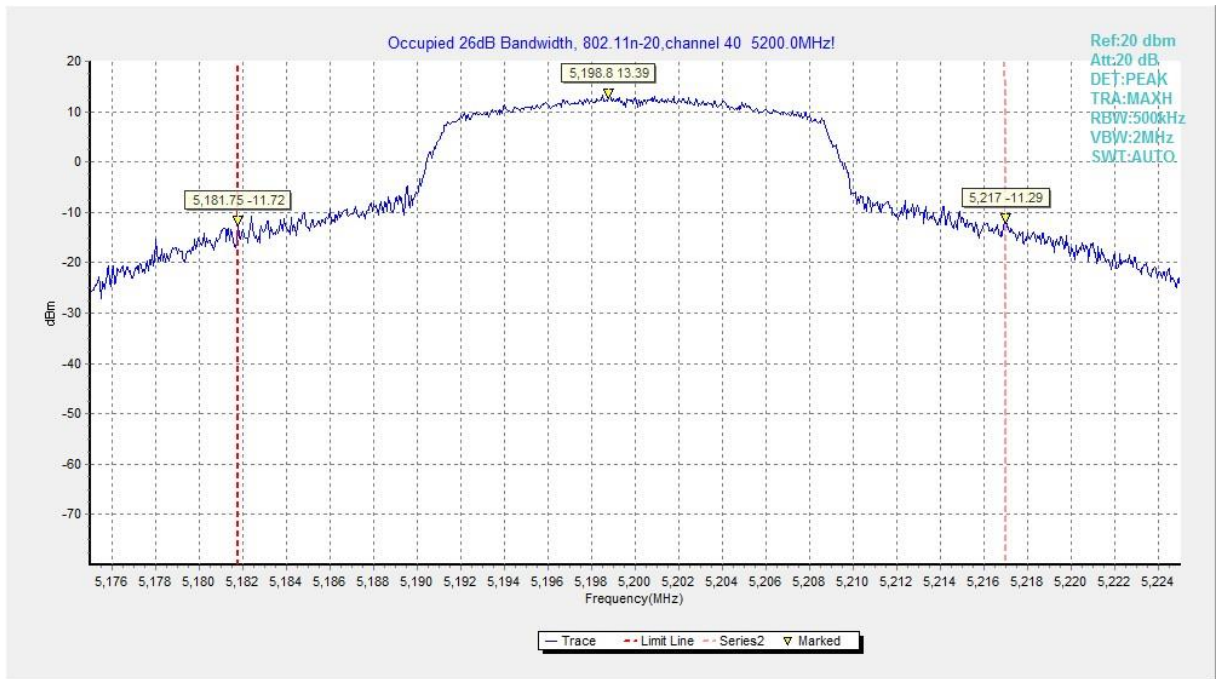


**Fig.10 Occupied 26dB Bandwidth (802.11a, 5720MHz)**

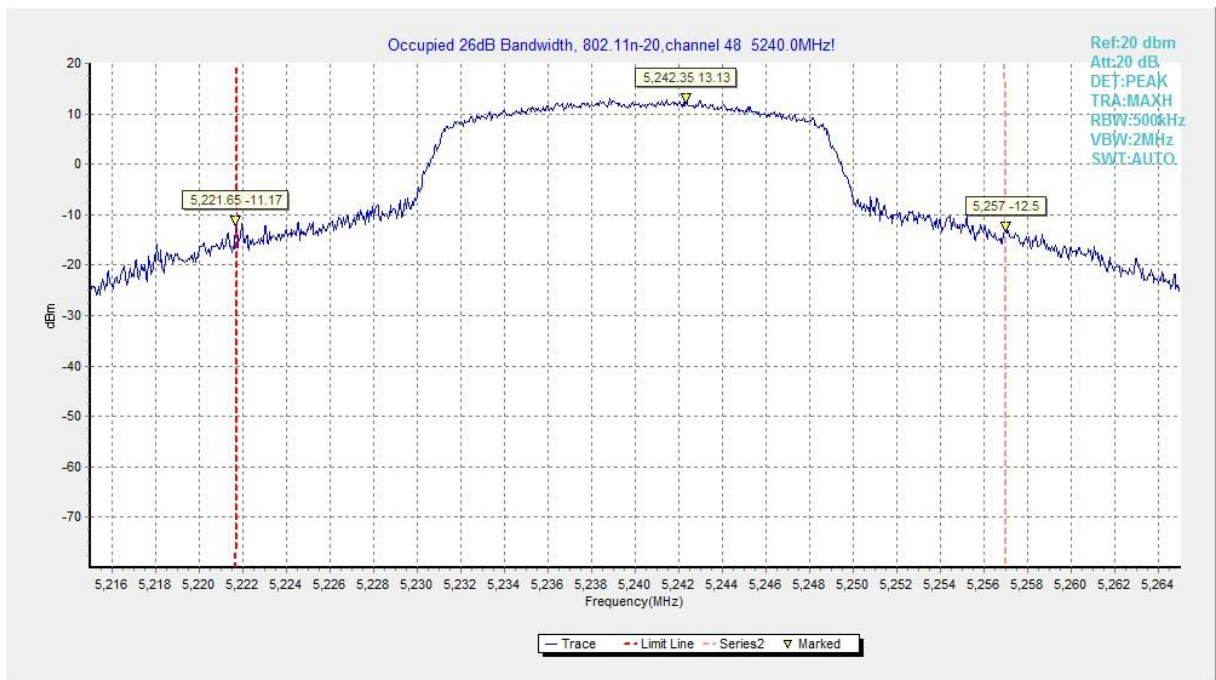


**Fig.11 Occupied 26dB Bandwidth (802.11n-HT20, 5180MHz)**



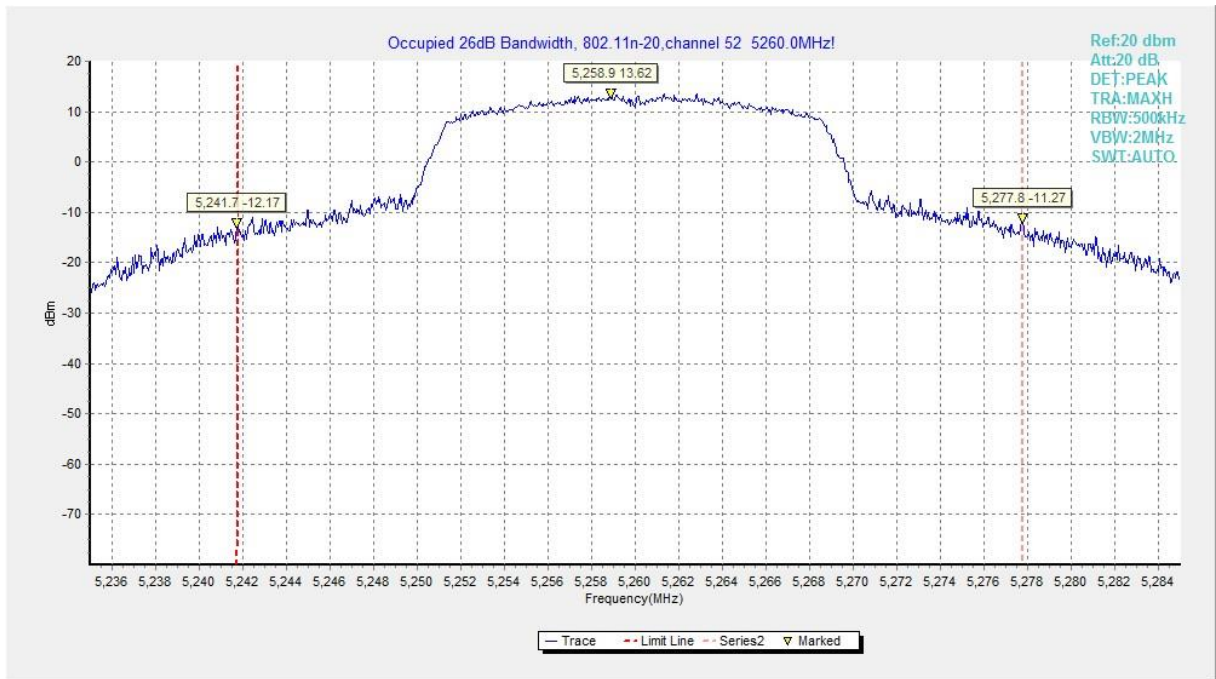


**Fig.12 Occupied 26dB Bandwidth (802.11n-HT20, 5200MHz)**

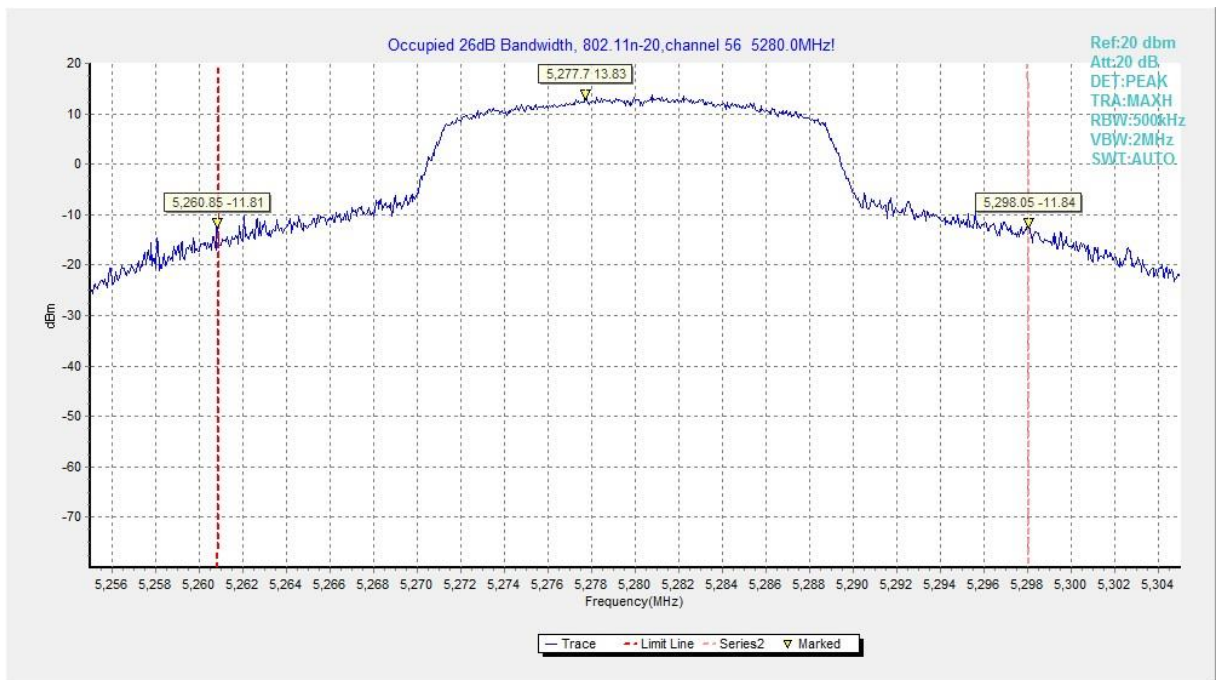


**Fig.13 Occupied 26dB Bandwidth (802.11n-HT20, 5240MHz)**

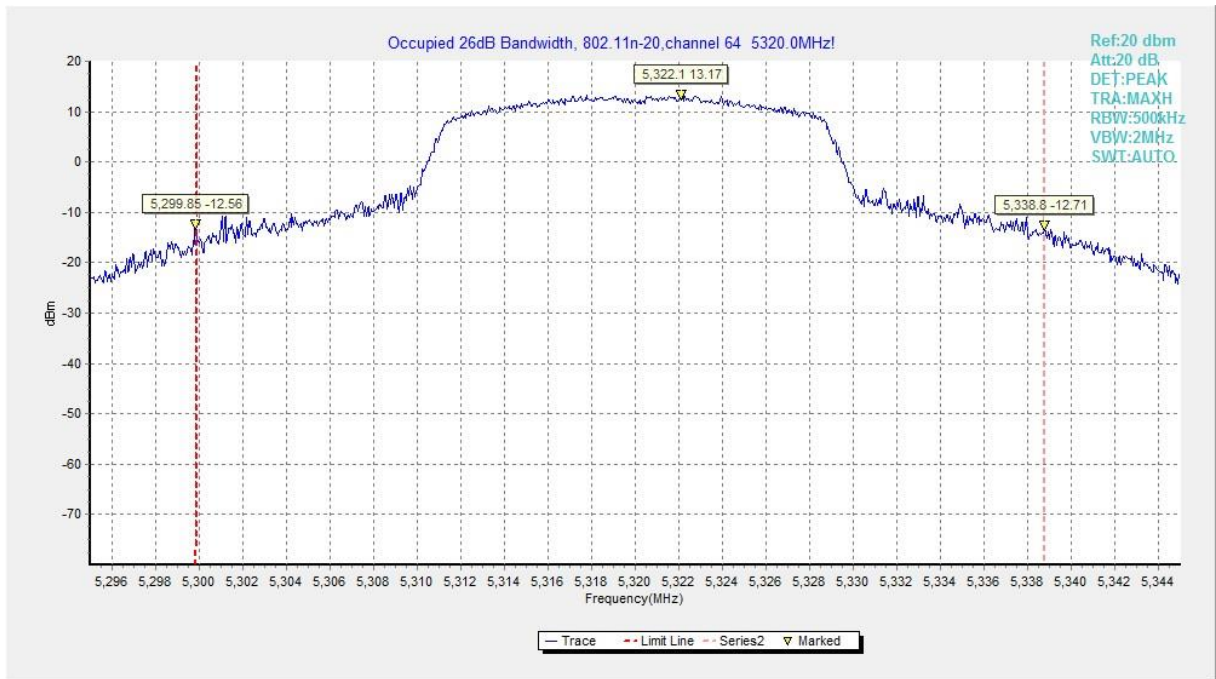




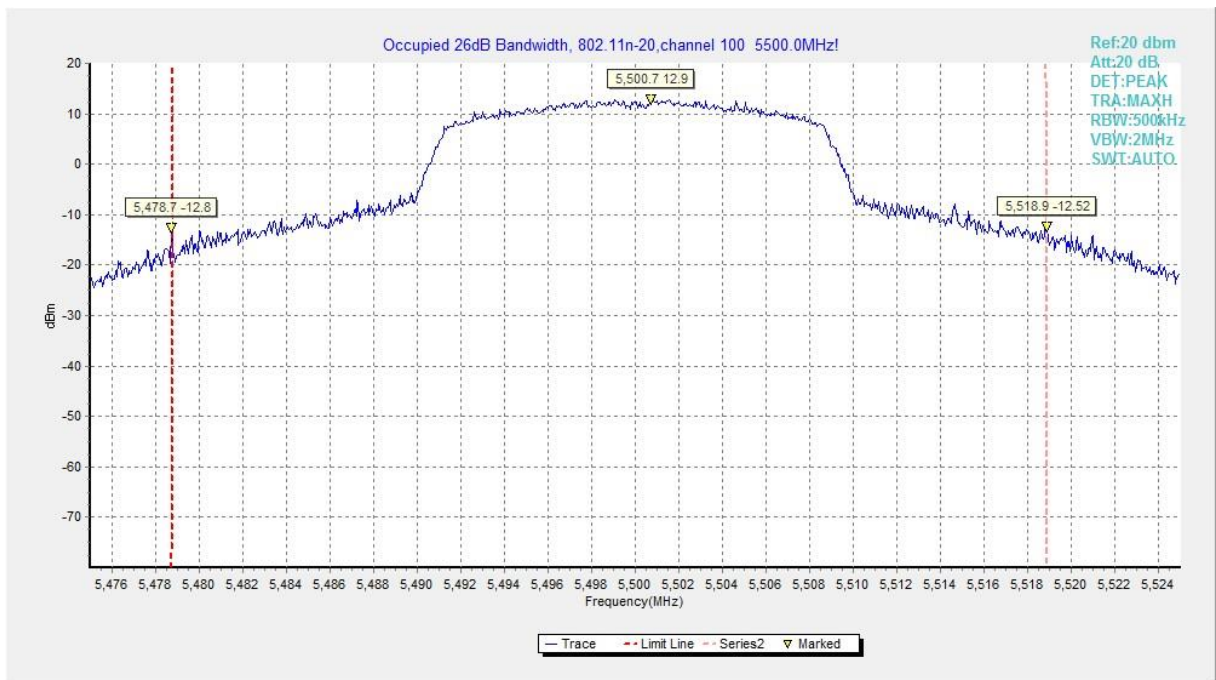
**Fig.14 Occupied 26dB Bandwidth (802.11n-HT20, 5260MHz)**



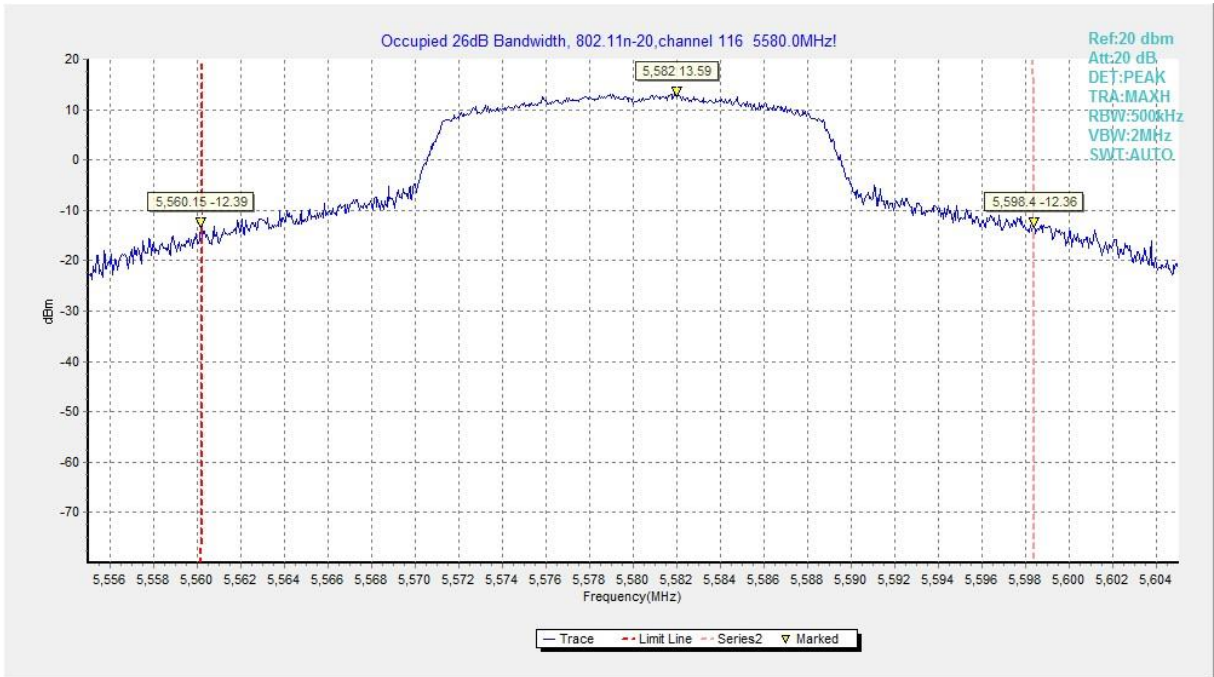
**Fig.15 Occupied 26dB Bandwidth (802.11n-HT20, 5280MHz)**



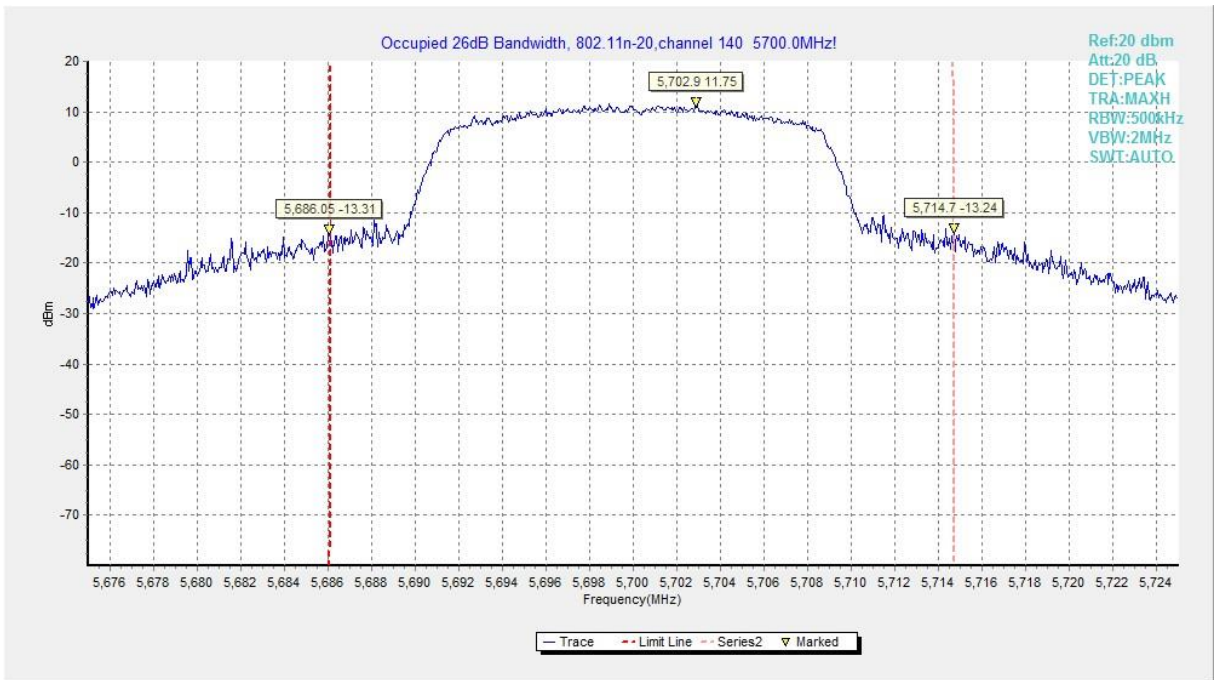
**Fig.16 Occupied 26dB Bandwidth (802.11n-HT20, 5320MHz)**



**Fig.17 Occupied 26dB Bandwidth (802.11n-HT20, 5500MHz)**

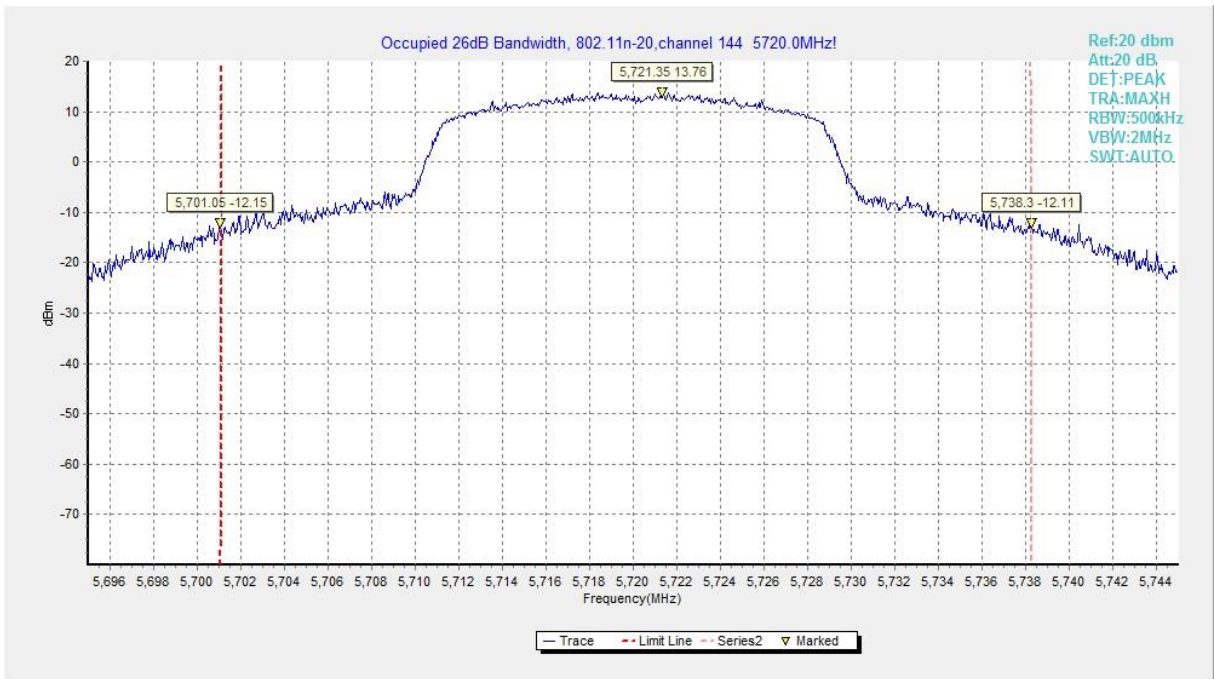


**Fig.18 Occupied 26dB Bandwidth (802. 11n-HT20, 5580MHz)**

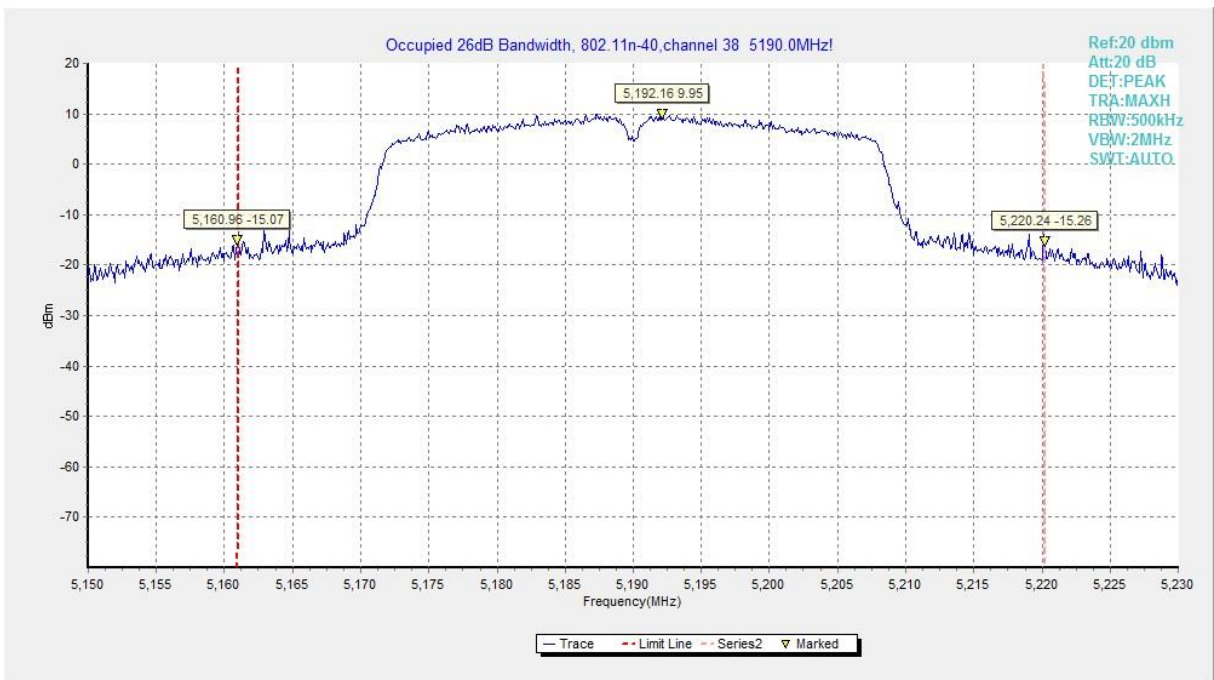


**Fig.19 Occupied 26dB Bandwidth (802. 11n-HT20, 5700MHz)**

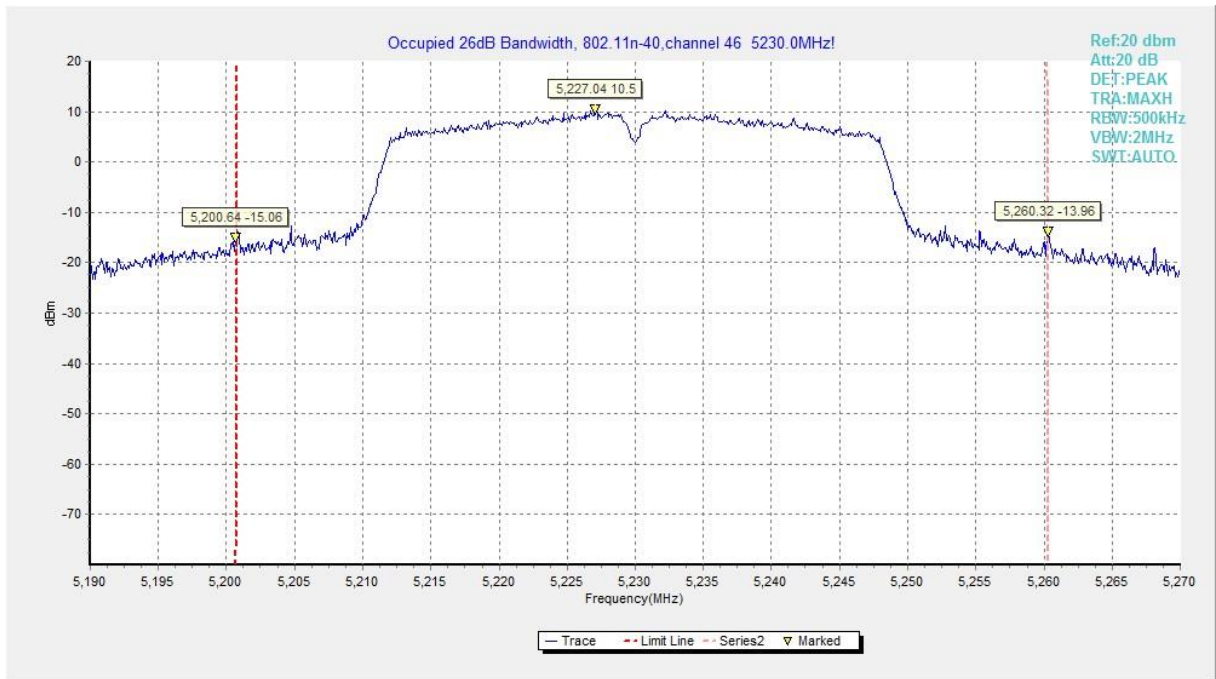




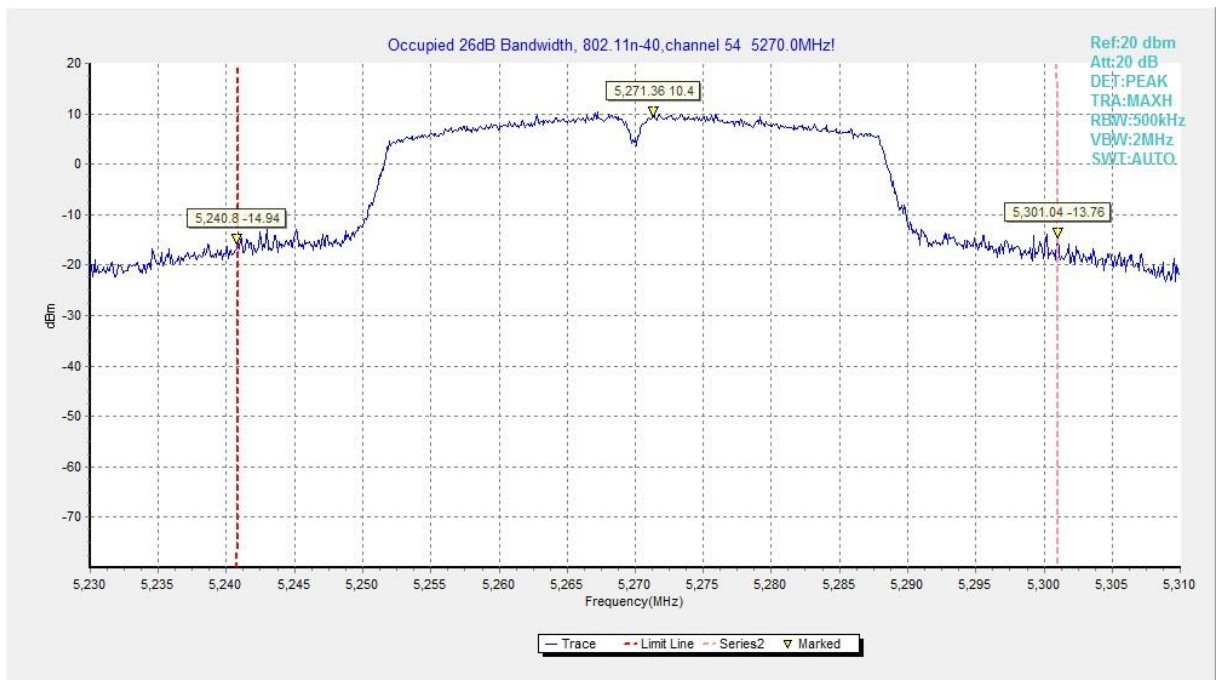
**Fig.20 Occupied 26dB Bandwidth (802. 11n-HT20, 5720MHz)**



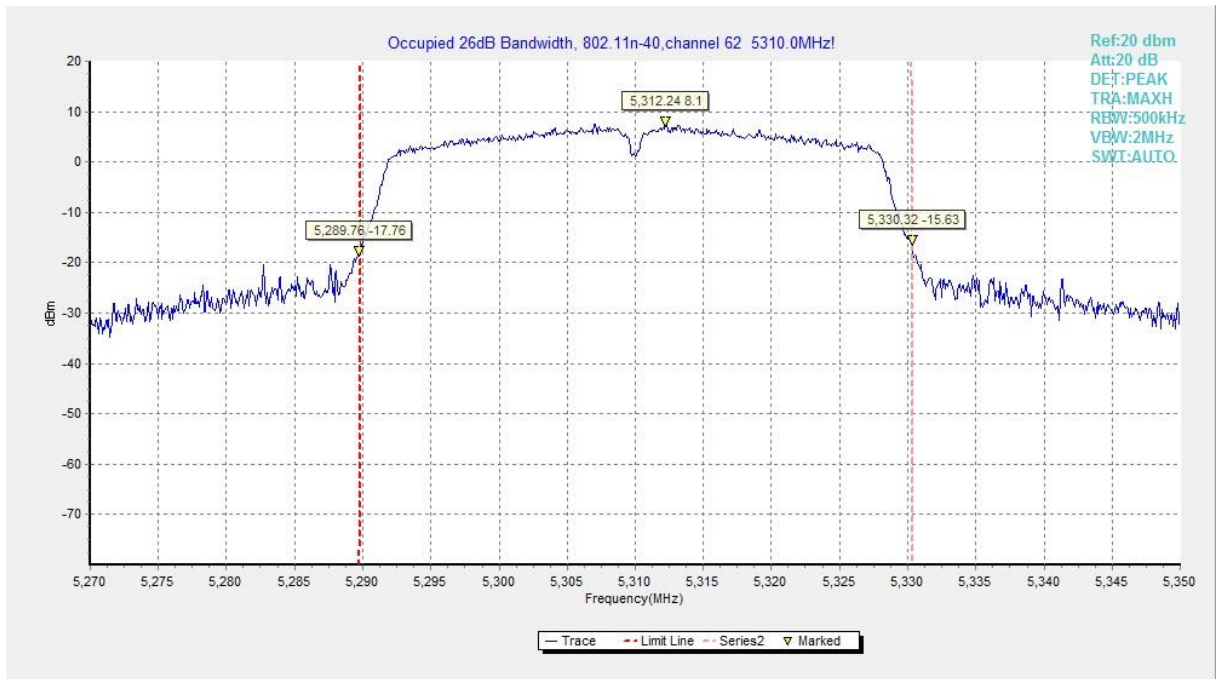
**Fig.21 Occupied 26dB Bandwidth (802.11n-HT40, 5190MHz)**



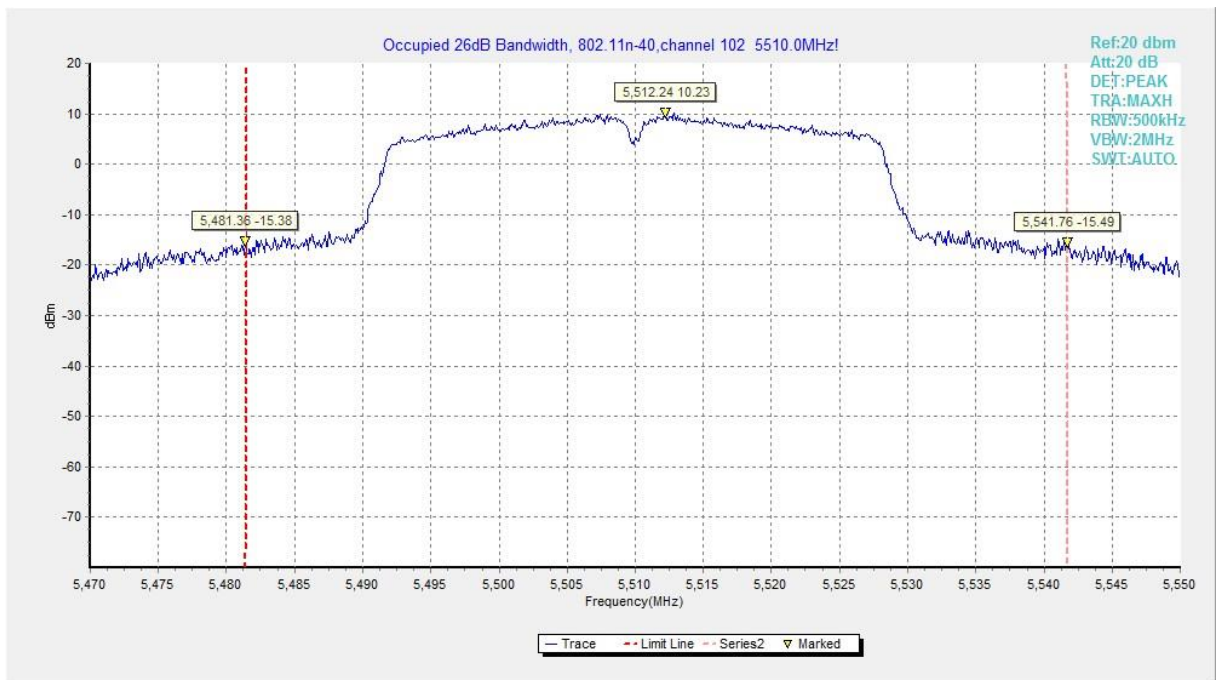
**Fig.22 Occupied 26dB Bandwidth (802.11n-HT40, 5230MHz)**

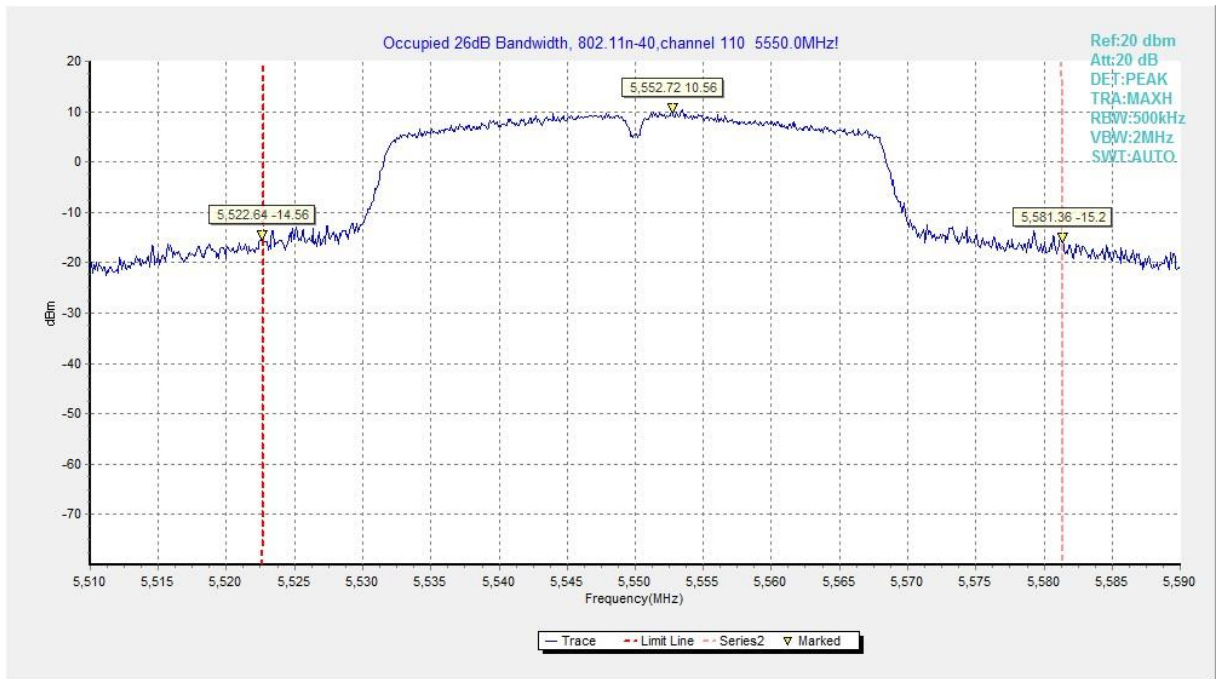


Fig.26 Occupied 26dB Bandwidth (802. 11n-HT40, 5590MHz)

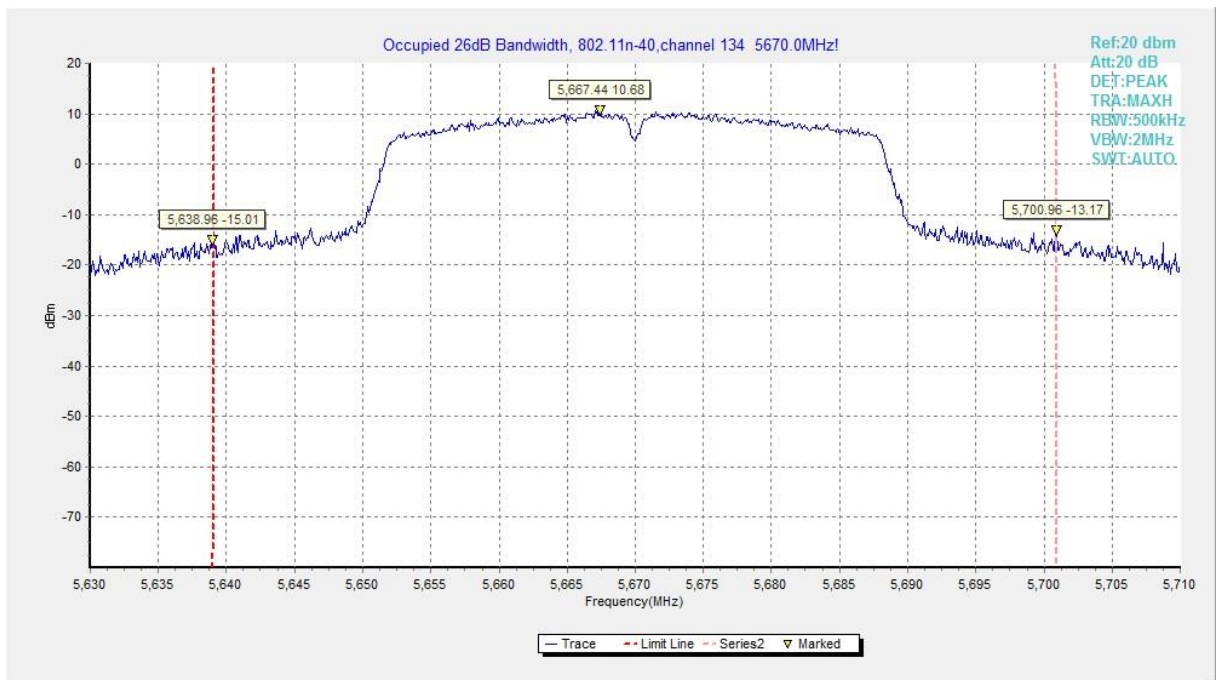
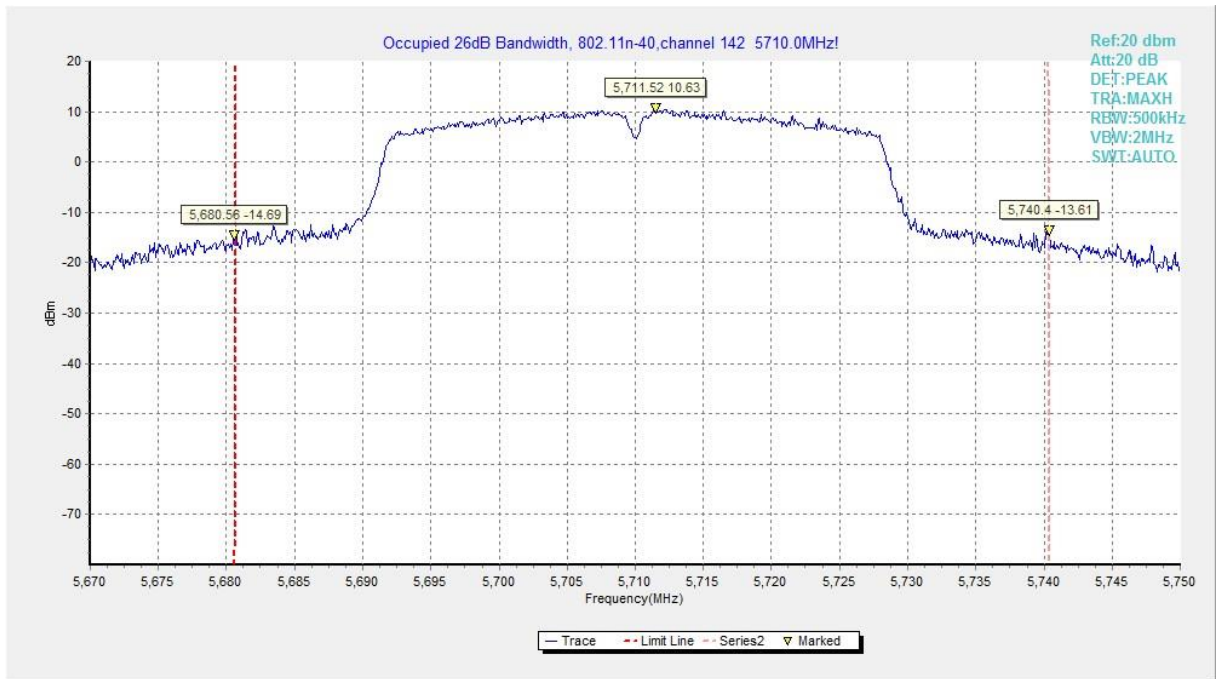
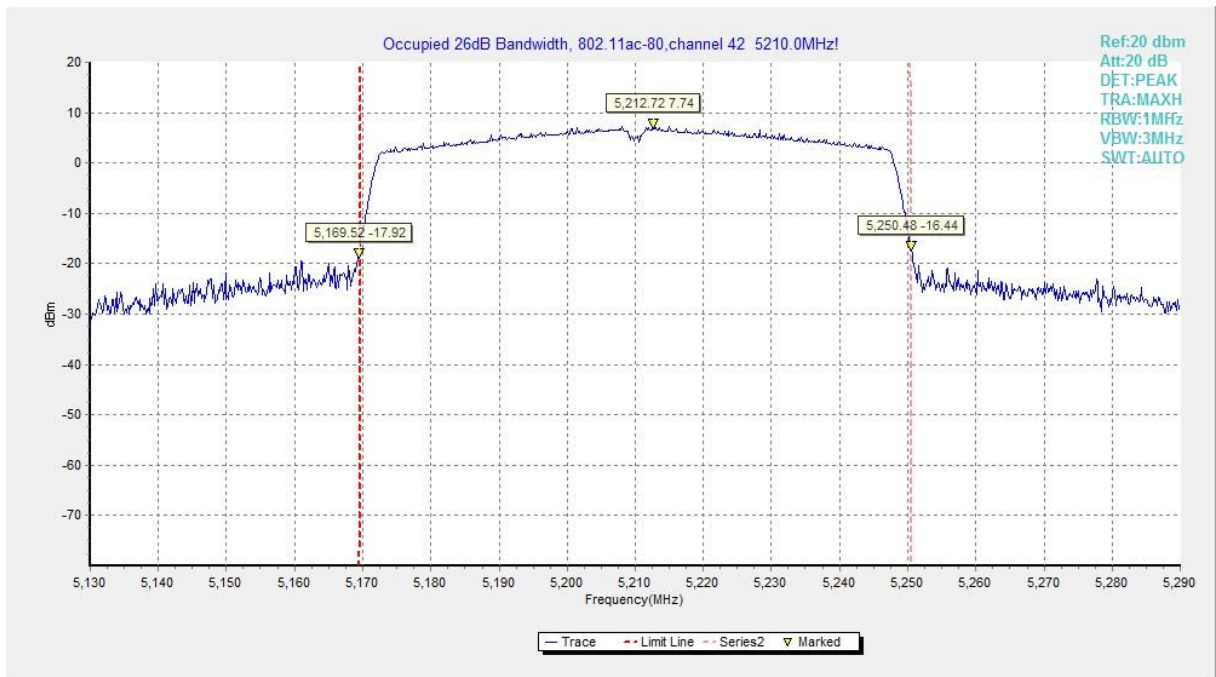


Fig.27 Occupied 26dB Bandwidth (802. 11n-HT40, 5670MHz)



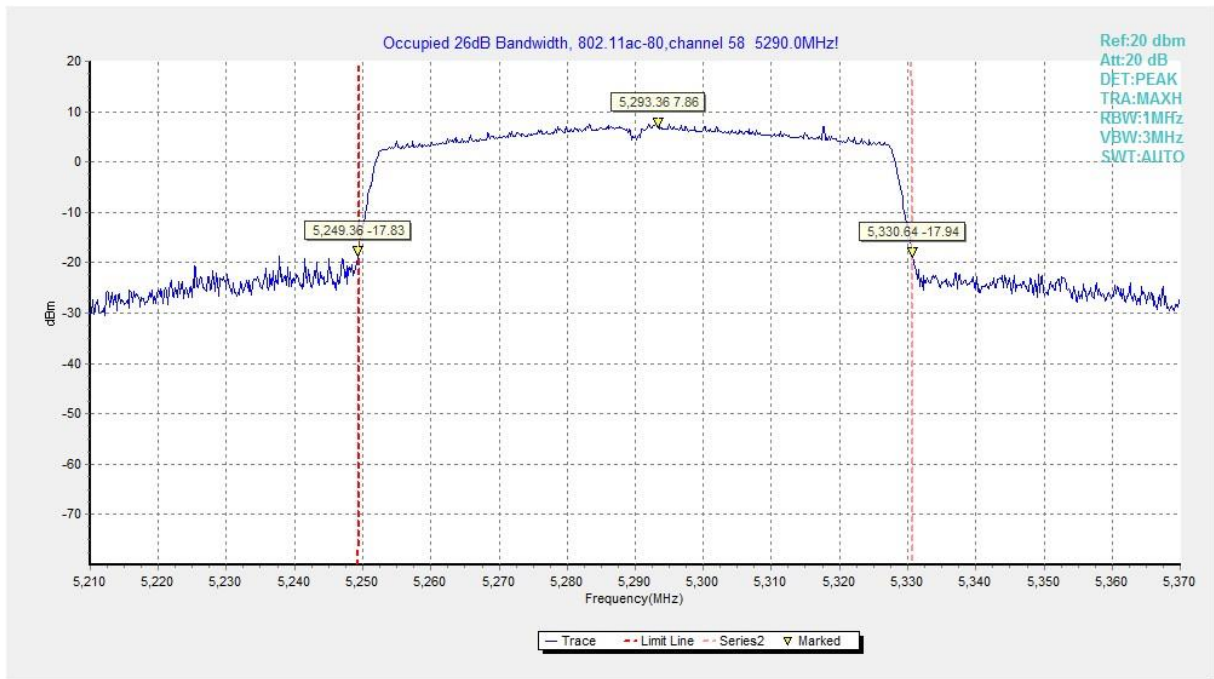


**Fig.28 Occupied 26dB Bandwidth (802. 11n-HT40, 5710MHz)**

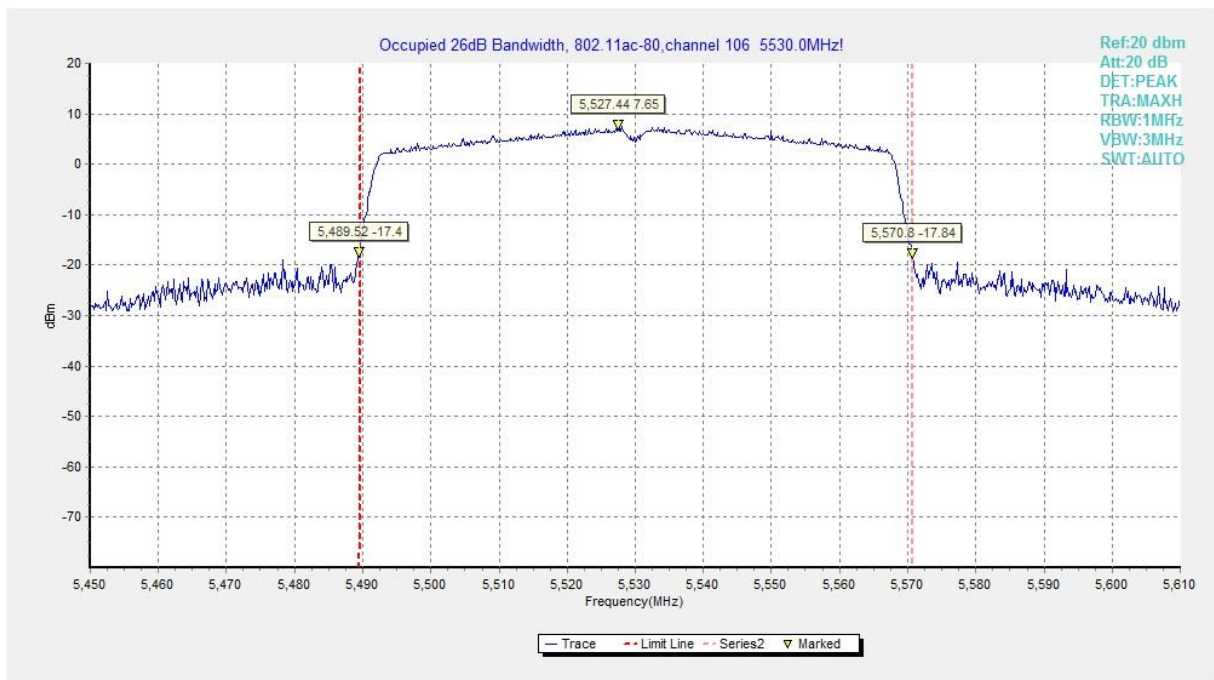


**Fig.29 Occupied 26dB Bandwidth (802. 11ac-HT80, 5210MHz)**

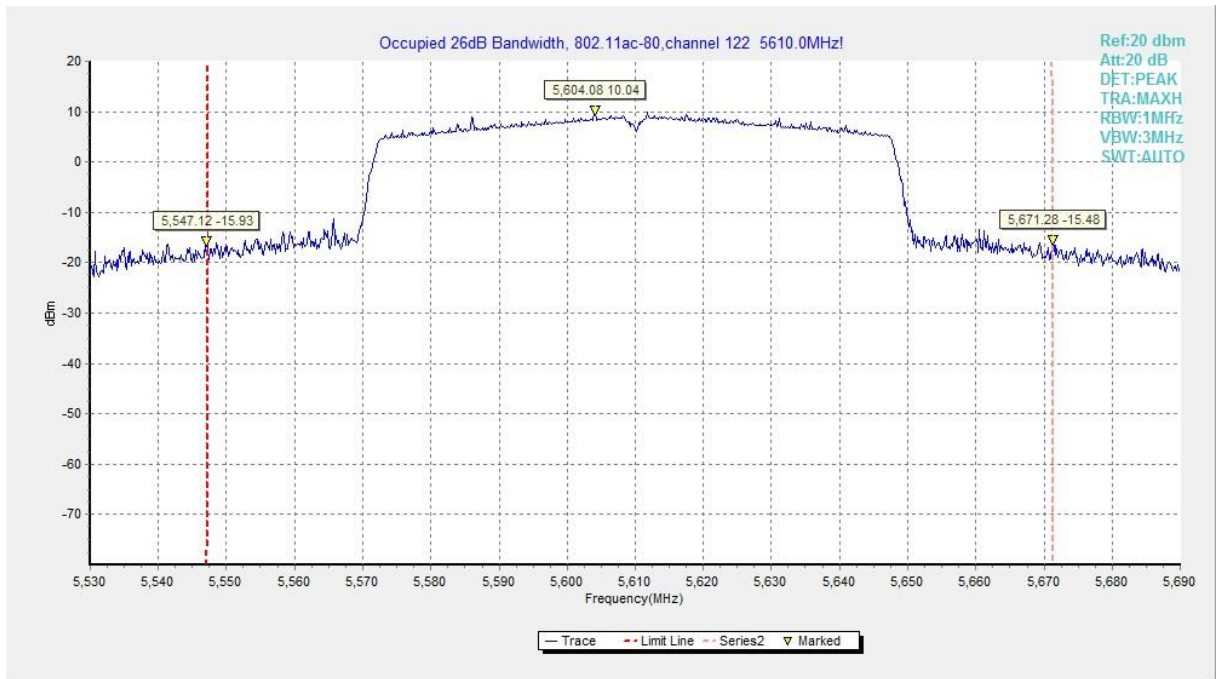




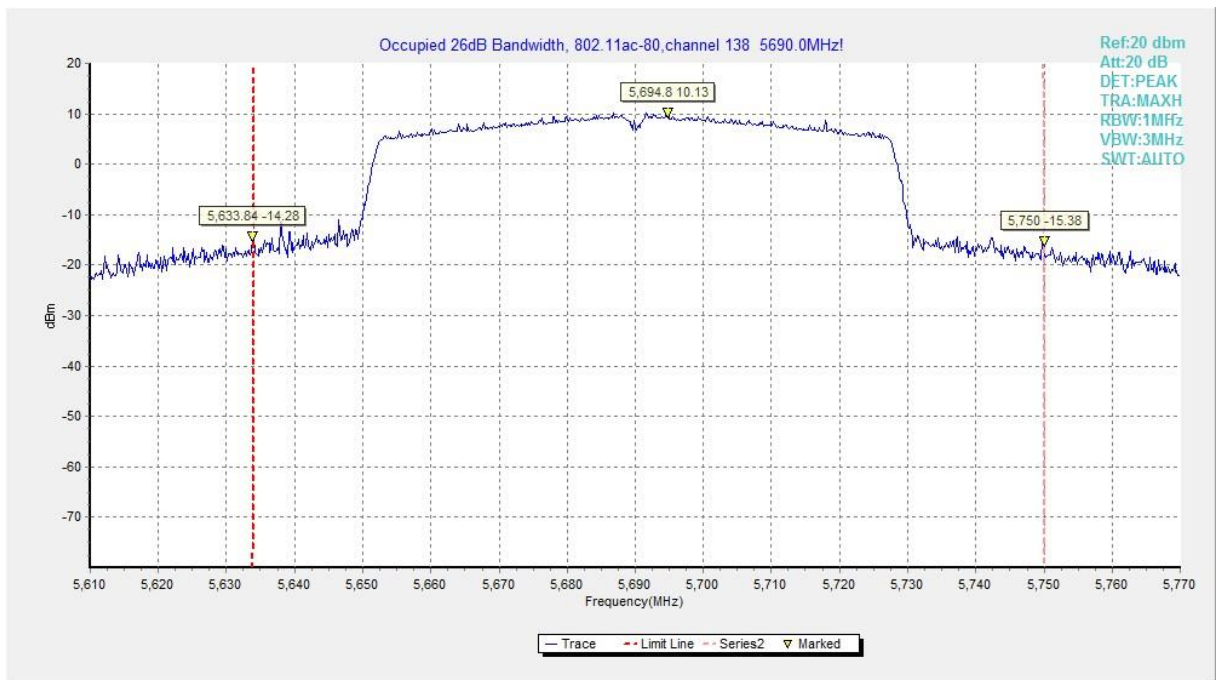
**Fig.30 Occupied 26dB Bandwidth (802. 11ac-HT80, 5290MHz)**

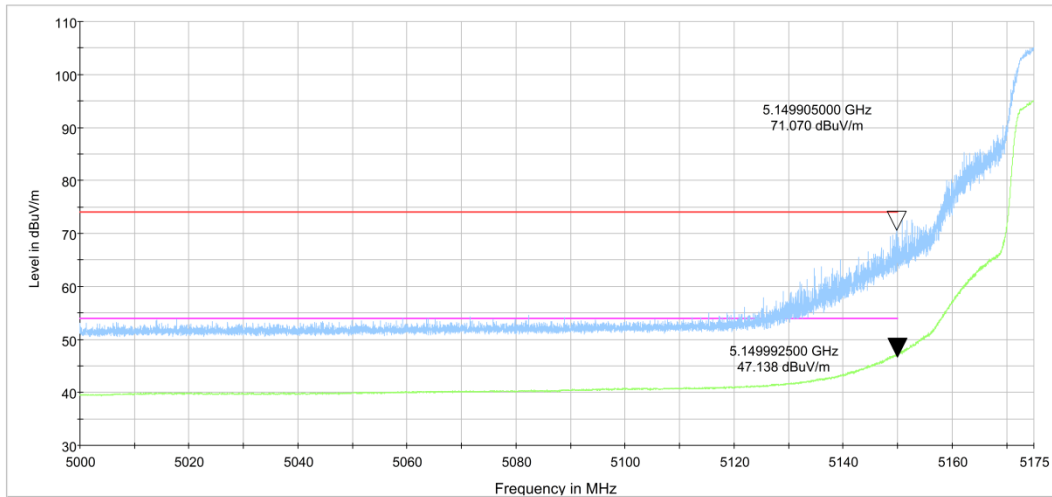

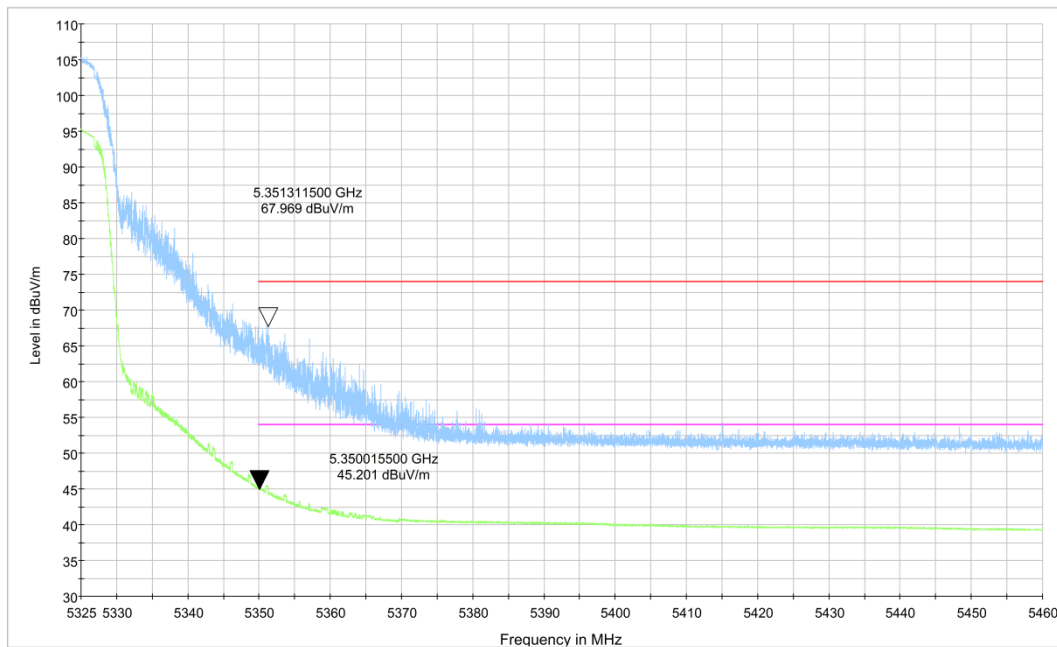

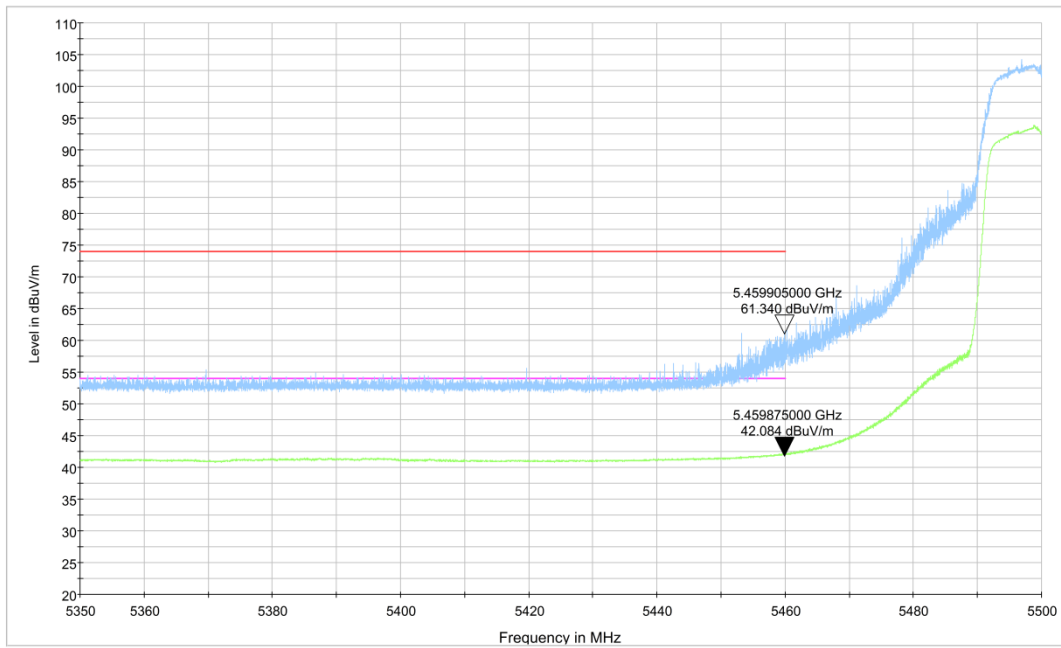

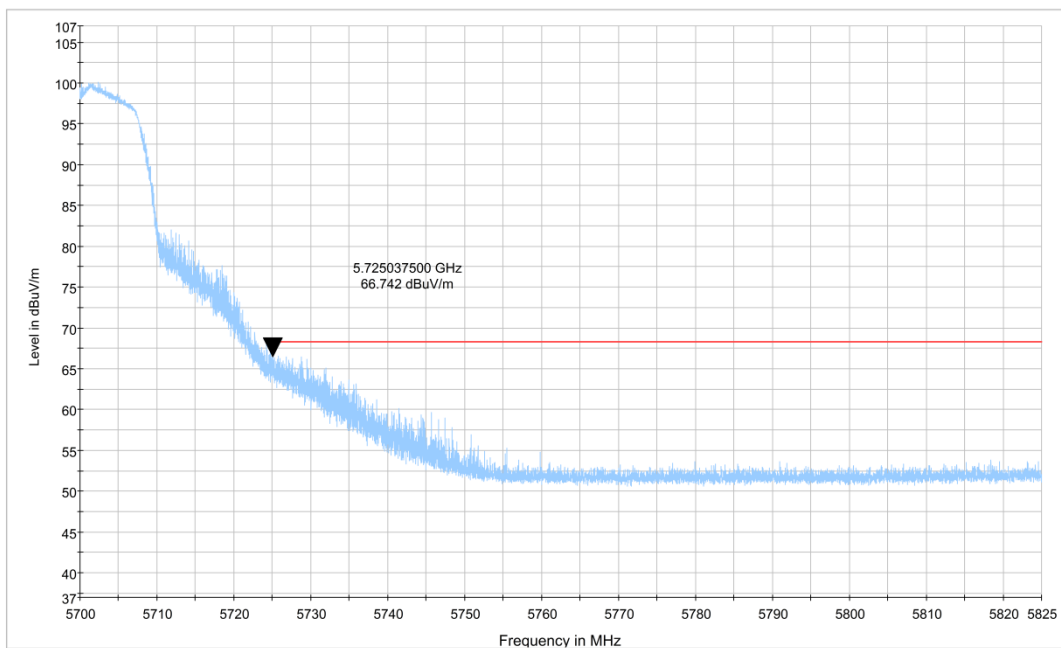
**Fig.34 Band Edges (802.11a Ch36, 5180MHz)**



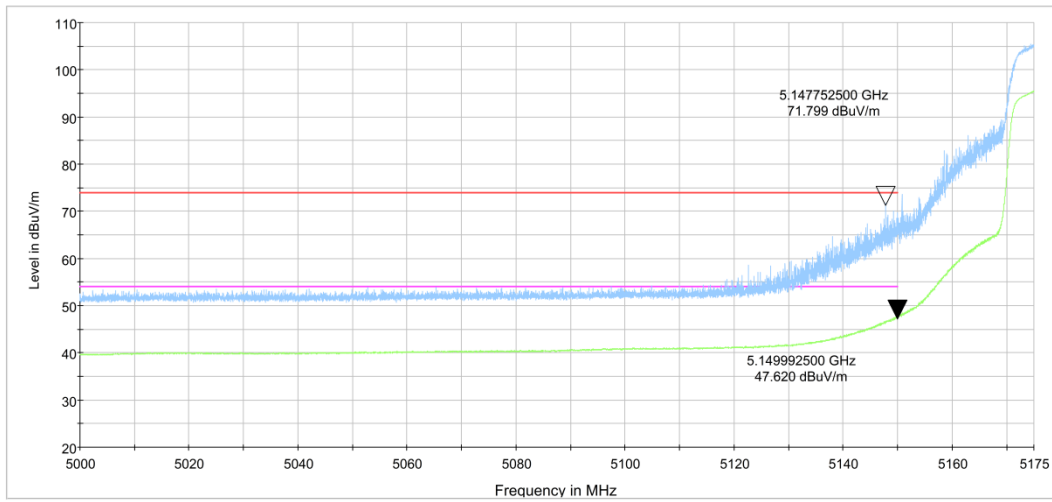
**Fig.35 Band Edges (802.11a Ch64, 5320MHz)**



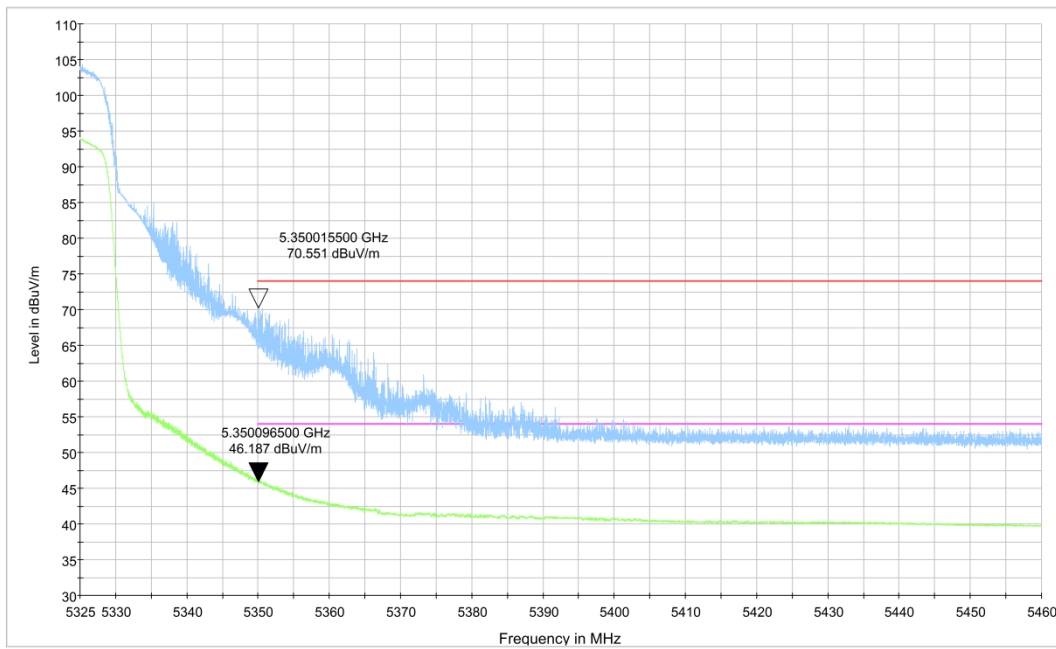
**Fig.36 Band Edges (802.11a Ch100, 5500MHz)**



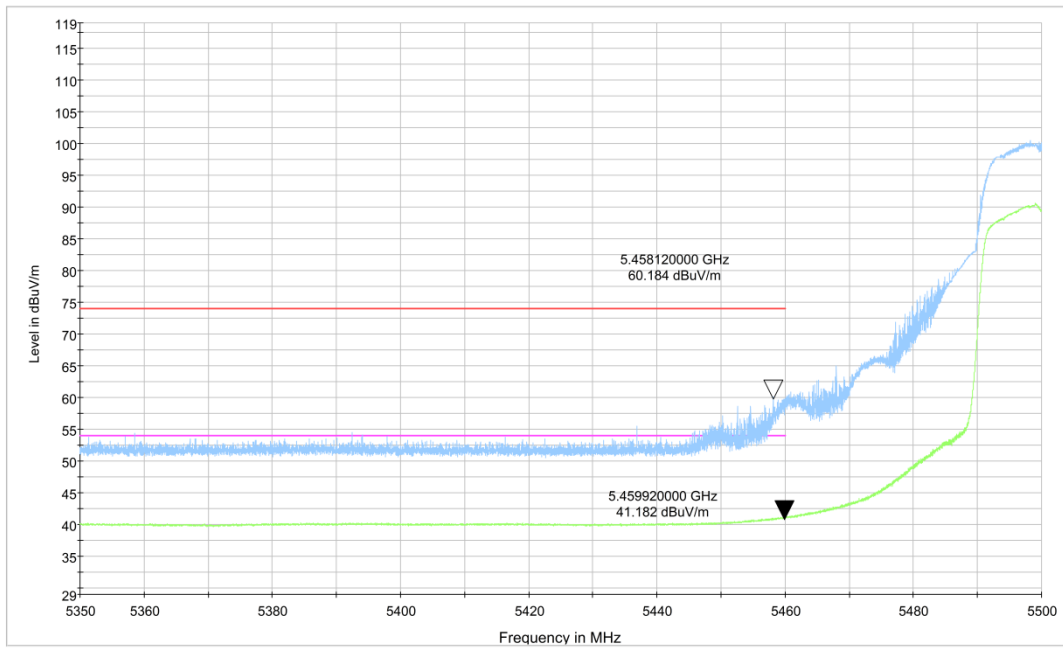
**Fig.37 Band Edges (802.11a Ch140, 5700MHz)**



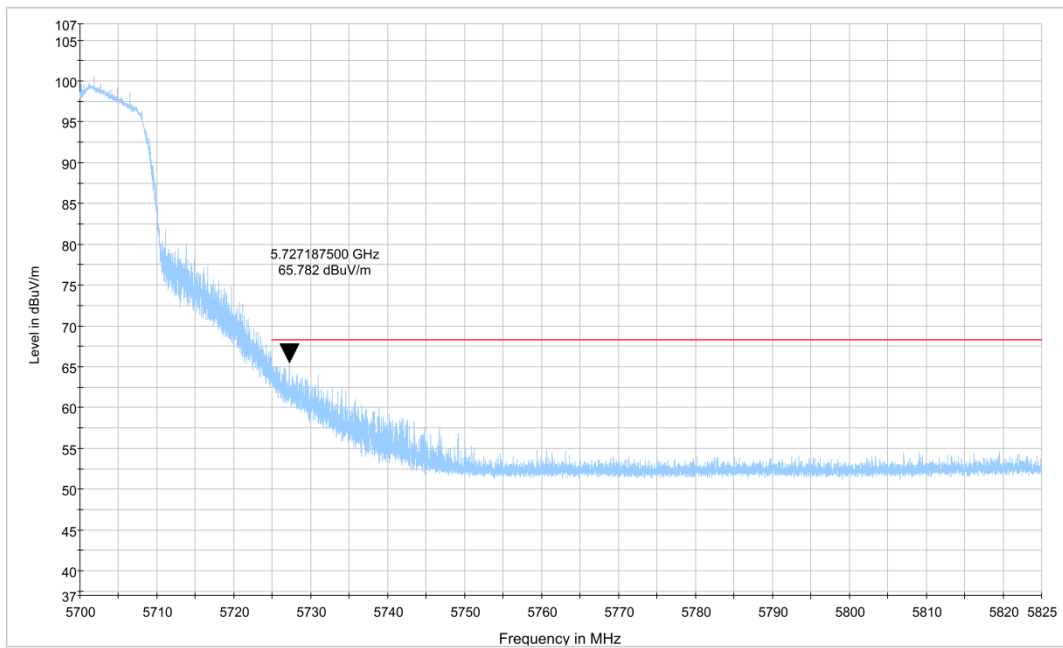
**Fig.38 Band Edges (802.11n-HT20 Ch36, 5180MHz)**



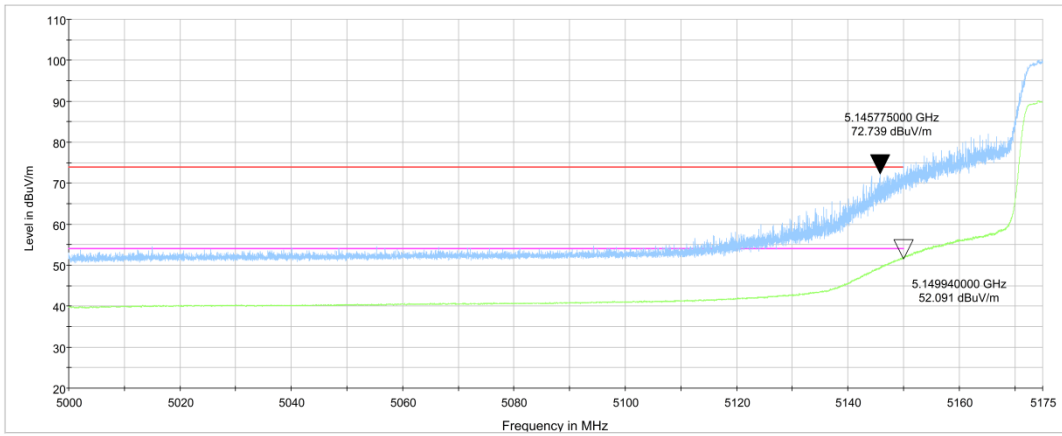
**Fig.39 Band Edges (802.11n-HT20 Ch64, 5320MHz)**



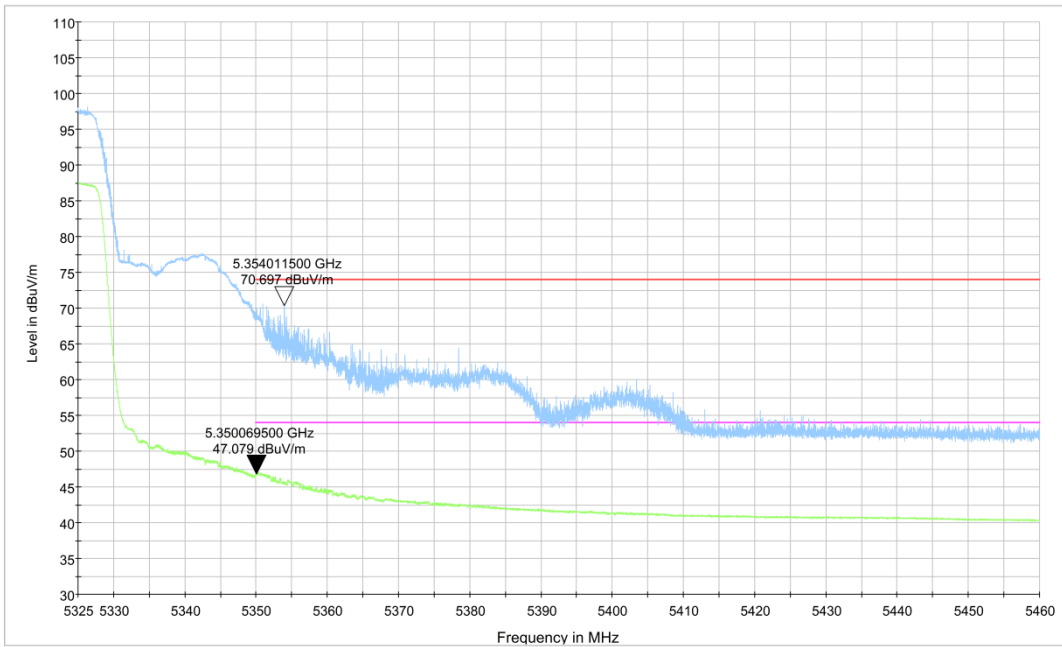
**Fig.40 Band Edges (802.11n-HT20 Ch100, 5500MHz)**
