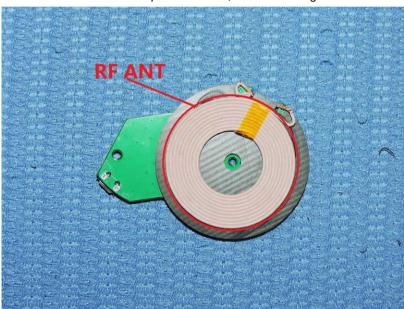

The antenna is Inductive loop coil Antenna, the best case gain of the antenna is 0dBi.





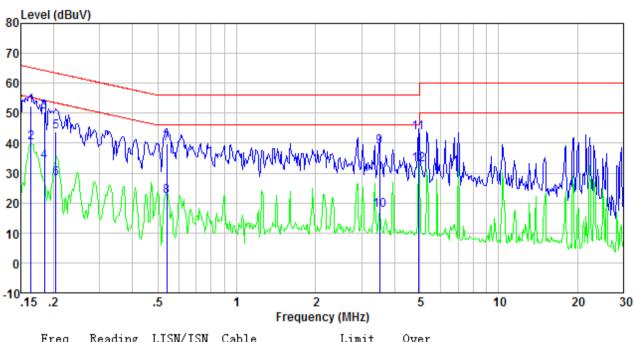
