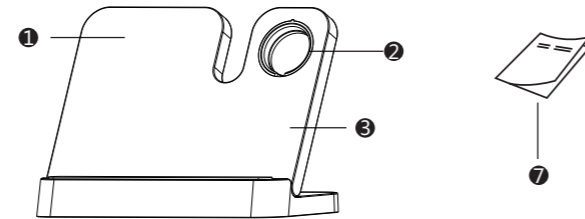

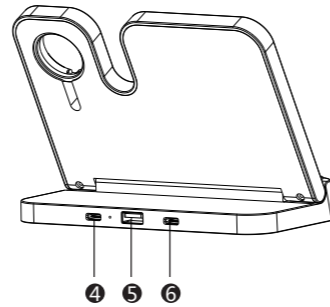

Operation:

- Charging the phones
1. Connect the cable to the Type-C port.
 2. Put your Qi compatible device on top of the wireless charger, ensuring that it is face up and centrally positioned.
 3. When the wireless charge is working correctly a blue light will turn on.

- Charging the wireless headphones
1. Connect the cable to a Type-C port.
 2. Put your wireless headphones on top of the wireless charger, ensuring that it is face up and centrally positioned.
 3. When the wireless charge is working correctly a white light will turn on.

Warnings:

1. Do not expose this product to rain or damp conditions.
2. Prevent this item from falling as it could cause serious damage.
3. Do not dismantle, repair or modify this product by yourself, contact an authorized specialist.
