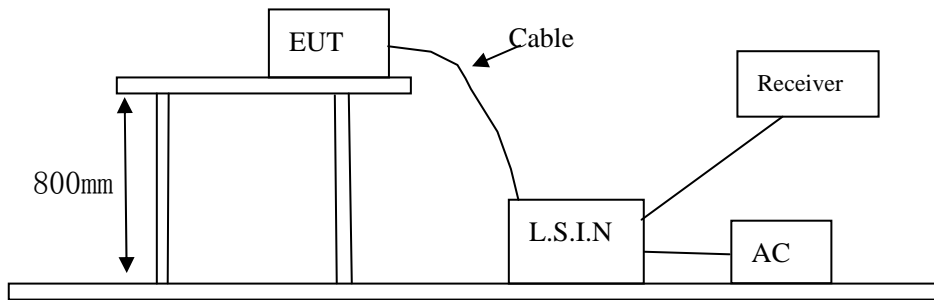

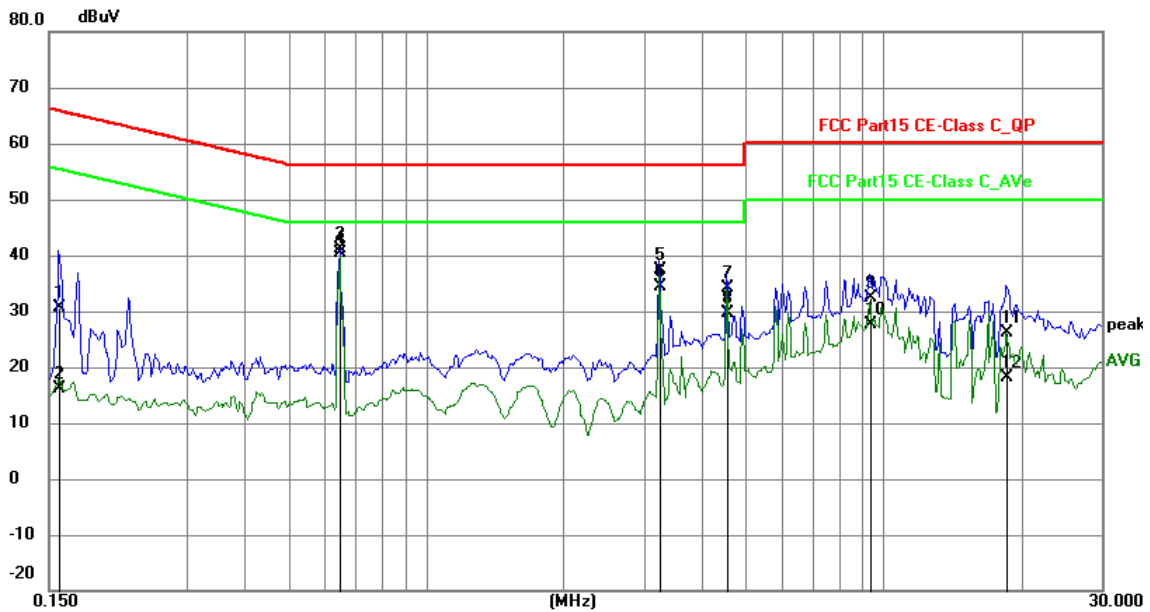

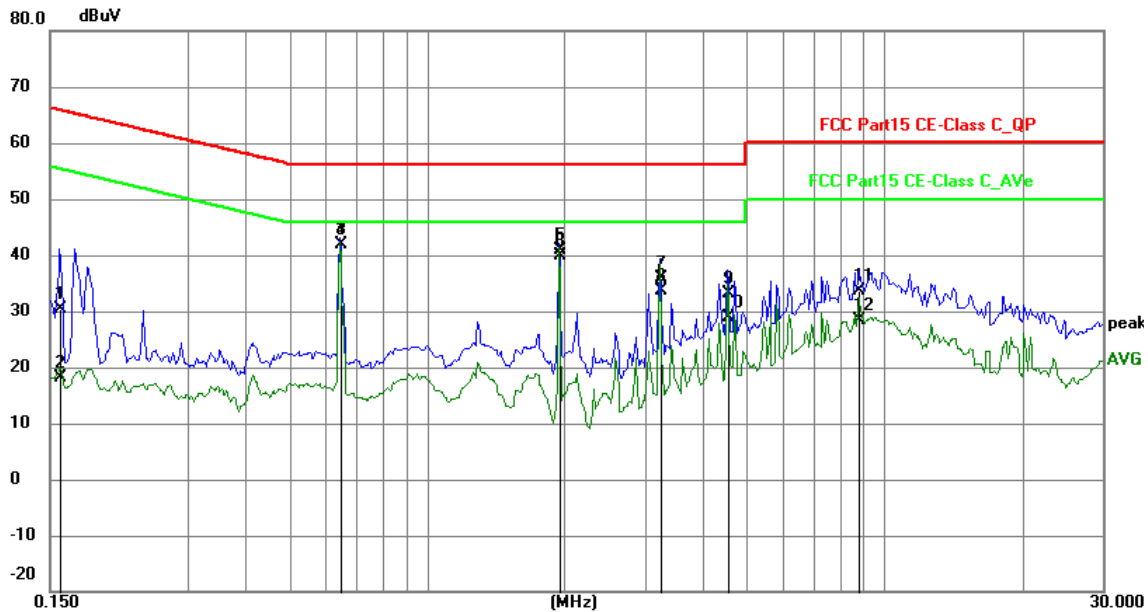

Radiated emission test view

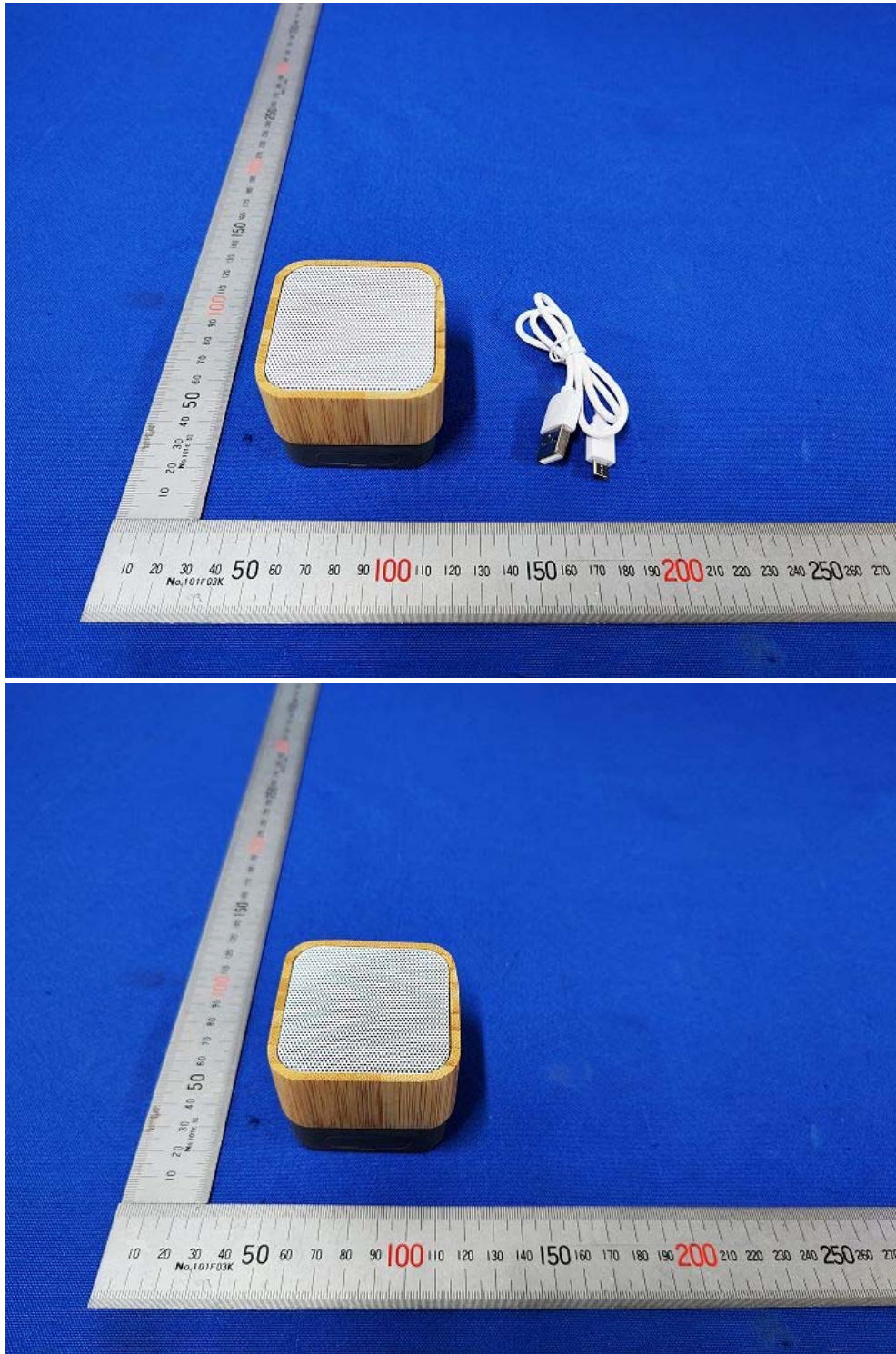
