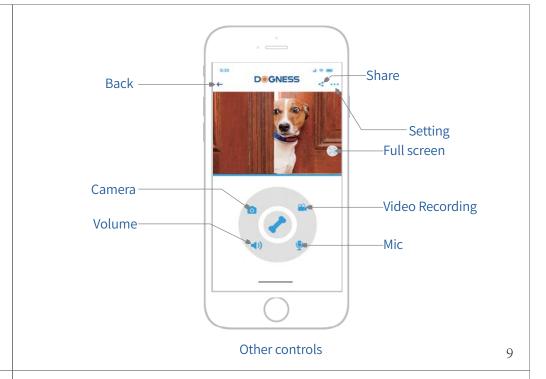

FAQs:

- C. Probably the network connection is delayed or interrupted. Please check your network connection and press the treat button again.

2. The video is not played smoothly? What should I do? Answer: Please check your network connection and play the video again.

3. Unable to login the existing account, what should I do? Answer: First, check if your network is connected appropriately.

Second, check if there is other user using your account.

If necessary, unload the App and re-download the App, and try again. If you are using Android system, please try the following steps:

Mobile-> Setting-> Apps & notifications-> Dogness App-> Storage -> Clear data, then login again.
