3 RF EXPOSURE

Per KDB 447498 D01, for 100 MHz to 6 GHz and test separation distances ≤ 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] \cdot [$\sqrt{f(GHz)}$] ≤ 3.0 for 1-g SAR, and ≤ 7.5 for 10-g extremity SAR,

f(GHz) is the RF channel transmit frequency in GHz;

Power and distance are rounded to the nearest mW and mm before calculation;

The result is rounded to one decimal place for comparison;

When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion
