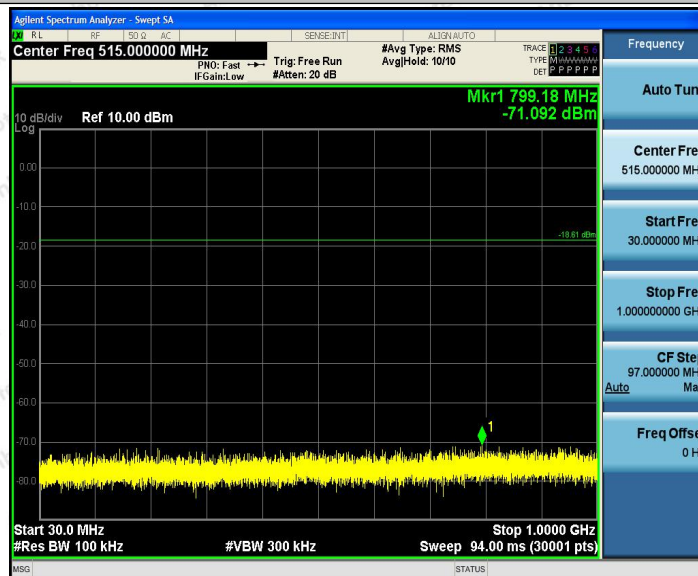




BLE\_1M\_Ant1\_2440\_0~Reference



BLE\_1M\_Ant1\_2440\_30~1000

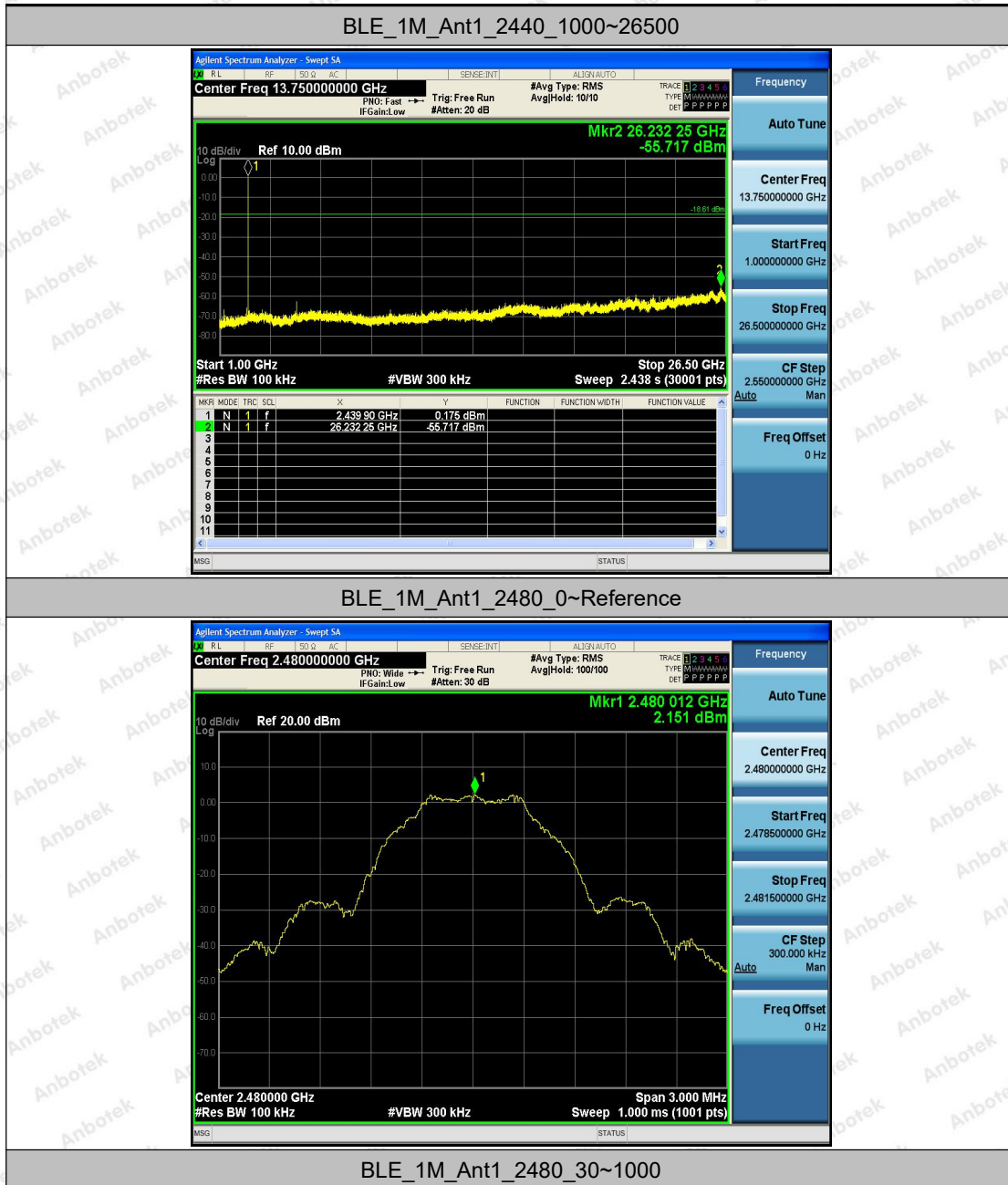
