**2.2 Assessment Results**

The highest EIRP adjusted with tune-up tolerance is  $-3.98\text{dBm} = 0.40\text{mW} < \underline{10\text{mW}}$  (Test Exclusion Thresholds of 2450MHz at 5mm). Therefore, the SAR requirement is deemed to be satisfied without test.
