


4.2.3 Measurement procedure

- 1) The RF exposure test was performed in anechoic chamber.
- 2) The aggregate H-field strengths at 15 cm surrounding the device and 20 cm above the top surface.
- 3) The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E, F) were completed.
- 4) The EUT was measured according to the dictates of KDB 680106 D01 v03.

Remark: The EUT's test position A, B, C, D, E and F is valid for the E and H field measurements.
