

- Charging the Powerbank:
- Charge the powerbank fully before usage.
 Connect the provided charging cable to a
- power source and to the micro USB port on the powerbank(6). Or your own Type C • cable to the Type Input Port (4). Once connected the LED Indicator will
- begin to flash WHITE when charging, once fully charged LED will turn WHITE.
- 2. Charging mobile phones and other electronic devices:
- Connect the charging cable to your mobile phone/device using the appropriate connector. Connect the USB part of the cable into either USB Output(3 or 5). LED Indicator will illuminate when charging.
- Remove the USB cable from your mobile device when it is fully charged.

3. Wireless Charging Function:

- Press the Powerbank ON/OFF button(7) to turn on the wireless charging function, LED indicator near power button will flash green for three seconds and turn off.
- Place wireless charging supported mobile device on the charging surface/suction pad, LED will remain green when device is charging.
- · Phone will begin to charge automatically.
- ** Note: When wireless charging, if the LED indicator will flashes the device is either NOT a wireless charging device or there is an object between the device and charging surface interfering with the charging.
