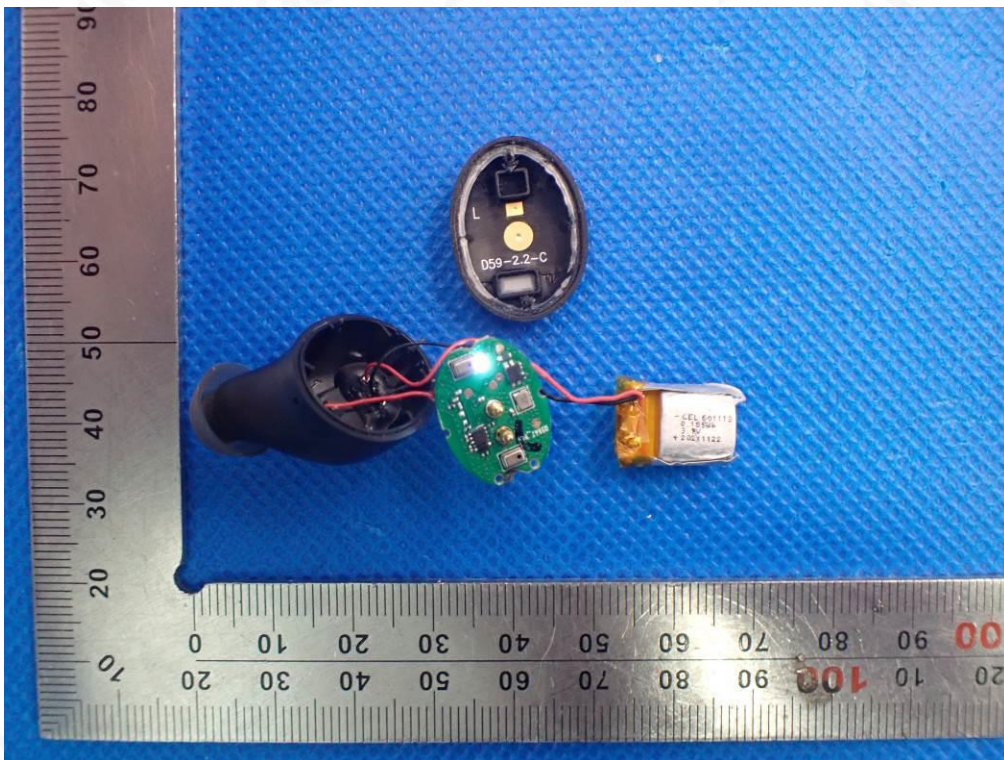

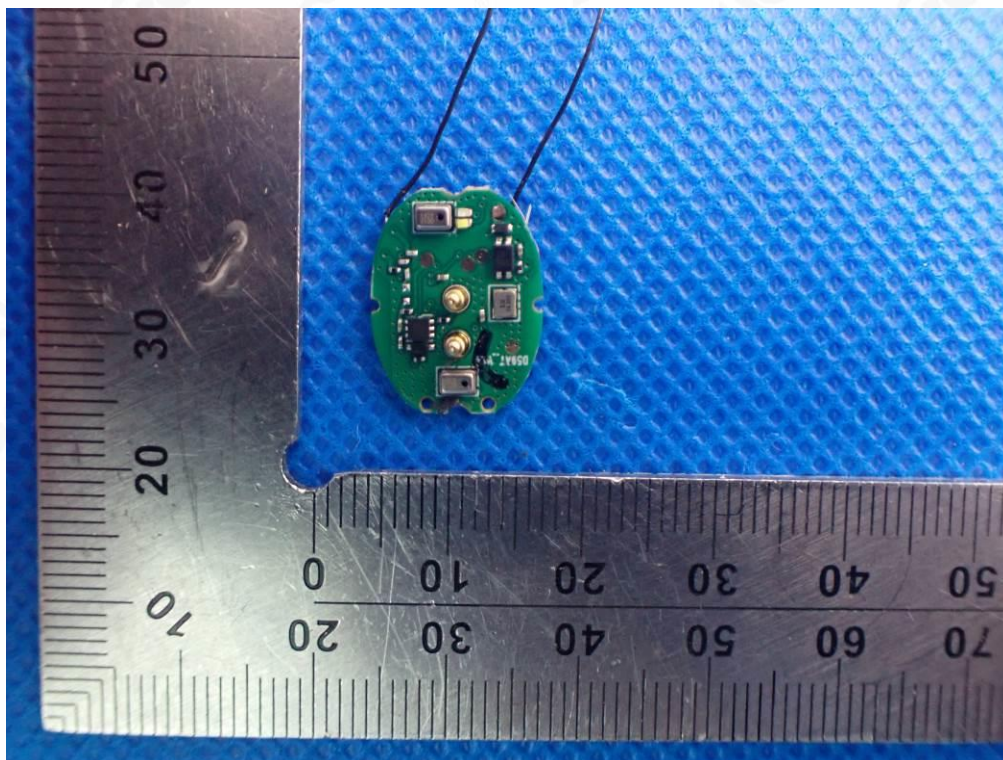

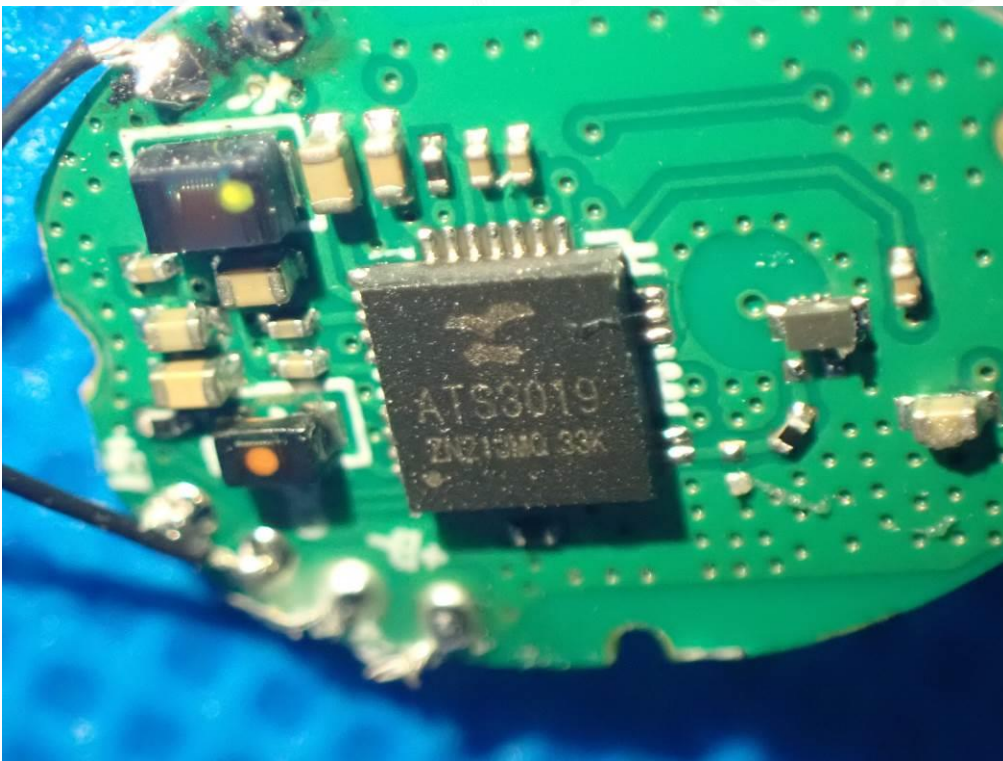

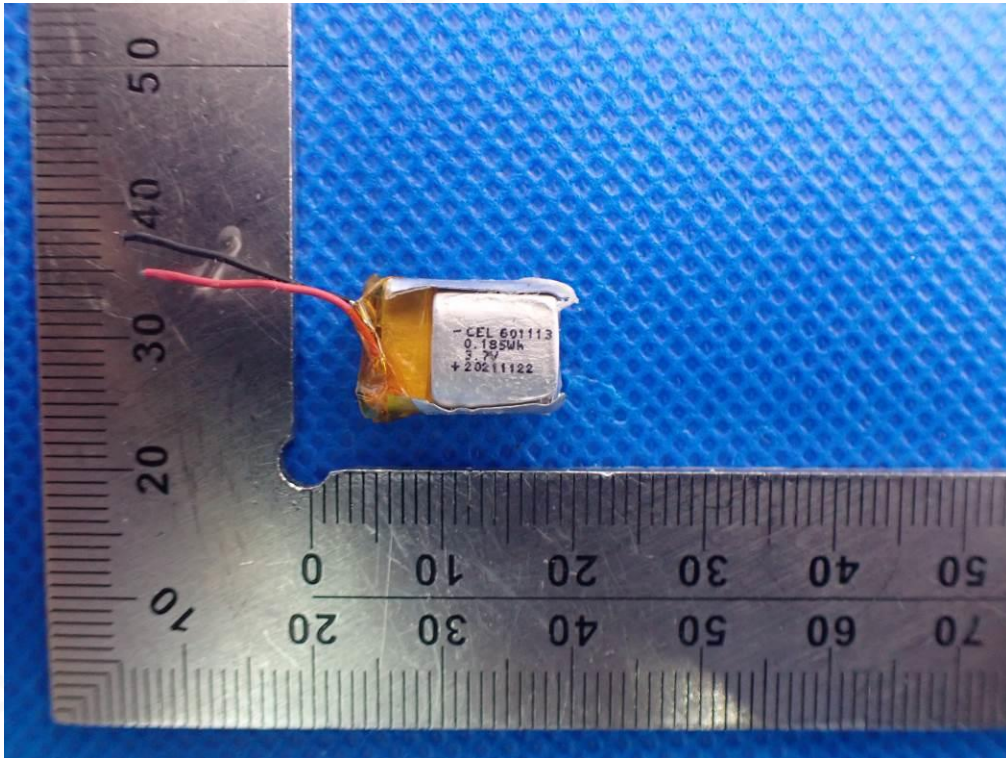

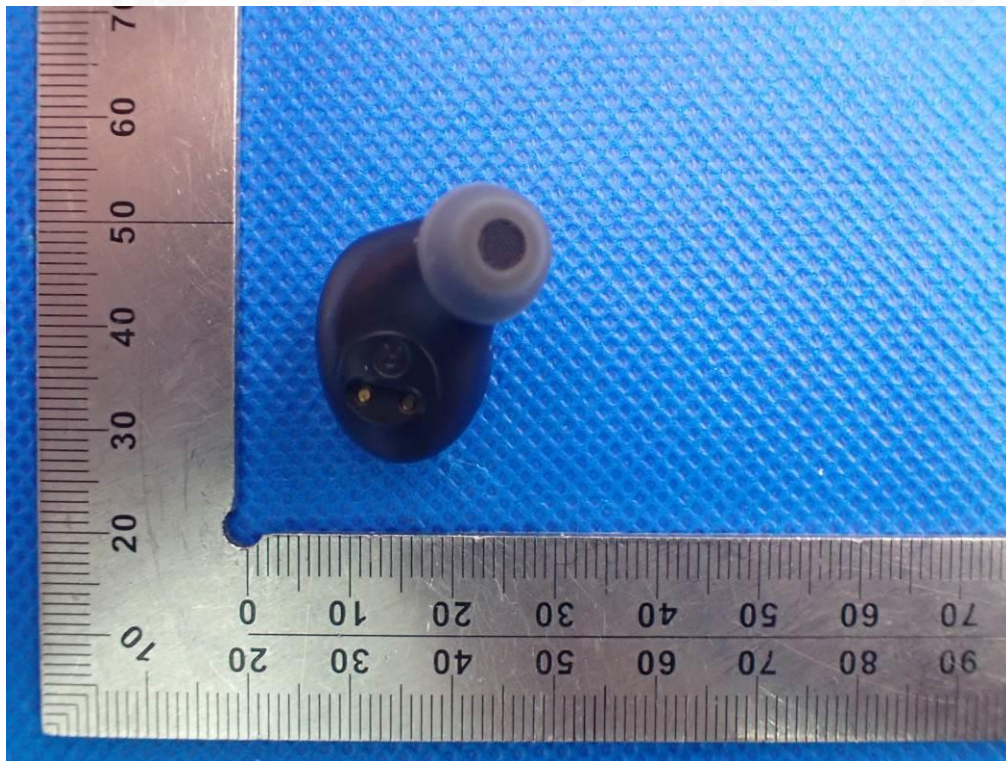

PORT VIEW OF EUT (FIGURE 1)-Right

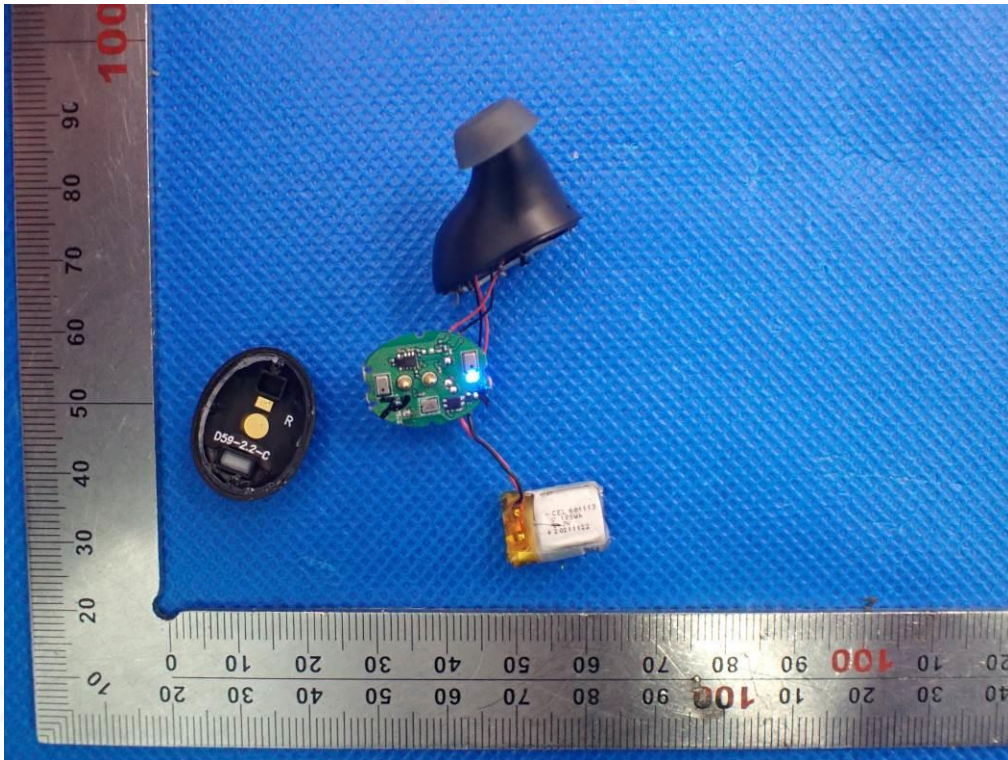

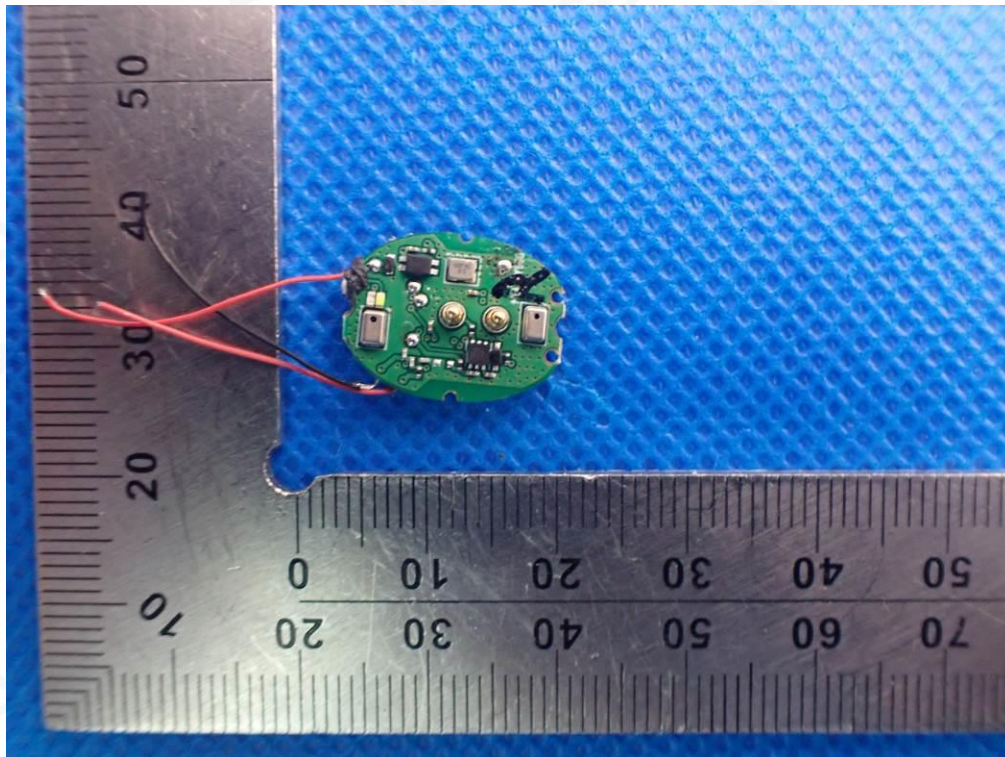

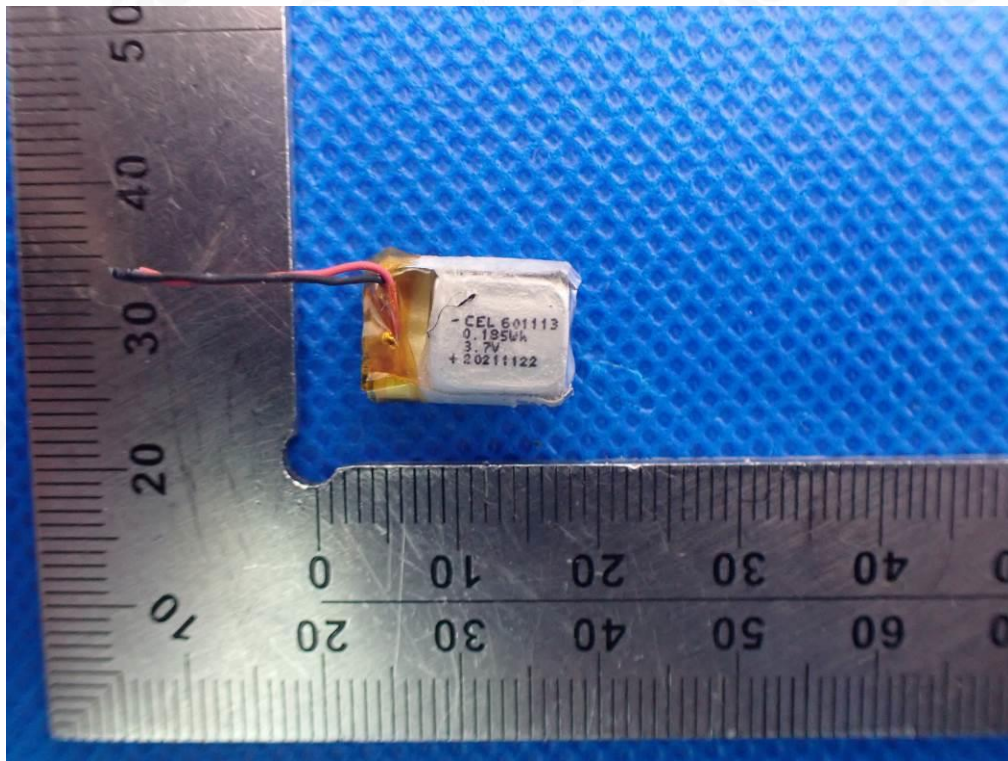
