



Usage of Android Smartphone and Android TV Set-top Box

- Press (A) button for 3 second
- 2 Press SELECT + START button for 5 seconds when 4 LEDs are lit.



B When All 4 LEDs flash guickly, search for Bluetooth device on your Android phone or Android TV.

- 4 Connect with 'Gamepad S2 XXXX'. (XXXX is an arbitrary alphanumeric number)
- 5 You can use Gamepad S2 when 1st LED liahts up



Press and hold button to turn on/off.

BATTERY CHARGE

- If the LED flashes continuously while in use, Gamepad S2 needs to get recharged.
- Charge the battery by connecting the supplied charging cable to a computer or USB power charging device (5W).
