--> Can you confirm by letter or statement that only the BT Classic part of this chipset is used in Padi.

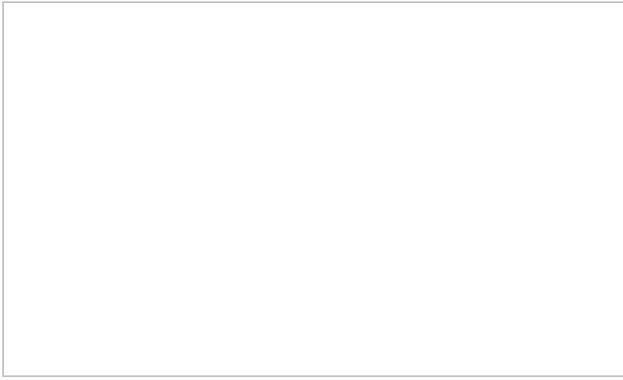

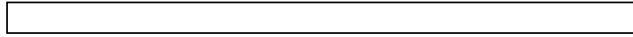
