## 1.7. Description of Test Modes

The EUT has been tested under operating condition.

The EUT operates in the unlicensed ISM band at 2.4GHz. The following operating modes were applied for the related test items.

All test modes were tested, only the result of the worst case was recorded in the report. The EUT is considered a portable unit and was set to transmit at 100% duty cycle. It was pre-tested on the positioned of each 3 axis. The worst case was found positioned on X-plane.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was the mode and channel with the highest output power, that was determined to be TX-2405MHz.

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be TX-2405MHz.

Pre-test AC conducted emission at both voltage AC 120V/60Hz and AC 240V/60Hz, recorded worst case.

Pre-test AC conducted emission at power adapter mode, recorded worst case.

## 2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

### 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### 2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.249 under the FCC Rules Part 15 Subpart C.

### 2.3. General Test Procedures

#### 2.3.1 Conducted Emissions

According to the requirements in Section 6.2 of ANSI C63.10: 2013, AC power-line conducted emissions shall be measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table and the turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10: 2013

The system was configured for testing in a continuous transmit condition. Continuous transmitting. EUT will transmit continuously when powered on, Change the frequency by adjusting the lever.

## 6. ANTENNA REQUIREMENT

### 6.1. Standard Applicable

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

### 6.2. Antenna Connected Construction

This sample use one external antenna and one internal antenna, maximum antenna gain are 2.00 dBi, external antenna use R-SMA antenna connector meets FCC part §15.203 antenna requirement.

The device not support MIMO technology, this means two antenna cannot transmit at same time.

## 7. RADIATED EMISSION MEASUREMENT

### 7.1. Standard Applicable

According to §15.249 (d) and RSS-210 B.10 (b): Emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in §15.209, whichever is the lesser attenuation.

As shown in §15.35(b), for frequencies above 1000 MHz, the field strength limits in paragraphs (a) and (b) of this section are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation. For point-to-point operation under paragraph (b) of this section, the peak field strength shall not exceed 2500 millivolts/meter at 3 meters along the antenna azimuth.

### 7.3. Test Procedure

#### 1) Sequence of testing 9 kHz to 30 MHz

##### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- If the EUT is a floor standing device, it is placed on the ground.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

##### Premeasurement:

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna height is 0.8 meter.
- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

##### Final measurement:

- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0° to 360°) and by rotating the elevation axes (0° to 360°).
- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.
- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.



## 2) Sequence of testing 30 MHz to 1 GHz

### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a table with 0.8 m height is used, which is placed on the ground plane.
- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

### Premeasurement:

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height changes from 1 to 3 meter.
- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

### Final measurement:

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45^\circ$ ) and antenna movement between 1 and 4 meter.
- The final measurement will be done with QP detector with an EMI receiver.
- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

### 3) Sequence of testing 1 GHz to 18 GHz

#### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

#### Premeasurement:

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height is 1.5 meter.
- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

#### Final measurement:

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum found antenna polarization and turntable position of the premeasurement the software maximizes the peaks by rotating the turntable position (0° to 360°). This measurement is repeated for different EUT-table positions (0° to 150° in 30°-steps). This procedure is repeated for both antenna polarizations.
- The final measurement will be done in the position (turntable, EUT-table and antenna polarization) causing the highest emissions with Peak and RMS detector.
- The final levels, frequency, measuring time, bandwidth, turntable position, EUT-table position, antenna polarization, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

#### 4) Sequence of testing above 18 GHz

##### **Setup:**

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.

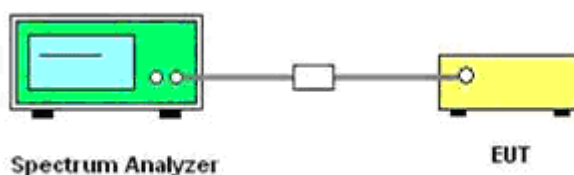
## 8. BAND-EDGE MEASUREMENTS FOR RADIATED EMISSIONS

### 8.1. Standard Applicable

According to FCC §15.249 (d): Emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in §15.209, whichever is the lesser attenuation.

According to RSS-210 B.10 (b): Emissions radiated outside of the specified frequency bands, except for harmonic emissions, shall be attenuated by at least 50 dB below the level of the fundamental emissions or to the general field strength limits listed in RSS-Gen, whichever is less stringent.

### 8.4. Test Procedures

According to ANSI C63.10:2013 Field Strength Approach (linear terms):

$$\text{eirp} = p_t \times g_t = (E \times d)^2/30$$

Where:

$p_t$  = transmitter output power in watts, □

$g_t$  = numeric gain of the transmitting antenna (unitless), □

$E$  = electric field strength in V/m, □

$d$  = measurement distance in meters (m).

$$\text{erp} = \text{eirp}/1.64 = (E \times d)^2/(30 \times 1.64)$$

Where all terms are as previously defined.

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to an EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
3. Set both RBW and VBW of spectrum analyzer for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/B for Peak detector.
4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
5. Repeat above procedures until all measured frequencies were complete.
6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).

7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)
8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies  $\leq$  30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies  $>$  1000 MHz).
9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
10. Compare the resultant electric field strength level to the applicable regulatory limit.
11. Perform radiated spurious emission test duress until all measured frequencies were complete.

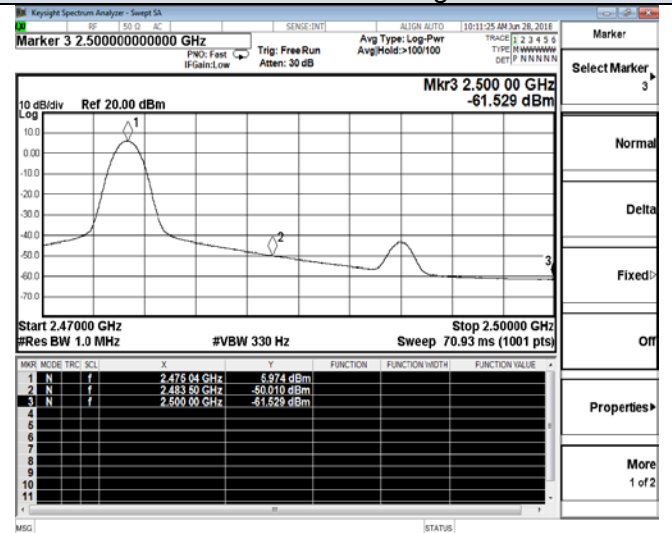
2405 MHz – Peak

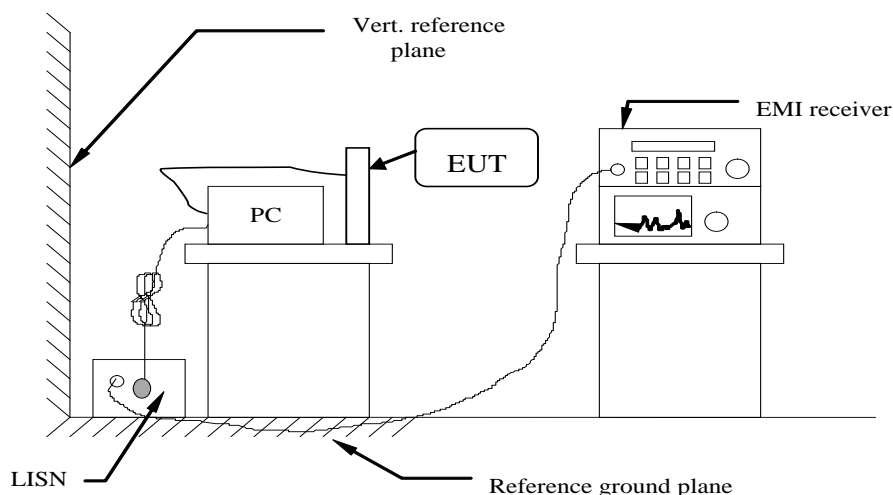
### 10.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 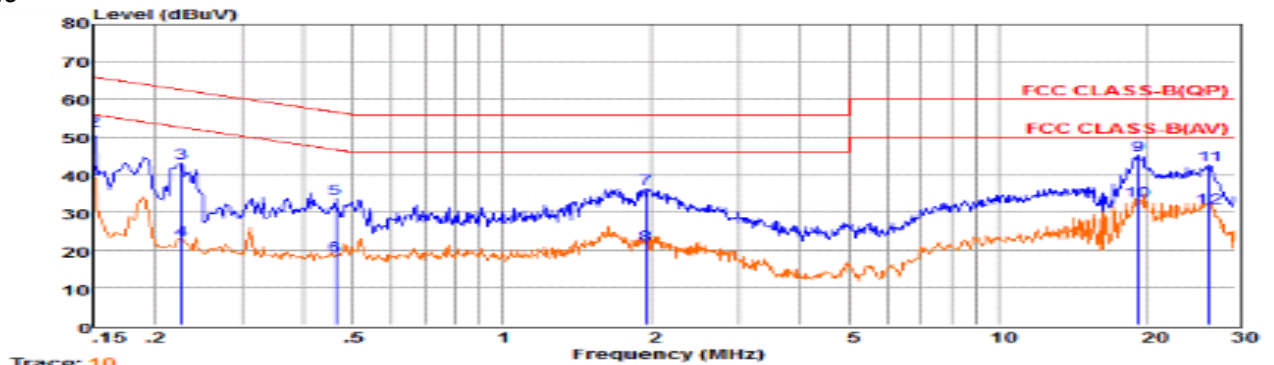

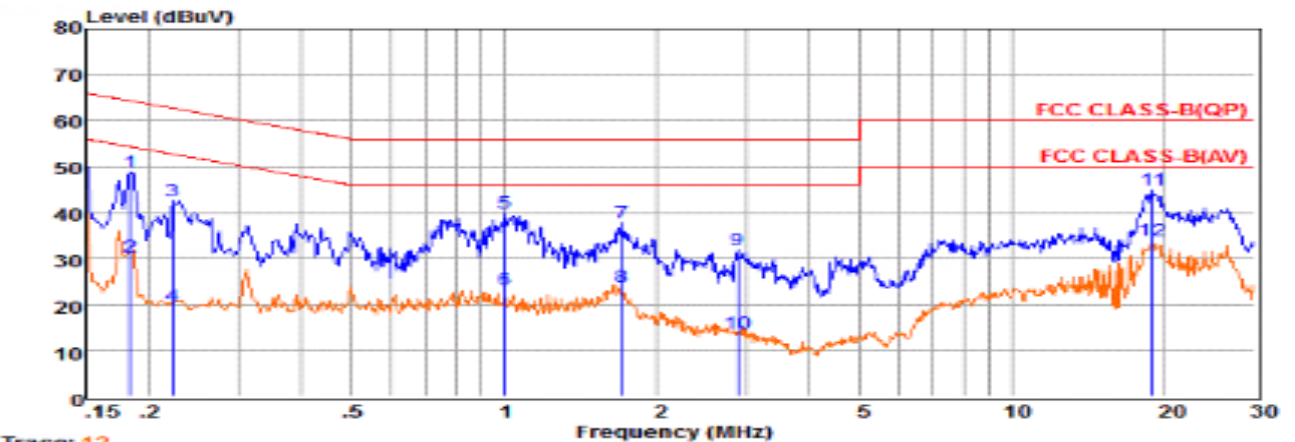
