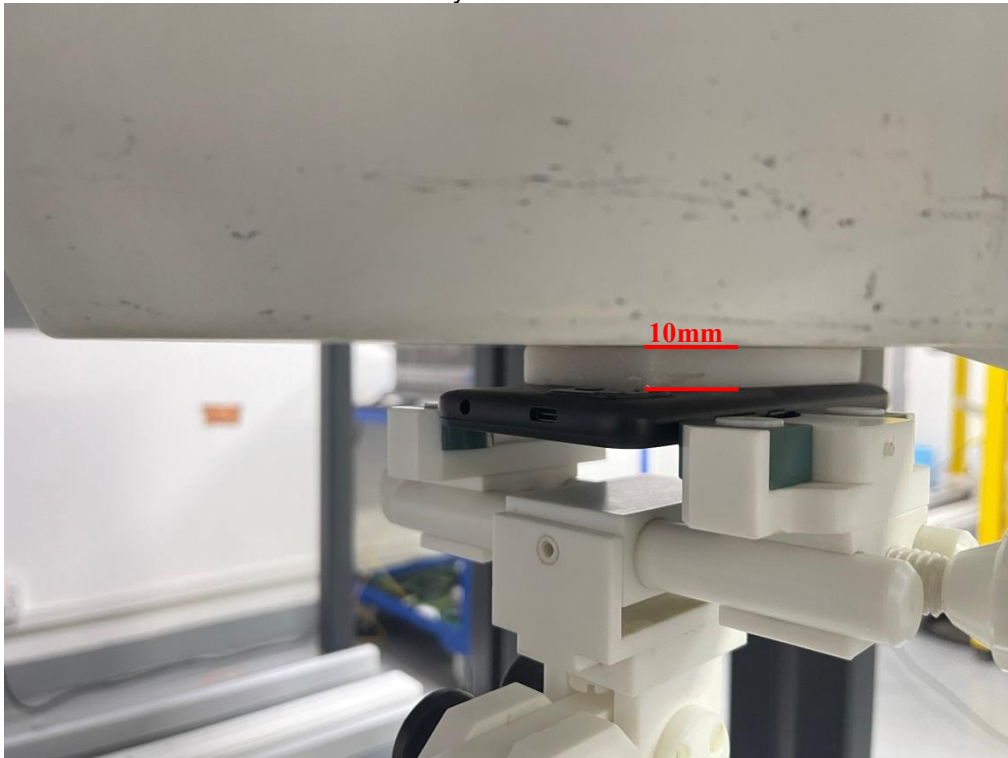
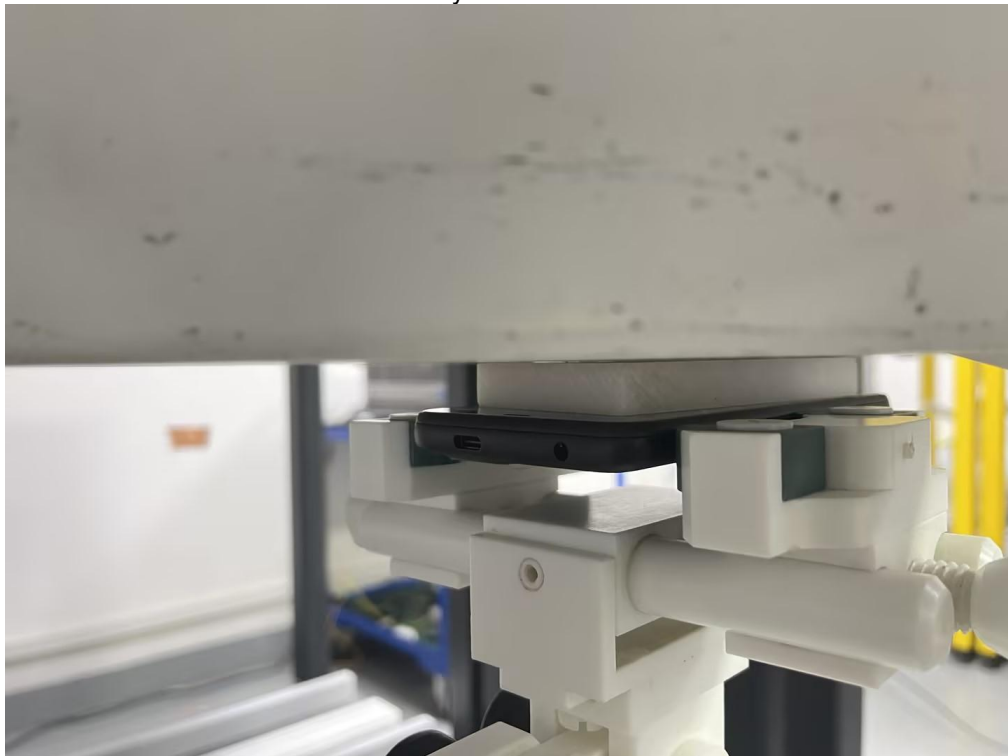


Body Back 10mm



Body Front 10mm

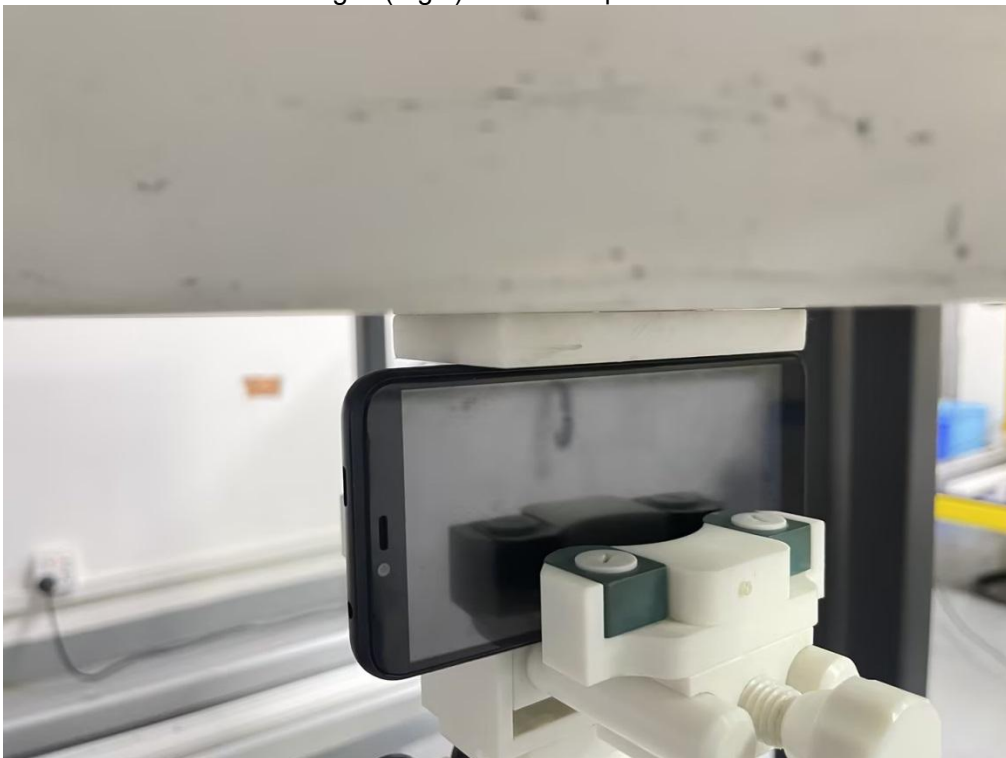

Edge 2(Right) 10mm-Hotspot Mode



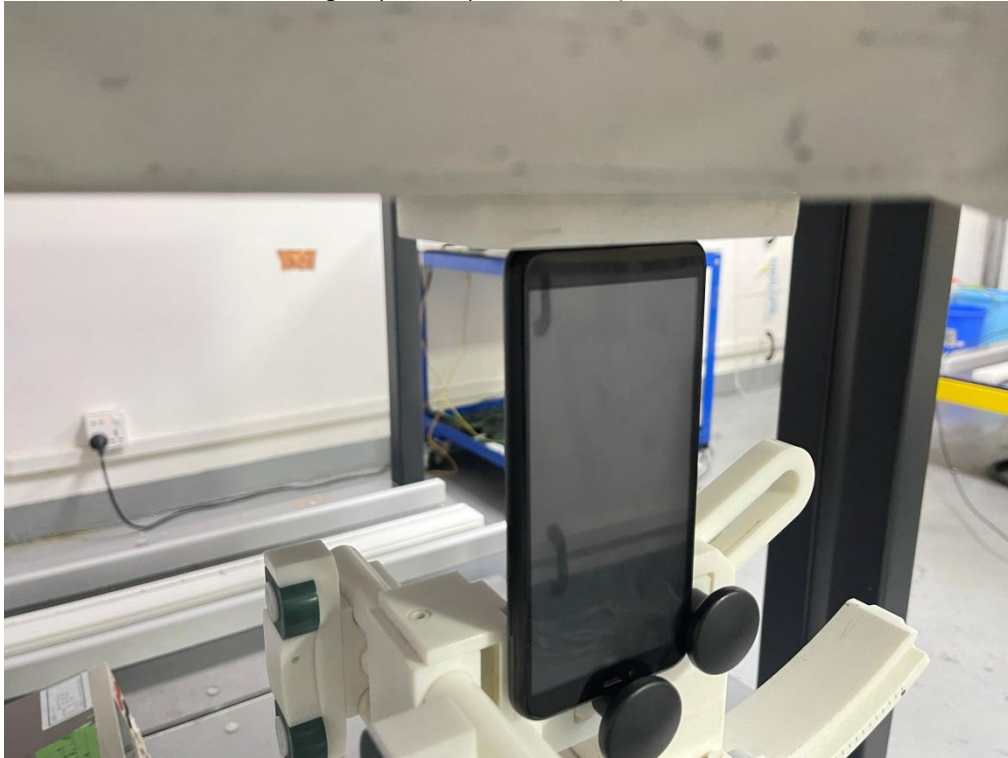

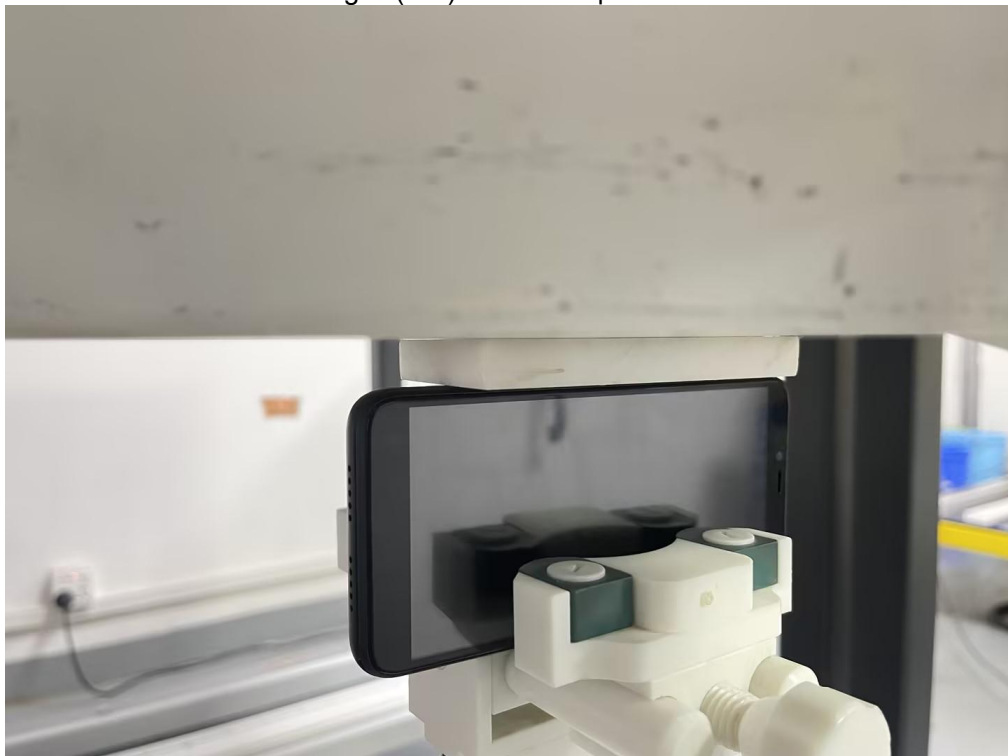

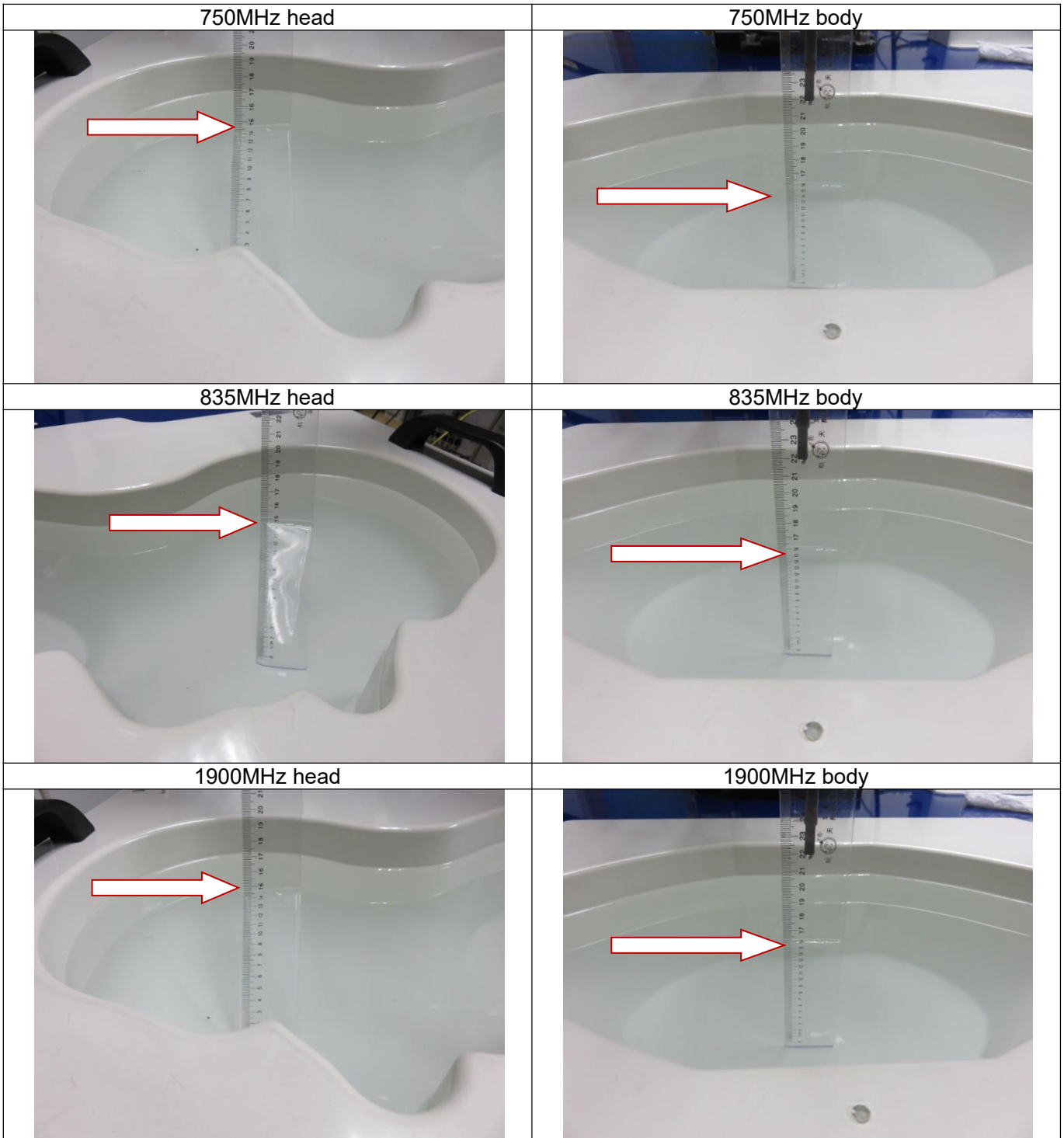
