
Download the FLX app on your smartphone 1









Go through the guided setup and create a PIN. 2 DO NOT FORGET YOUR PIN. It is necessary to be able to restore from your FLX Key.



Insert the FLX Key into the USB port on the FLX ONE when prompted. The FLX Key is used to recover your wallet in the event of loss or damage.




Make sure Bluetooth is enabled on your smartphone, and the Bluetooth switch on the top of the FLX ONE is to the left. The FLX ONE should be on and unlocked. The Bluetooth LED should be lit.



Start the FLX mobile app and unlock the FLX ONE with the PIN you created. The app should see your FLX ONE in the list of devices. Select your device




