



Setup diagram for Conducted Test










Setup diagram for Raidation(9KHz~30MHz) Test



Setup diagram for Raidation(Below 1G) Test








Setup diagram for Raidation(Above1G) Test

Measurement Results Explanation Example

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

4.1 20dB and 99% Bandwidth Measurement

4.1.1 Limit of 20dB and 99% Bandwidth

4.1.2 Test Procedures

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument.
- 3. Use the following spectrum analyzer settings for 20dB Bandwidth measurement.

Span = approximately 2 to 5 times the 20 dB bandwidth, centered on a hopping channel;

RBW ≥ 1% of the 20 dB bandwidth; VBW ≥ RBW; Sweep = auto; Detector function = peak;

Trace = max hold.

4. Use the following spectrum analyzer settings for 99 % Bandwidth measurement.

Span = approximately 1.5 to 5 times the 99% bandwidth, centered on a hopping channel;

RBW ≥ 1% of the 99% bandwidth; VBW ≥ RBW; Sweep = auto; Detector function = sample;

Trace = max hold.

4.2 Peak Output Power Measurement

4.2.1 Limit of Peak Output Power

Section 15.247 (b)

The maximum peak conducted output power of the intentional radiator shall not exceed the following:

(1) For frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725-5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400-2483.5 MHz band 0.125 watts.

RSS-247 5.4(b)

For FHSs operating in the band 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1.0 W if the hopset uses 75 or more hopping channels; the maximum peak conducted output power shall not exceed 0.125 W if the hopset uses less than 75 hopping channels. The e.i.r.p. shall not exceed 4 W

4.2.2 Test Procedures

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument.
- 3. The transmitter output is connected to a spectrum analyzer the analyzer bandwidth is set to a value greater than the 20 dB bandwidth of the EUT.

4.3 Carrier Frequency Separation Measurement

4.3.1 Limit of Hopping Channel Separation

FCC §15.247 (a) (1)

RSS-247 5.1(b)

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hoping channel, whichever is greater.

Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

4.3.2 Test Procedures

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument.
- 3. The transmitter output is connected to a spectrum analyzer. The RBW is set to 300 kHz and the VBW is set to 300 kHz. The sweep time is coupled.

4.4 Time of Occupancy Measurement

4.4.1 Limit of Average Time of Occupancy

FCC §15.247 (a) (1) (iii)

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

RSS-247 5.1(d)

FHSs operating in the band 2400-2483.5 MHz shall use at least 15 hopping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds, multiplied by the number of hopping channels employed. Transmissions on particular hopping frequencies may be avoided or suppressed provided that at least 15 hopping channels are used.

4.4.2 Test Procedures

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument.
- 3. The transmitter output is connected to a spectrum analyzer. The span is set to 0 Hz, centered on a single, selected hopping channel. The width of a single pulse is measured in a fast scan The number of pulses is measured in a 3.16 second scan, to enable resolution of each occurrence.
- 4. The average time of occupancy is calculated from the transmit time per hop multiplied by the number of hops in the period specified in the requirements.

The test period: T= 0.4 Second/Channel x 79 Channel = 31.6 s

4.5 Number of Hopping Channels Measurement

4.5.1 Limits of Number of Hopping Channels

FCC § 15.247(a)(1)(iii)

Frequency hopping systems in the 2400-2483.5 MHz band shall use at least 15 channels.

RSS-247 5.1(d)

FHSs operating in the band 2400-2483.5 MHz shall use at least 15 hopping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds, multiplied by the number of hopping channels employed. Transmissions on particular hopping frequencies may be avoided or suppressed provided that at least 15 hopping channels are

used.

4.5.2 Test Procedure

1. Check the calibration of the measuring instrument using either an internal calibrator or a known

signal from an external generator.

2. Turn on the EUT and connect it to measurement instrument.

3. The transmitter output is connected to a spectrum analyzer. The span is set to cover the entire

authorized band, in either a single sweep or in multiple contiguous sweeps. The RBW is set to

100KHz. The analyzer is set to Max Hold.

4.6 Conducted Band Edges Measurement

4.6.1 Limit of Band Edges

FCC §15.247(d)

IC RSS-247 5.5

In any 100 kHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.

4.6.2 Test Procedures

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument.
- 3.Set RBW = 100kHz, VBW = 300kHz. Band edge emissions must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100kHz RBW. The attenuation shall be 30 dB instead of 20 dB when RMS conducted output power procedure is used.
- 4. Enable hopping function of the EUT and then repeat step 1~3.

In any 100 kHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.

4.7.2 Test Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument.
- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4.Set RBW = 100 kHz, VBW = 300kHz, scan up through 10th harmonic. All harmonics / spurs must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100 kHz RBW.
- 5. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

4.9.2 Test Procedures

- 1. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
- 2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
- 6. Both sides of AC line were checked for maximum conducted interference.
- 7. The frequency range from 150 kHz to 30 MHz was searched.
- 8. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.





4.10 Antenna Requirements

4.10.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded..

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

4.10.2 Antenna Connected Construction

An Monopole Antenna type design is used.

4.10.3 Antenna Gain

The antenna peak gain of EUT is less than 6 dBi. Therefore, it is not necessary to reduce maximum peak output power limit.
