#### **Evaluation Method**

Transmission formula:  $P_d = (Pout*G)/(4*pi*R^2)$ 

Where

Pd = power density in mW/cm2, Pout = output power to antenna in mW, G = gain of antenna in linear scale;Pi = 3.1416, R = distance between observation point and center of the radiator in cm
