SYSTEM TEST CONFIGURATION

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

2.3 Test Procedure

2.3.1Conducted Emissions

The EUT is a placed on a table which is 0.8 m above ground plane. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz. The CISPR Quasi-Peak and Average detector mode is employed. The two LISNs provide 50uH/50 ohm of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

2.3.2Conducted Test (RF)

The active antenna port of the unlicensed wireless device is connected to the spectrum analyzer with attenuator to protect the instrumentation. If a second antenna port is available, it is tested at one operating frequency, with other port(s) appropriately terminated, to verify it has similar output characteristics as the fully tested port.

2.3.3Radiated Emissions

The EUT is a placed on a turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plane. For emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

2.4 Measurement Results Explanation Example

2.4.1 Radiated Emission Test Sites For Measurements From 9 kHz To 30 MHz

Radiated emission below 30MHz is measured in a 9m*9m*6m semi-anechoic chamber, the measurements correspond to those obtained at an open-field test site. There is a comparison data of both open-field test site and semi-Anechoic chamber, and

the result came out very similar.






Fig 2-3 Conduction (AC Power Line) Radi-






(A) Radiated Emission Test Set-UP Frequency Below 30MHz.

10.4 Measurement Procedure

10.4.1 Radiated Emission

- 1. The testing follows the Measurement Procedure of ANSI C63.10:2013.
- 2. The EUT was placed on a turn table with 0.8m for frequency< 1GHz and 1.5m for frequency> 1GHz above ground plan.
