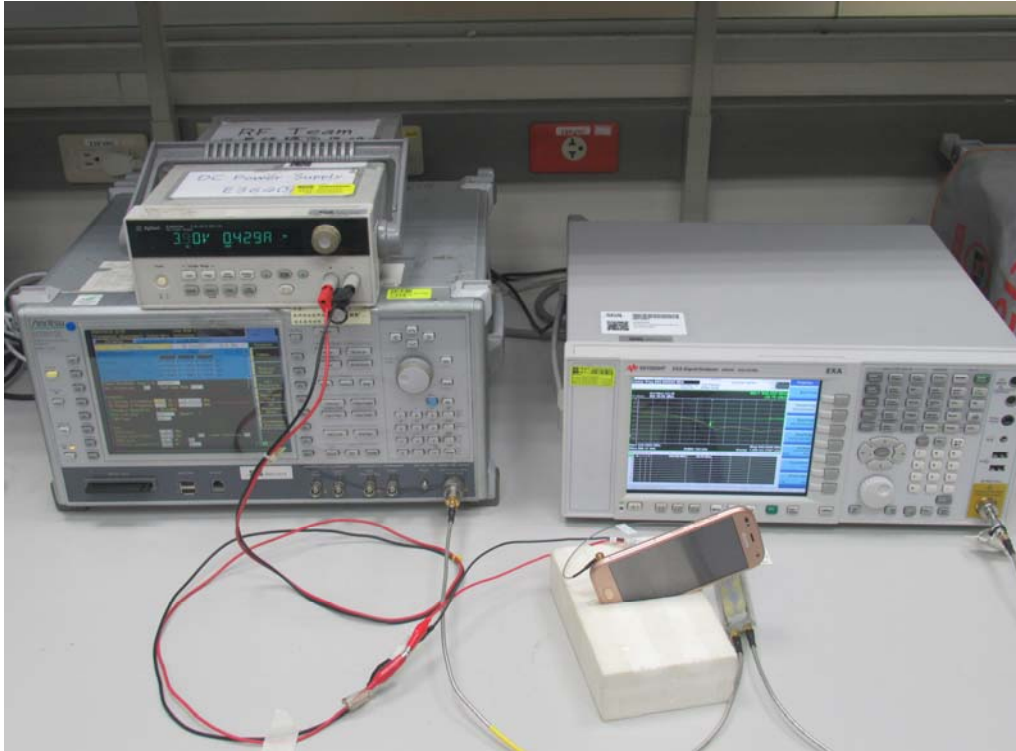
### AC Power-Line Conducted Emission Set up Photo



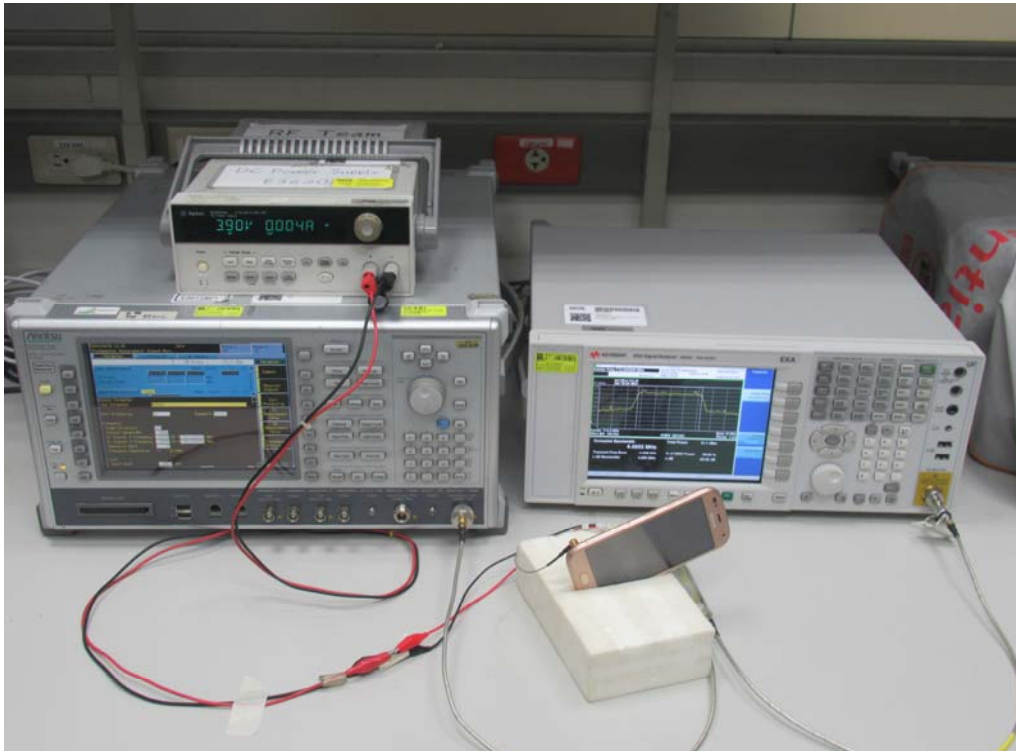

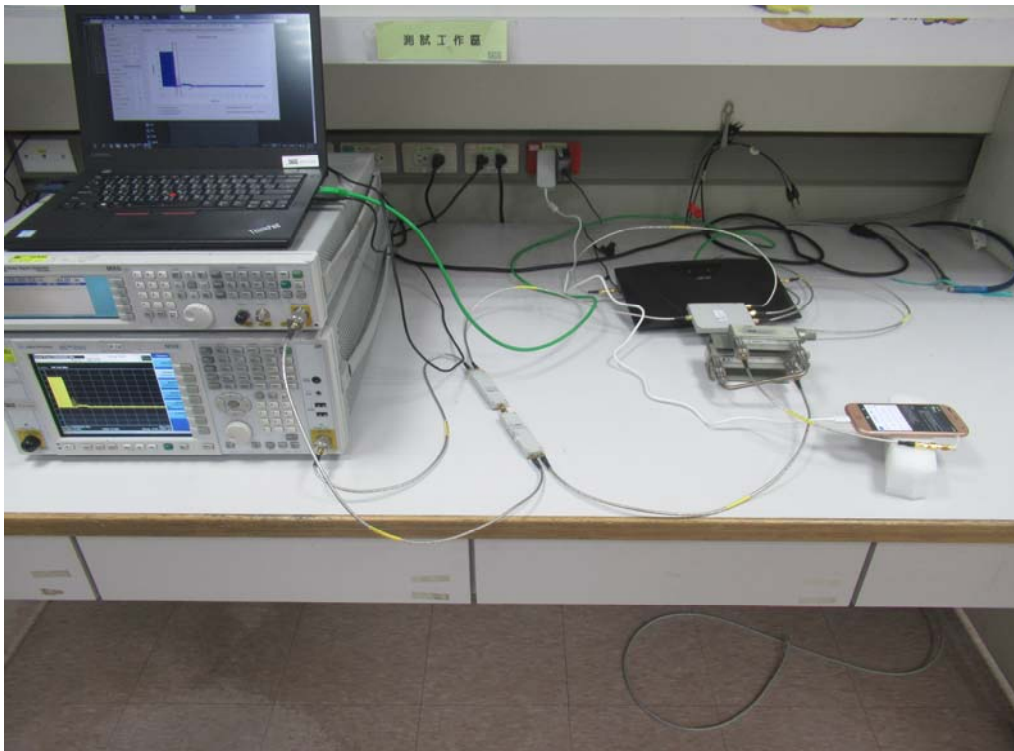
