



Radiated Emission Set up Photos (Above 1GHz)




















Radiated Emission Set up Photos (Above 1GHz)



Radiated Emission Set up Photos (Front View)














Conducted Set up Photos (2G, 3G)








Conducted Setup Photo (Measurement at Antenna Port) (BT BLE WLAN)
