1.2 Test Standards

The tests were performed according to following standards:

1.3 Test Methodology

All measurements contained in this report were conducted with ANSI C63.10-2013, KDB 558074 D01 15.247 Meas Guidance v05.

The equipment under test (EUT) was configured to measure its highest possible emission level. The test modes were adapted accordingly in reference to the Operating Instructions.

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements. All testing shall be performed under maximum output power condition, with a duty cycle equal to 100%, and to measure its highest possible emissions level, more detailed description as follows:

3. RF Exposure

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

4.2 Evaluation Information

This product has a chip antenna, fulfill the requirement of this section.

5. Power Spectral Density

5.1 Standard Applicable

According to 15.247(a)(1)(iii), for digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.




According to the KDB 558074 D01 v05 Subclause 8.4 and ANSI C63.10-2013 Subclause 11.10.3, such specifications require that the same method as used to determine the conducted output power shall also be used to determine the power spectral density. The test method of power spectral density as below:




- a) Set instrument center frequency to DTS channel center frequency.
- b) Set span to at least 1.5 times the OBW.
- c) Set RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
- d) Set VBW $\geq 3 \times \text{RBW}$.
- e) Detector = power averaging (RMS) or sample detector (when RMS not available).
- f) Ensure that the number of measurement points in the sweep $\geq 2 \times \text{span}/\text{RBW}$.
- g) Sweep time = auto couple.
- h) Employ trace averaging (RMS) mode over a minimum of 100 traces.
- i) Use the peak marker function to determine the maximum amplitude level.
- j) If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat (note that this may require zooming in on the emission of interest and reducing the span in order to meet the minimum measurement point requirement as the RBW is reduced).





6.1 Standard Applicable

According to 15.247(a)(2), systems using digital modulation techniques may operate in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.




- a) Set RBW = 100 kHz.
- b) Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
- c) Detector = Peak.
- d) Trace mode = max hold.
- e) Sweep = auto couple.
- f) Allow the trace to stabilize.
- g) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.





7. RF Output Power

7.1 Standard Applicable

According to 15.247(b)(3), for systems using digital modulation in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands: 1 Watt.

7.2 Test Procedure

According to the KDB-558074 D01 v05 Subclause 8.3.2.2 and ANSI C63.10-2013 Subclause 11.9.2.2, when this option is exercised, the measured power is to be referenced to the OBW rather than the DTS bandwidth




- a) Set span to at least 1.5 times the OBW.
- b) Set RBW = 1-5% of the OBW, not to exceed 1 MHz.
- c) Set VBW $\geq 3 \times$ RBW.
- d) Number of points in sweep $\geq 2 \times$ span / RBW. (This gives bin-to-bin spacing \leq RBW/2, so that narrowband signals are not lost between frequency bins.)
- e) Sweep time = auto.
- f) Detector = RMS (i.e., power averaging), if available. Otherwise, use sample detector mode.
- g) If transmit duty cycle < 98 %, use a sweep trigger with the level set to enable triggering only on full power pulses. The transmitter shall operate at maximum power control level for the entire duration of every sweep. 8. Field Strength of Spurious Emissions

8.1 Standard Applicable

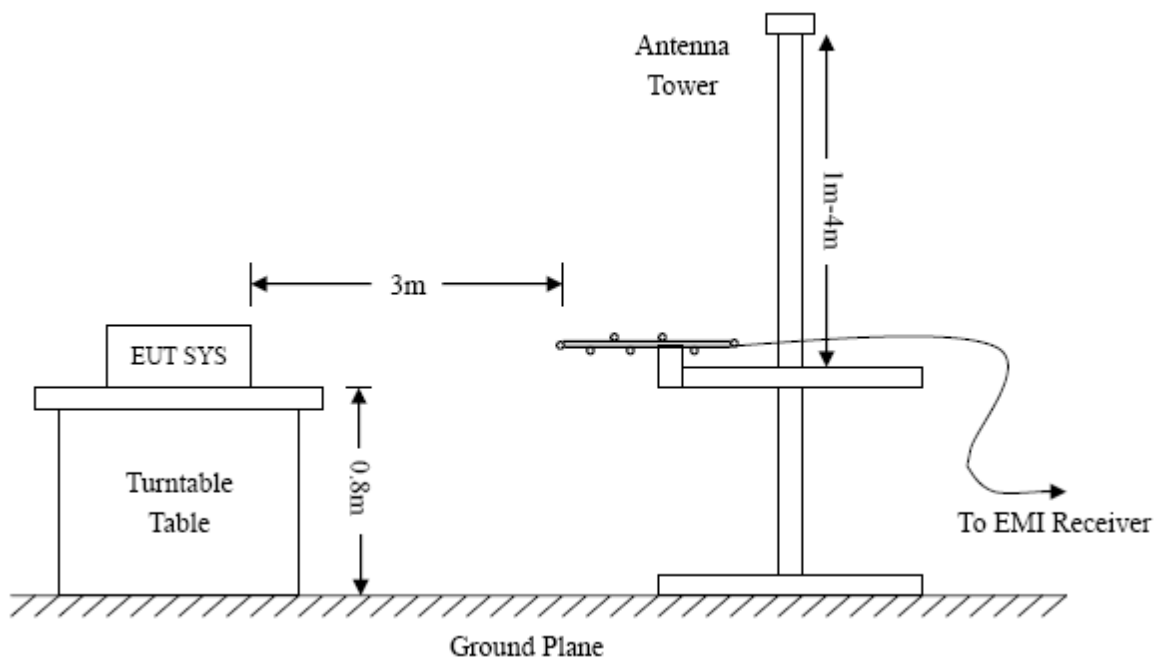
According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a).

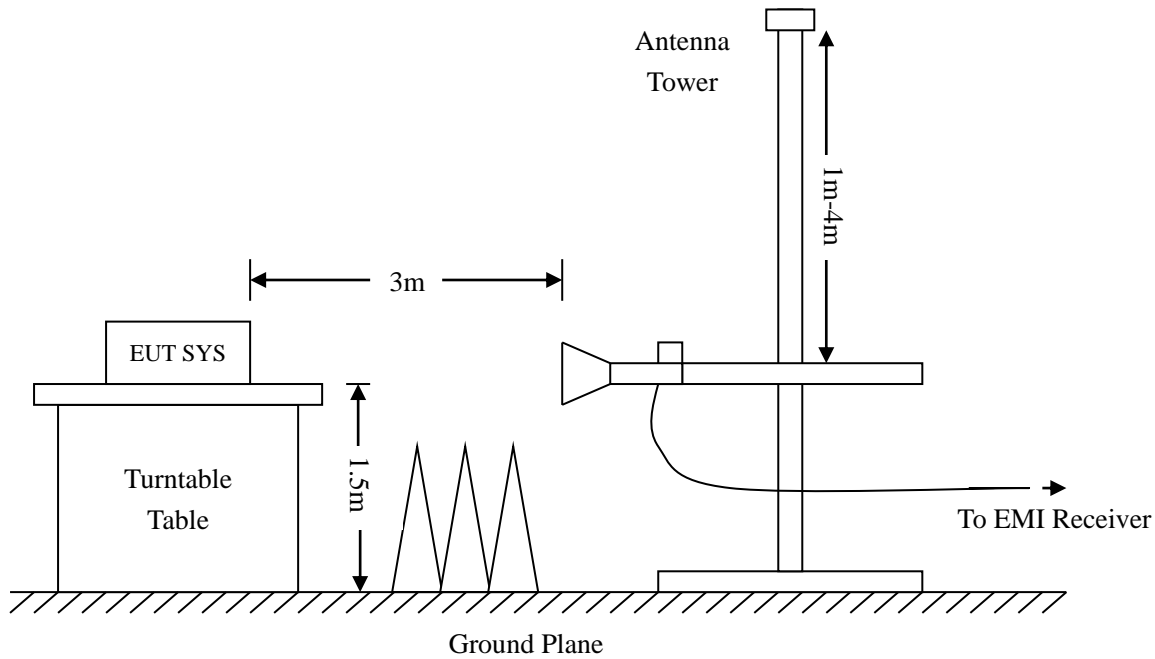
The emission limit in this paragraph is based on measurement instrumentation employing an average detector. The provisions in §15.35 for limiting peak emissions apply. Spurious Radiated Emissions measurements starting below or at the lowest crystal frequency.

8.2 Test Procedure

The setup of EUT is according with per ANSI C63.10-2013 measurement procedure. The specification used was with the FCC Part 15.205 15.247(a) and FCC Part 15.209 Limit.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle. The spacing between the peripherals was 10 cm.

8.3 Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and the Cable Factor, and subtracting the Amplifier Gain from the Amplitude reading. The basic equation is as follows:

$$\text{Corr. Ampl.} = \text{Indicated Reading} + \text{Ant. Factor} + \text{Cable Loss} - \text{Ampl. Gain}$$

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of -6dB μ V means the emission is 6dB μ V below the maximum limit. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Corr. Ampl.} - \text{FCC Part 15 Limit}$$

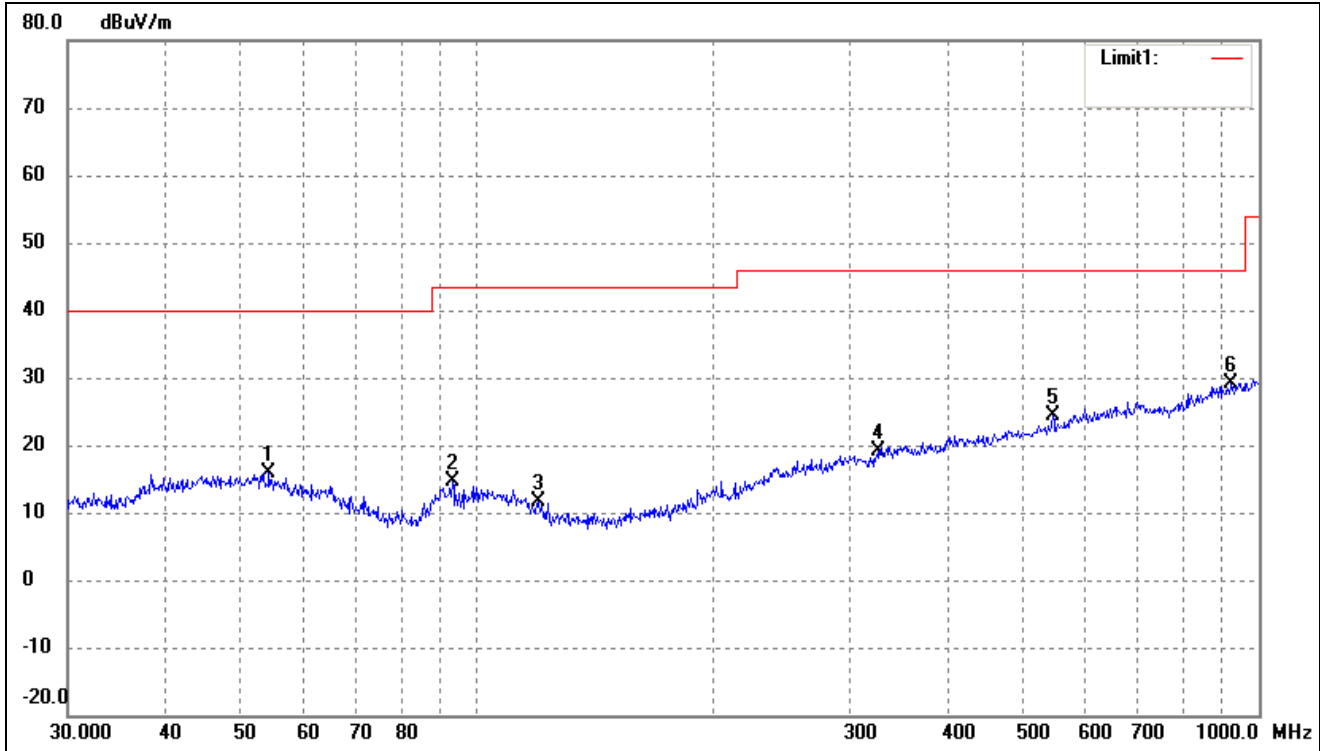

According to §15.247 (d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a).

9.2 Test Procedure

According to the KDB 558074D01 v05 Subclause 8.4 and ANSI C63.10-2013 Subclause 11.11, the emissions in nonrestricted frequency bands test method as follows:

- a) Set the center frequency and span to encompass frequency range to be measured.
- b) Set the RBW = 100 kHz.
- c) Set the VBW $\geq [3 \times \text{RBW}]$.
- d) Detector = peak.
- e) Sweep time = auto couple.
- f) Trace mode = max hold.
- g) Allow trace to fully stabilize.
- h) Use the peak marker function to determine the maximum amplitude level.

According to the KDB 558074 D01 v05 Subclause 8.5 and ANSI C63.10-2013 Subclause 11.12, the emissions in restricted frequency bands test method as follows:

A. Radiated emission measurements:

Set span = wide enough to capture the peak level of the emission operating on the channel closest to the bandedge, as well as any modulation products which fall outside of the authorized band of operation (2310MHz to 2420MHz for low bandedge, 2460MHz to 2500MHz for the high bandedge)

RBW = 1MHz, VBW = 1MHz for peak value measured

RBW = 1MHz, VBW = 10Hz for average value measured

Sweep = auto; Detector function = peak/average; Trace = max hold

All the trace to stabilize, set the marker on the emission at the bandedge, or on the highest modulation product outside of the band, if this level is greater than that at the bandedge. Enable the marker-delta function, then use the marker-to-peak function to move the marker to the peak of the in-band emission. Those emission must comply with the 15.209 limit for fall in the restricted bands listed in section 15.205. Note that the method of measurement KDB publication number: 913591 may be used for the radiated bandedge measurements.

B. Antenna-port conducted measurements

Peak emission levels are measured by setting the instrument as follows:

- a) RBW = as specified in Table 9/
- b) VBW $\geq [3 \times \text{RBW}]$.
- c) Detector = peak.
- d) Sweep time = auto.
- e) Trace mode = max hold.
- f) Allow sweeps to continue until the trace stabilizes. (Note that the required measurement time may be lengthened for low-duty-cycle applications.)

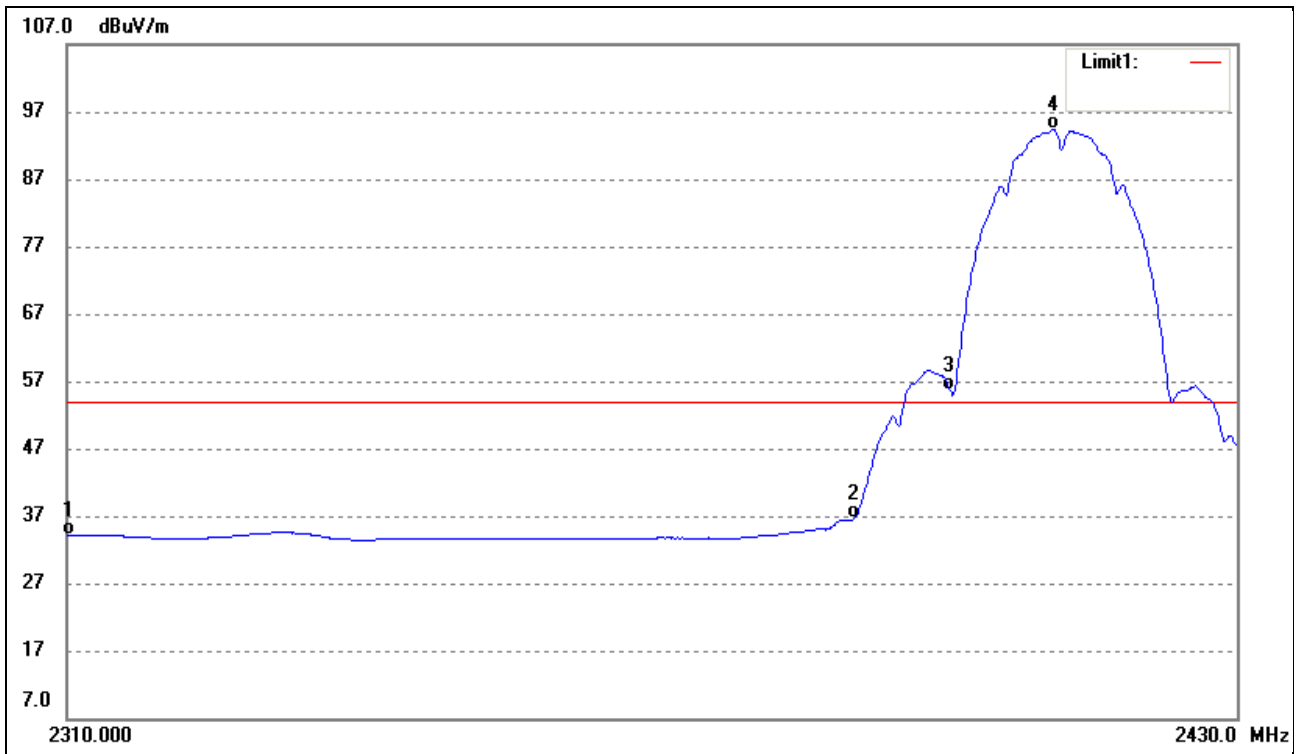
If the peak-detected amplitude can be shown to comply with the average limit, then it is not necessary to perform a separate average measurement.

Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) are attenuated by at least the minimum requirements specified in section 8.1 report the three highest emissions relative to the limit.

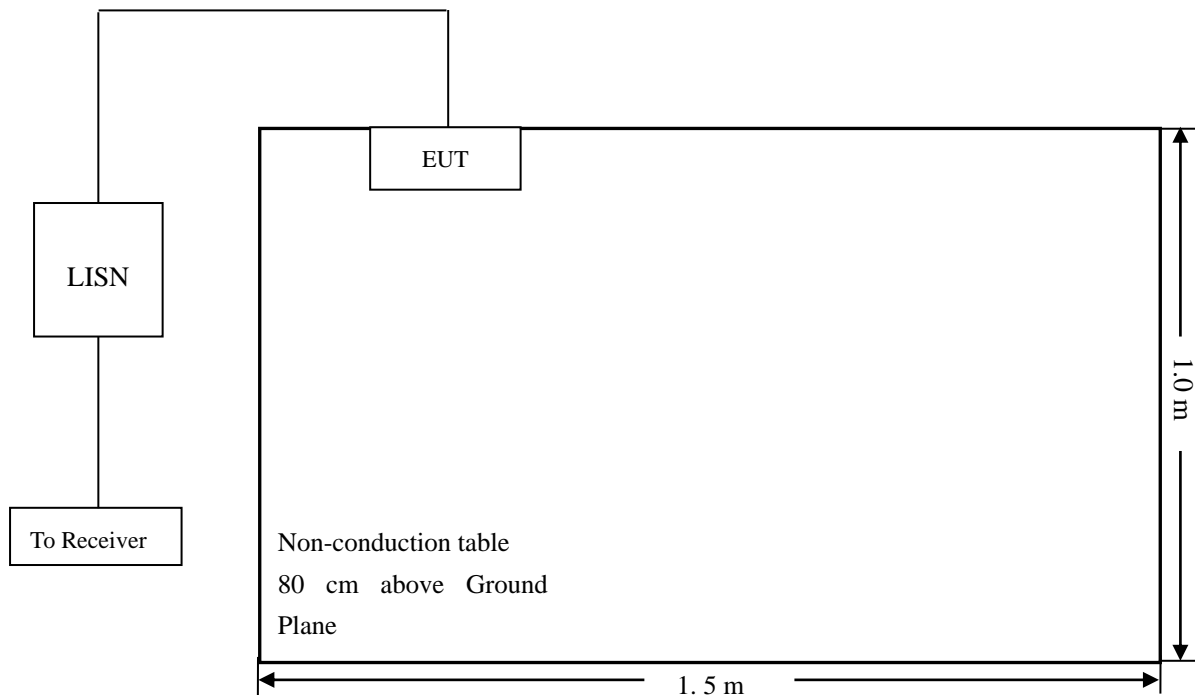
10. Conducted Emissions

10.1 Test Procedure

The setup of EUT is according with per ANSI C63.10-2013 measurement procedure. The specification used was with the FCC Part 15.207 Limit.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle. The spacing between the peripherals was 10 cm.

10.2 Basic Test Setup Block Diagram



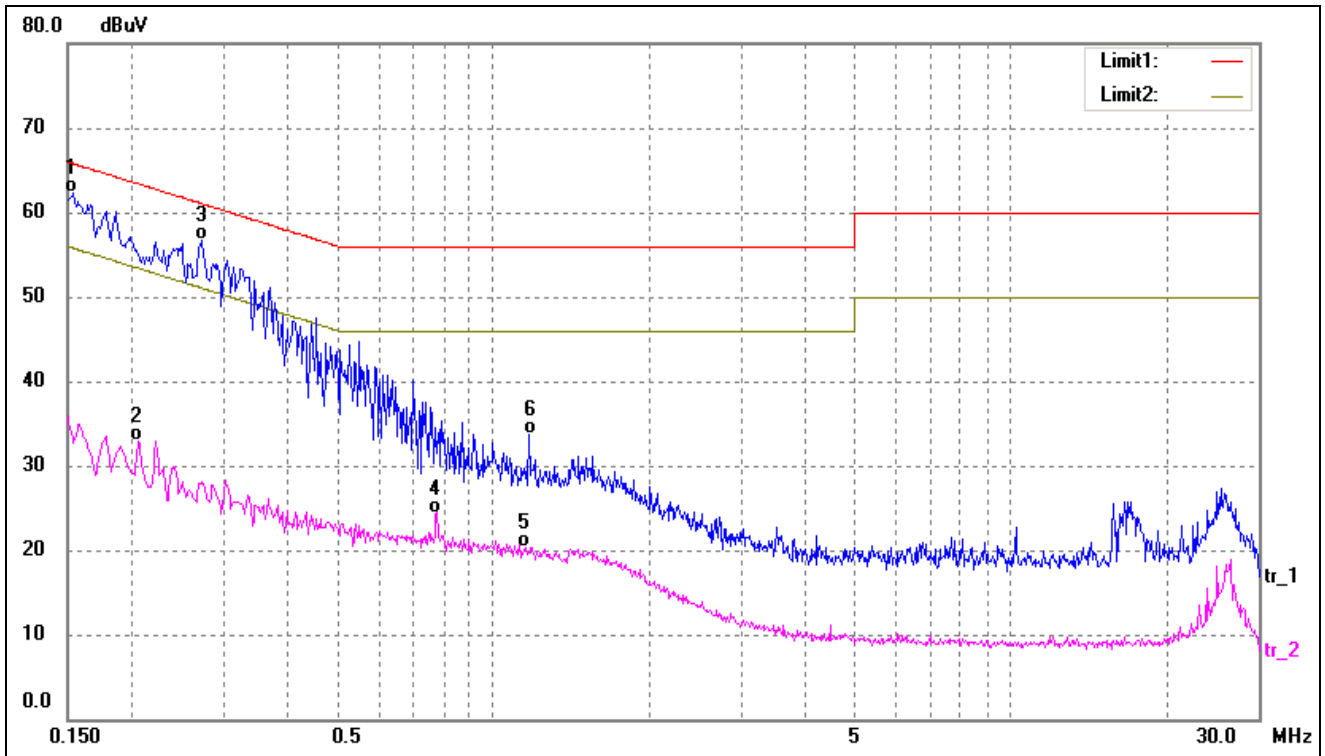

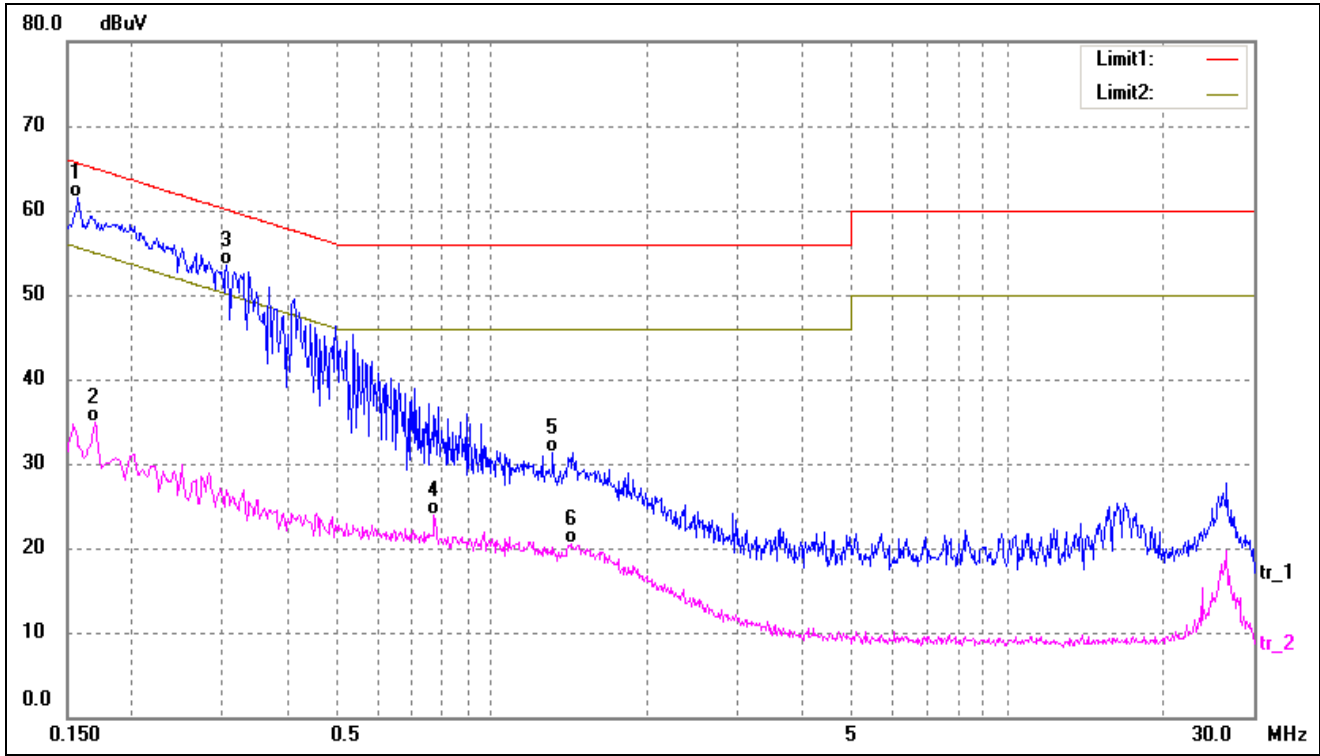
