

- 2. For model TAT1108LE&TAT1138LE, the two headphone main boards are identical in hardware, while the differences are reflected in software, mainly EQ file (acoustic debugging of the sound quality parameters file)different.
- 3. The battery models of the TAT1108LE and TAT1138LE headphones are different.
- 4. TAT1108LE and TAT1138LE headphones use different speakers.
- 5. TAT1108LE and TAT1138LE two headphone charging case main board and battery is completely consistent.
