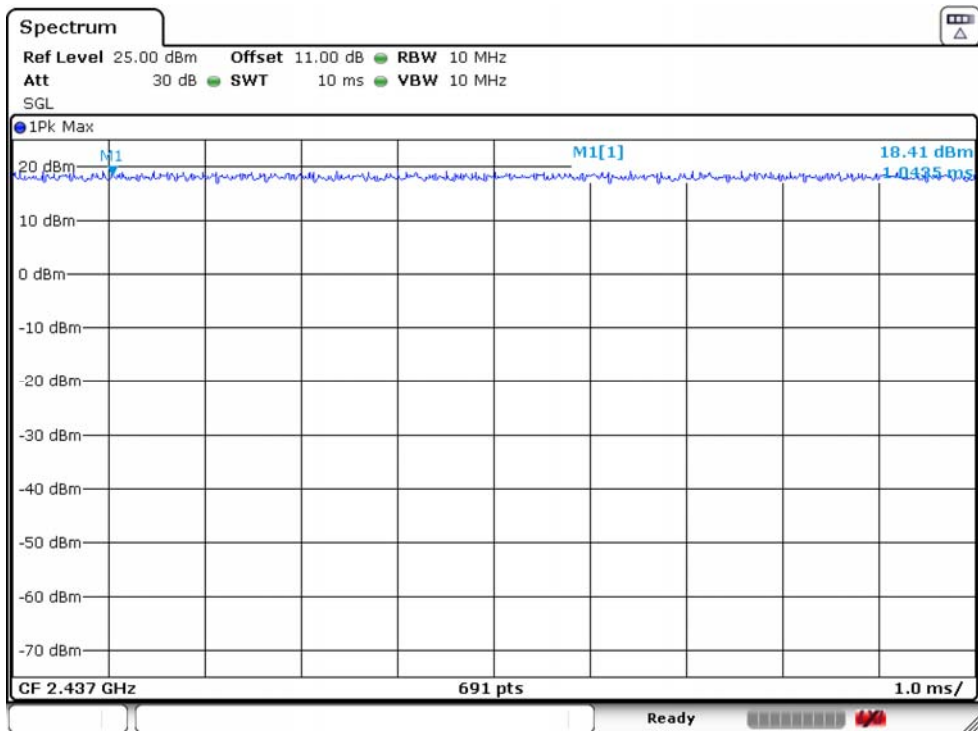
IEEE 802.11g 2437MHz

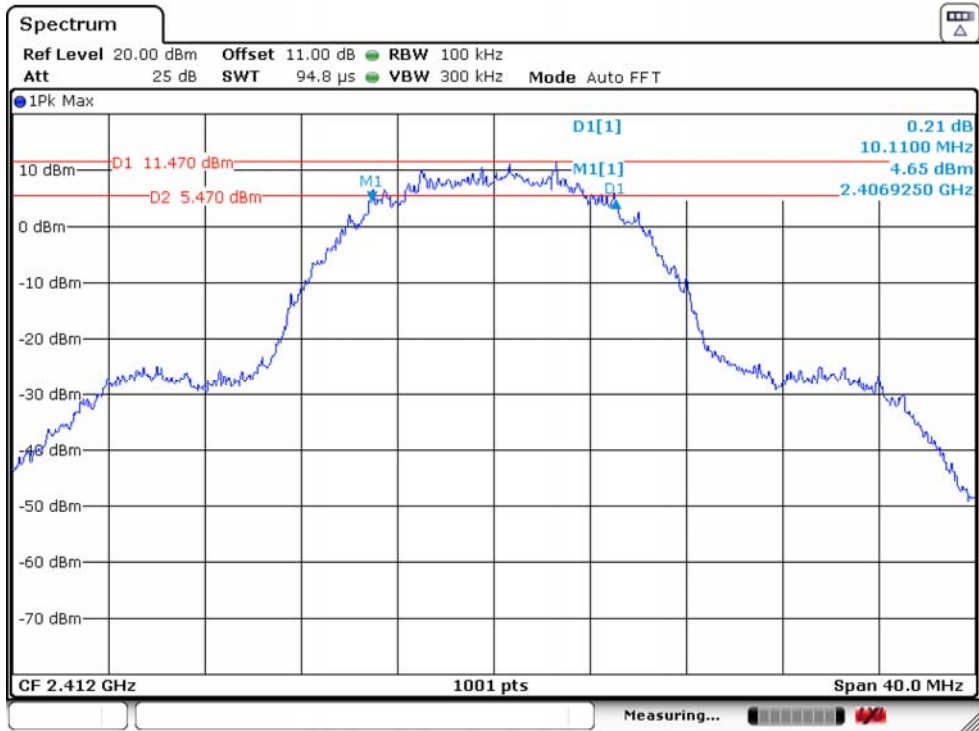

- b. Spectrum analyzer setting parameters in accordance with section 3.3.
- c. Set the EUT transmit continuously with maximum output power.
- d. Allow trace to stabilize, measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.
- e. Repeat above procedures until all modes and channels were measured.
- f. Record the results in the test report.

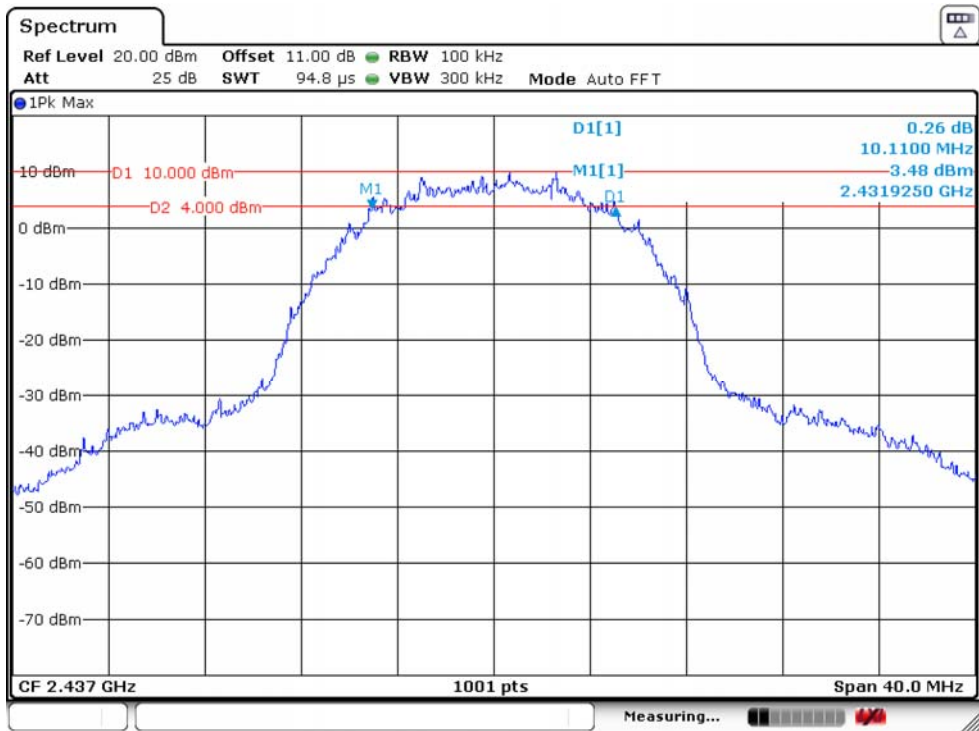

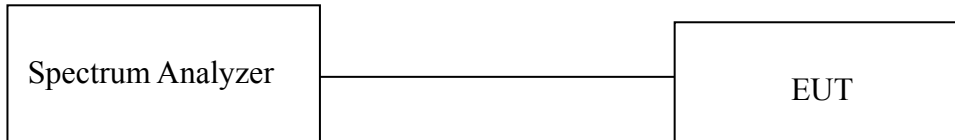


5. POWER SPECTRAL DENSITY

5.1. Limit

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

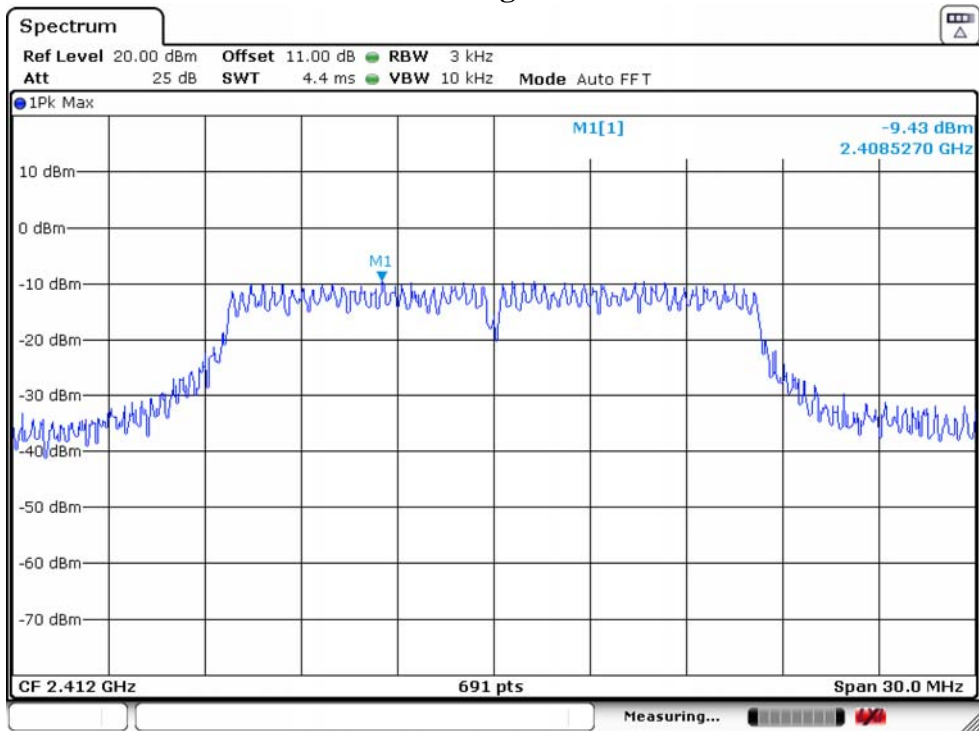
IEEE 802.11b 2437MHz



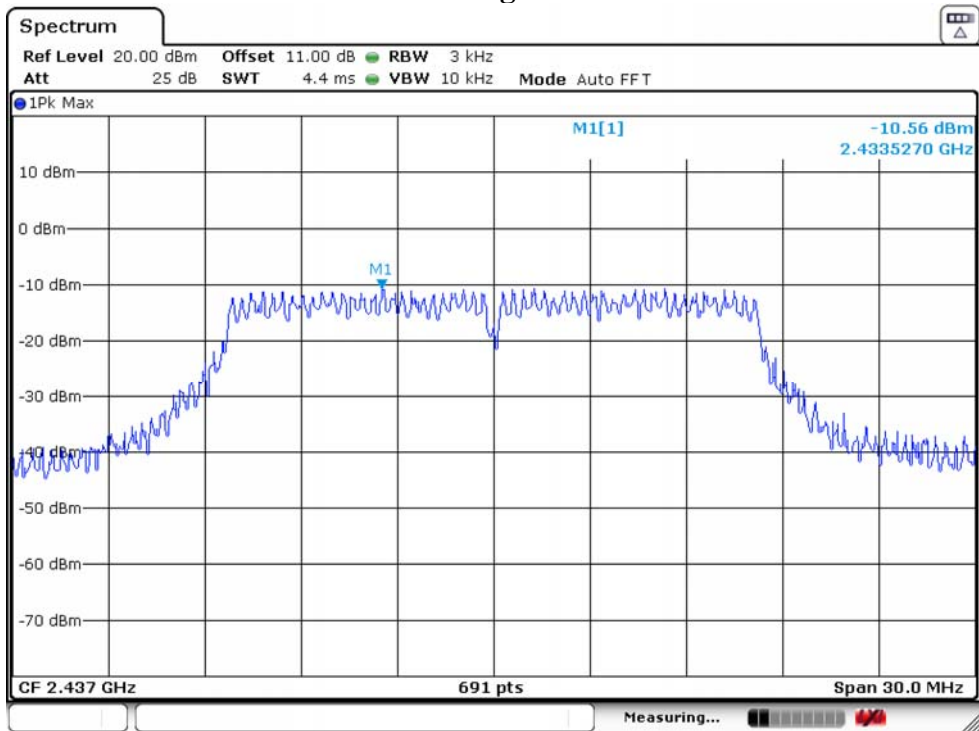

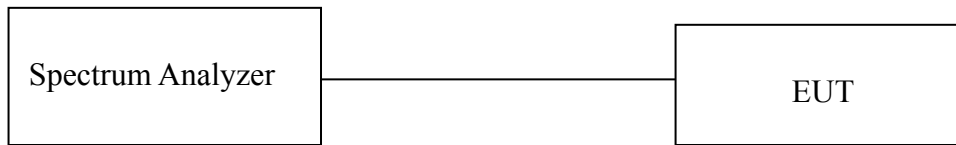


6. CONDUCTED BAND EDGE

6.1. Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. - a. EUT was placed on a turn table, which is 0.8 meter high above ground for below 1GHz test, and which is 1.5 meter high above ground for above 1GHz test.
- b. EUT is set 3 meters away from the receiving antenna, which is mounted on a antenna tower.
- c. Set the EUT transmit continuously with maximum output power.
- d. The turn table can rotate 360 degrees to determine the position of the maximum emission level.
- e. The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarization of the antenna are set on test.
- f. Spectrum analyzer setting parameters in accordance with section 8.3.
- g. Repeat above procedures until all channels were measured.
- h. Record the results in the test report.

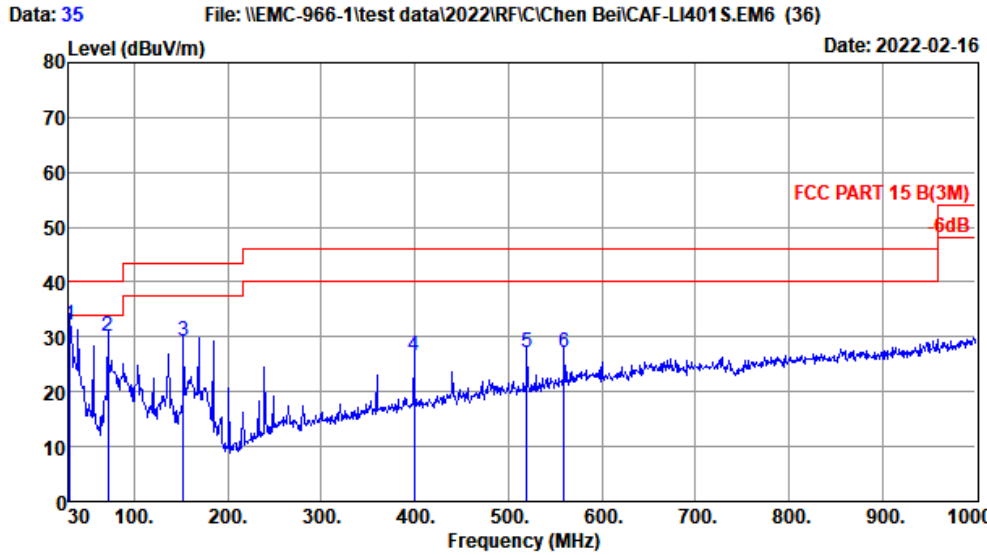

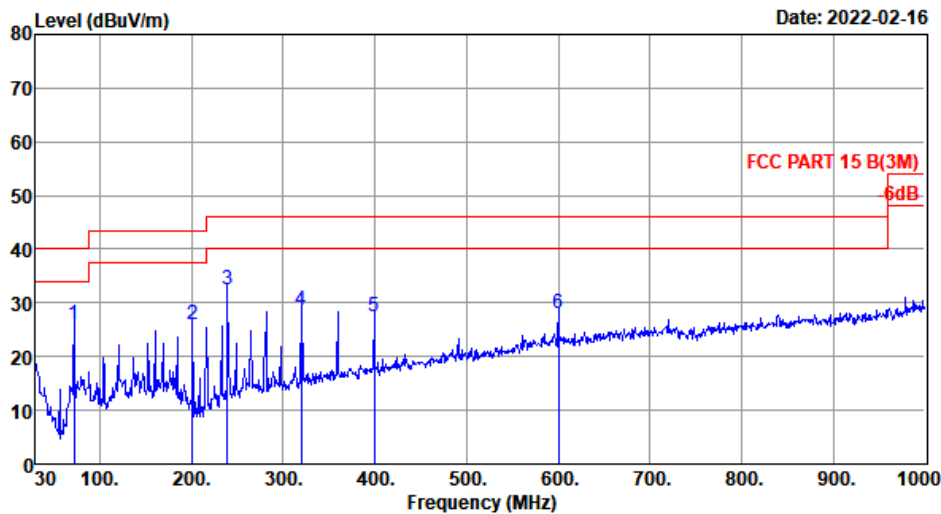

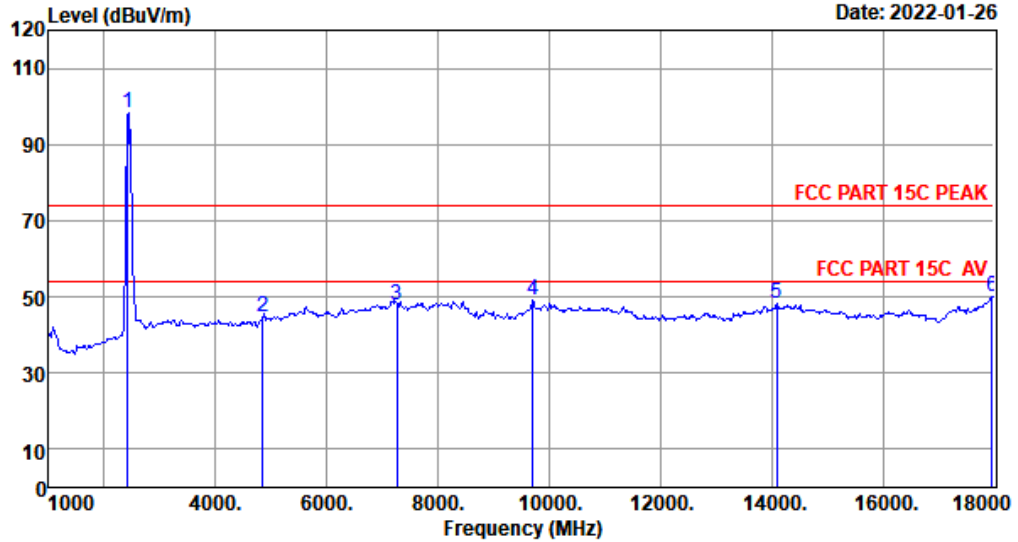


Radiated Emissions Above 1G

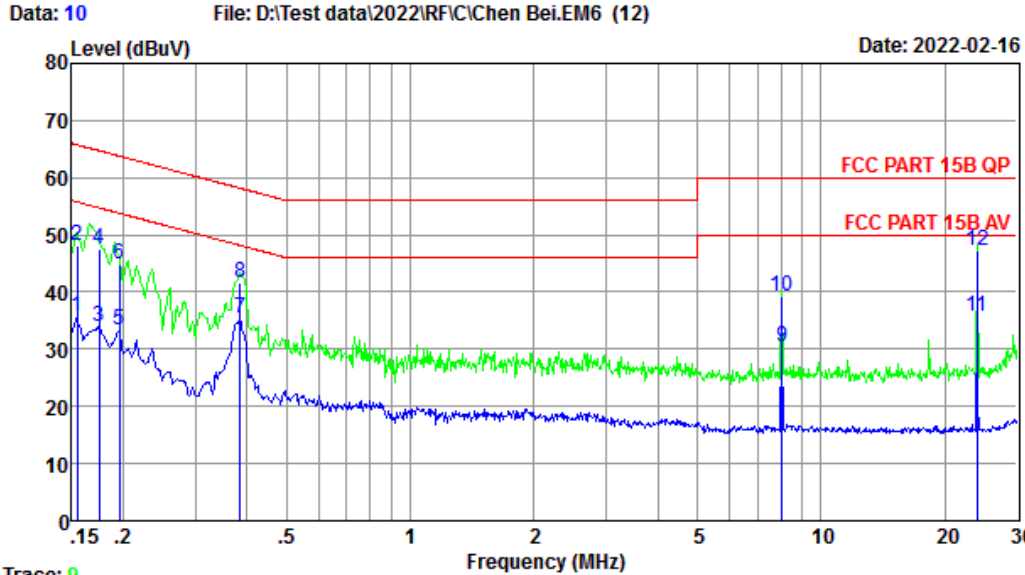
9.4. Test Procedure

- d. Set the EUT transmit continuously with maximum output power.
- e. Spectrum analyzer setting parameters in accordance with section 9.3.
- f. The AC line are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.10: 2013 on Conducted Emission Test.
- g. Record the results in the test report.
