#### 2.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.10. Radiated emission measurement was performed in semi-anechoic chamber and conducted emission measurement was performed in shield room. For radiated emission measurement, preliminary scans and final tests were performed in the semi-anechoic chamber to determine the worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise.

# 3.0 System Test Configuration

#### 3.1 Justification

The difference among KF-P31W, KF-P32W, KF-P33W, KF-P34W, KF-P35W, KF-P36W: KF-P31W, KF-P32W, KF-P33W and KF-P34W is the same except the appearance and control board PCB layout, the Wi-Fi module is the same. PURABREEZE is the same as KF-P31W except the model designation number. CZAP602SWT is the same as KF-P33W except the model designation number. CZAP502SWT is the same as KF-P34W except the model designation number.

KF-P35W and KF-P36W is the same except the appearance and control board PCB layout, the Wi-Fi module is the same.

All the models with the same Wi-Fi module. KF-P31W is selected for fully testing.

For emissions testing, the equipment under test (EUT) setup to transmit continuously to simplify the measurement methodology. Care was taken to ensure proper power supply



voltages during testing. During testing, AC power line was manipulated to produce worst case emissions. It was powered by AC 120V,60Hz supply.

The signal is maximized through rotation and placement in the three orthogonal axes. The antenna height and polarization are varied during the search for maximum signal level. The antenna height is varied from 1 to 4 meters. Radiated emissions are taken at three meters unless the signal level is too low for measurement at that distance. If necessary, a pre-amplifier is used and/or the test is conducted at a closer distance.

All readings are extrapolated back to the equivalent three meter reading using inverse scaling with distance. The spurious emissions more than 20 dB below the permissible value are not reported.

For an intentional radiator, the spectrum shall be investigated from the lowest radio frequency signal generated in the device, without going below 9 kHz, up to at least the frequency shown in the following table:

#### 4.1 Antenna Requirement

# 15.203 requirement:

For intentional device. According to 15.203 an intentional radiator shall be designed to Ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

#### **EUT Antenna**

The antenna is an integral antenna and no consideration of replacement. The best case gain of the antenna is 2.5dBi as declared by applicant.

# 802.11n(HT20) mode with 6.5Mbps data rate





#### 4.6 Out of Band Conducted Emissions

Test Requirement: FCC Part 15 C section 15.247

(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating. The radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power. Based on either an RF conducted or a radiated measurement. Provided the transmitter demonstrates compliance with the peak conducted power limits. #### Test Procedure:

## Test Setup and Procedure:

Test was performed according to ANSI C63.10 Clause 6.2. The EUT was set to achieve the maximum emission level. The mains terminal disturbance voltage was measured with the EUT in a shielded room. The EUT was connected to AC power source through an Artificial Mains Network which provides a  $50\Omega$  linear impedance Artificial hand is used if appropriate (for handheld apparatus). The load/control terminal disturbance voltage was measured with passive voltage probe if appropriate.

The table-top EUT was placed on a 0.8m high non-metallic table above earthed ground plane (Ground Reference Plane). And for floor standing EUT, was placed on a 0.1m high non-metallic supported on GRP. The EUT keeps a distance of at least 0.8m from any other of the metallic surface. The Artificial Mains Network is situated at a distance of 0.8m from the EUT.

During the test, mains lead of EUT excess 0.8m was folded back and forth parallel to the lead so as to form a horizontal bundle with a length between 0.3m and 0.4m

The bandwidth of test receiver was set at 9 kHz. The frequency range from 150 kHz to 30MHz was checked.







