

Test Procedure

- 1, The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. A wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10.
- 2, Support equipment, if needed, was placed as per ANSI C63.10.
- 3, All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10.
- 4, If a EUT received DC power from the USB Port of Notebook PC, the PC's adapter received AC power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5, All support equipments received AC power from a second LISN, if any.
- 6, The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7, Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.





3.2 RADIATED EMISSION TEST




Test Setup

Test Procedure

- 1. Below 1GHz measurement the EUT is placed on a turntable which is 0.8m above ground plane, and above 1GHz measurement EUT was placed on a low permittivity and low loss tangent turn table which is 1.5m above ground plane.
- 2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0°℃ to 360°℃ to acquire the highest emissions from EUT
- 3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4. Repeat above procedures until all frequency measurements have been completed.
- 5. Radiated emission test frequency band from 9KHz to 25GHz.
- 6. The distance between test antenna and EUT as following table states:



PASS-

- 2. All three channels (lowest/middle/highest) of each mode were measured below 1GHz and recorded worst case at 802.11b low channel.
- 3. All three channels (lowest/middle/highest) of each mode were measured above1GHz and recorded worst case at 802.11b mode.
- 4. Radiated emission test from 9 KHz to 10th harmonic of fundamental was verified, and no emission found except system noise floor in 9 KHz to 30MHz and not recorded in this report.



3.6 OUT-OF BAND EMISSIONS

<u>Limit</u>

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desiredpower, based on either an RF con-ducted or a radiated measurement, pro-vided the transmitter demonstrates compliance with the peak conducted power limits. 





















Band-edge Measurements for RF Conducted Emissions:









