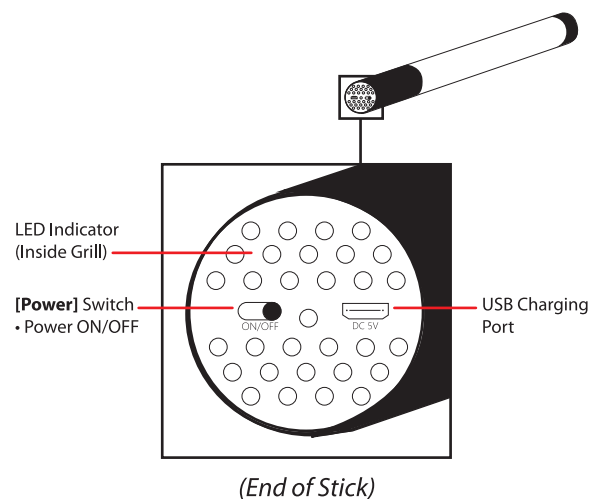

## Getting Started

### ⚡ Charging the Speaker

Plug the small connector of the USB cable into the USB charging port on the end of the stick. Plug the other end into the USB port on your computer, a USB charging device, or a **5V USB charging adapter** (not included) and plug into a wall socket.

The LED indicator will **turn RED** while charging and turn off when full charged.

On low power, a tone will be periodically heard, indicating that the speaker should be charged.

### 🔊 Using the Speaker & Lights

**Make sure that the speaker has been charged.**

- Move the **[Power]** switch to the ON position. A voice will be heard, the lights will turn on, and the speaker will enter Bluetooth pairing mode. The speaker will automatically re-pair to any nearby, previously-paired device.
- Move the **[Power]** switch to the OFF position to power OFF.

### 📶 Connecting with Bluetooth

1. Power the speaker ON. A voice will be heard.
2. Set your mobile device to search for Bluetooth devices. When it appears, select **AR-ELCFSS** from the list of found devices.
3. After a successful pairing, a voice will be heard.
