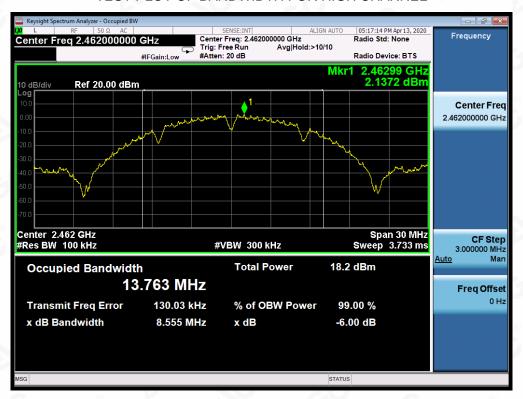

TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL



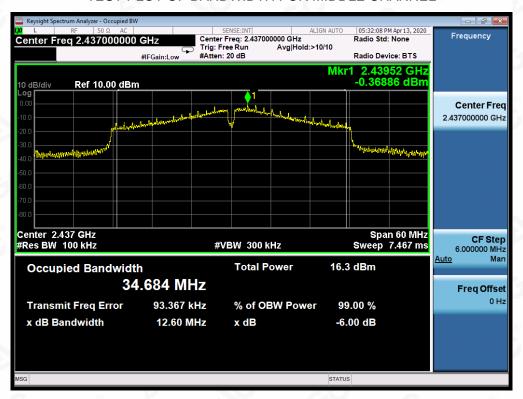
