



# Device not charging/LED is red Make sure that your device is Qi-enabled.

- Make sure that your charging pad is connected to a working power outlet.
- Make sure that your device is positioned correctly on your charging pad.
- Make sure that there are no other objects on the charging pad.
- Remove your device's case. It may be blocking the wireless signal.

#### Device charges slowly

- Your device may charge more slowly with the charging pad than a charging cable. This is normal behavior.
- Make sure that your device is positioned in the center of your charging pad.

**CAUTION:** Only use the cable with the attached power adapter that came with your charger. Using a different cable and adapter can decrease charging performance or damage your charger.
