1 Measuring Standard

1.1 According to §1.1307(b)(1), systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess of the Commission's guidelines. According to §1.1310 and §2.1091 RF exposure is calculated. According KDB 680106 D01 Wireless Power Transfer v04.

1.2 MEASUREMENT UNCERTAINTY

The reported uncertainty of measurement y \pm U, where expended uncertainty U is based on a standard uncertainty multiplied by a coverage factor of k=2, providing a level of confidence of approximately 95 %.

2.1 Requirements

The EUT does comply with item 5.2 of KDB 680106 D01 V04:

1) The power transfer frequency is below 1 MHz.

Yes, the device operate in the frequency range from 110kHz to 205kHz.

2) The output power from each transmitting element (e.g., coil) is less than or equal to 15 watts. Yes, the maximum output power of the primary coil is 15W.

3) A client device providing the maximum permitted load is placed in physical contact with the transmitter (i.e., the surfaces of the transmitter and client device enclosures need to be in physical contact).Yes, the surfaces of the transmitter and client device enclosures are in physical contact.

4) Only § 2.1091-Mobile exposure conditions apply (i.e., this provision does not cover § 2.1093-Portable exposure conditions)..

Yes, the EUT is a Mobile Wireless Charger.

5) The E-field and H-field strengths, at and beyond 20 cm surrounding the device surface, are demonstrated to be less than 50% of the applicable MPE limit, per KDB 447498, Table 1.Yes, the EUT field strength levels are less 50% * MPE limit.

6) For systems with more than one radiating structure, the conditions specified in (5) must be met when the system is fully loaded (i.e., clients absorbing maximum power available), and with all the radiating structures operating at maximum power at the same time, as per design conditions. Yes, the EUT has one coil, all test modes met the conditions specified in (5).

3 Test Procedure

1) The RF exposure test was performed on 360 degree turn table in anechoic chamber.

2) The measurement probe was placed at test distance (20 cm and above from all sides and Top) which is between the edge of the charger and the geometric centre of probe.

3) The turn table was rotated 360d degree to search of highest strength.

4) The highest emission level was recorded and compared with limit as soon as measurement of each points were completed.

5) The EUT were measured according to the dictates of KDB 680106 D01 V04.
